5. COMMENTS FROM CITIZENS

Gary White, 2301 Eagle Drive - spoke to request removal of a curb located in front of his home. Mr. White briefly discussed the history of his request

to install the curb in 2002 because of a stormwater overflow problem occurring on his property from large rain events.

City Manager Estes spoke concerning reoccurring storm water issues if the curb was removed. Mr. White suggested a "California Curve" to alleviate possible issues with removal of the existing curb.

Steve Swecker, 2310 Eagle Drive - spoke regarding the current condition of the Elizabethton Golf Course. He stated that he has been a member of the golf course for eight (8) years. He discussed his concerns of projects not completed and the overall degrading appearance of the greens. He suggested that the city regain management of the course under the Parks and Recreation Department. He requested a workshop between councilmembers and concerned members of the golf course.

Robert Benfield, Elizabethton Arts Alliance member, spoke regarding the success and positivity of an art event downtown at August Muse, 518 East Elk Avenue on Saturday, May 6, 2023. Mr. Benfield thanked council for support of small downtown business events and also extended a thank you to the community for participation in the event.

Paula Augustine, 601 Evergreen Lane, owner of August Moon, 518 East Elk Avenue - spoke regarding her concern with an incident involving a Carter County Car Club representative questioning a young artist about permission to use the sidewalk area in front of her business. Ms. Augustine stated that this incident occurred during the previous car show event on Saturday, May 6, 2023.

Nash Acuna, President of Elizabethton Arts & Cultural Alliance, also spoke regarding her concerns of the inappropriate interaction by a car show representative involving a young artist that occurred on Saturday, May 6, 2023. She spoke on the need for encouragement and support of youth by suggesting that the city develop, create and provide resources to give talented youth the ability to grow and flourish in the arts industry.

Justin McClain, Roan Mountain, TN, owner of Wayward Springs Tack & Consignment, 441 E. Elk Avenue, spoke regarding his concern of the Carter County Car Club's weekly (Saturday evening) car show being a hardship of downtown activity by downtown business owners.

Steven Wilson, Elizabethton Golf Course General Manager, spoke and provided a copy of his resignation to councilmembers. Mr. Wilson spoke to address and state his opinion regarding some current issues at the golf course as follows: defense of

the course's operations regarding the issue of trees, stumps, and trimmings being left at the golf course property due to not having a disposal site locally to dispose of the tree trimmings; golf course could not have a country club look of appeal on a municipal budget; golf course needs capital improvements including a new irrigation system. He further stated that membership at the golf course is currently up to 123 members from 78 members previously.
