

ORDINANCE NO. 51-25

**“AN ORDINANCE TO AMEND THE MUNICIPAL CODE, ELIZABETHTON, TENNESSEE, 2000, AS AMENDED, BY AMENDING TITLE 12, CHAPTER 10, SECTION 12-1001, TO ADD A SUBSECTION (4) WHICH WOULD EXEMPT LOCAL CITY OR COUNTY GOVERNMENTS FROM APPLYING FOR A PERMIT IF THE VALUE OF THE WORK TO BE COMPLETED IS LESS THAN TEN THOUSAND (\$10,000.00) DOLLARS.”**

**WHEREAS**, pursuant to Ordinance No. 51-6, passed on Second Reading on May 14, 2015, the Elizabethton City Council adopted a new Title 12, Chapter 10, entitled “Applicant Requirements and Fees”; and

**WHEREAS**, after the adoption of Ordinance No. 51-6, City Staff has determined that it is necessary to add a new Subsection (4) to Section 12-1001, which Subsection (4) would exempt local city or county governments from the minimum requirements of a permit if the value of the work to be completed is less than Ten Thousand (\$10,000.00) Dollars; and

**WHEREAS**, it is in the best interest and welfare of the citizens and residents of the City of Elizabethton that Title 12, Chapter 10, Section 12-1001, be amended to add a Subsection (4), which subsection would exempt local city or county governments from the minimum requirement of a permit if the value of the work to be completed is less than Ten Thousand (\$10,000.00) Dollars.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ELIZABETHTON, TENNESSEE, AS FOLLOWS:**

**Section 1.** That Title 12, Chapter 10, Section 12-1001, shall be amended to add a Subsection (4) to read as follows:

**(4).** Local city or county governments applying for a permit shall be exempt from the requirements of this section if the valuation of the work completed is less than Ten Thousand (\$10,000.00) Dollars.

**Section 2.** This Ordinance shall take effect ten (10) days from and after its final passage.
