NINTH DAY GENESEE COUNTY LEGISLATURE Batavia, New York Wednesday, May 12, 2021

The Genesee County Legislature met in Regular Session on Wednesday, May 12, 2021 at 5:30 PM in the Legislative Chambers of the Old Courthouse and remotely using ZOOM. Legislator Maha assisted with the audit. The prayer was offered by Legislator Deleo followed by the Pledge to the Flag.

In addition to our regular meeting Legislature Chair Stein opened a public hearing on Local Law Introductory No. 1 Year 2021 The County Of Genesee, NY To Allow 12 And 13 Year Old Licensed Hunters To Hunt Deer With A Firearm Or Crossbow During Hunting Season With The Supervision Of A Licensed Adult. The following citizens spoke in support of the proposed local law: Mr. Louis Lang and Mr. Glen Adams. Mr. Lang urged Legislators to pass the local law and give these younger hunters a chance to hunt deer with the supervision of an adult licensed hunter. Both requested the legislature support the measure by voting in favor of adoption. Mr. Adams extended appreciation for the Genesee County Legislature taking up the matter so quickly. He is a Federation of Sportsmen officer and was speaking on behalf of the local organization with a membership of about 1200.

Legislator Maha presented National Police Week proclamation to members of the Genesee County Sheriff's Office and Batavia Police Department. Undersheriff Brad Mazur and Batavia Police Chief Shawn Heubusch accepted the proclamation and thanked members of their respective departments for putting their lives on the line each shift and for their continuous commitment to serve and protect the citizens of our County.

Legislators Dibble and Torrey presented National Mental Health Awareness Month Proclamation to Mental Health Director Lynda Battaglia and Mental Health Association Executive Director Tom Christianson. Ms. Battaglia commented on how much our mental health affects other aspects of health and well-being. More people are reporting mental health issues since the pandemic was declared and people were forced to work remotely or leave their jobs to care for children. There has been an increase in food instability, less opportunities to socialize and increased financial stress on individuals and families.

Minutes of the April 28, 2021 Legislature Meeting were approved upon motion of Legislator Clattenburg seconded by Legislator Deleo, carried unanimously.

Legislator Yunker commented on the recent Rotary Club donation to the Youth Bureau and County Park and the work done by Rotarians and the Genesee County Highway employees lead by Deputy Superintendent Paul Osborn. Legislature Chair Stein stated the final Control Room call is scheduled for Friday, May 14<sup>th</sup>. The Treasury has opened a portal for counties to access the American Rescue Act funds. She reported activity from the Regional Economic Development Council and consolidated funding applications are being accepted. Congressional earmark funds are being requested by Senate Leader Schumer. Genesee County submitted requests to Congressman Jacobs for the new jail project and water. Another Genesee County emergency declaration was signed with the hope this will be the last.

### RESOLUTION NO. 181 AGREEMENT –PUBLIC HEALTH/NEW YORK STATE SEPTIC SYSTEM REPLACEMENT PROGRAM ROUND #2 FUNDING - APPROVAL OF

Legislator Deleo offered the following resolution:

WHEREAS, Genesee County has identified the repair and replacement of substandard septic systems as a critical community development need that will improve Genesee County's housing stock and water quality; Genesee County agrees to accept the second round of funding (\$170,000) that will be added to the first round of funding (\$150,000) for a maximum aggregate amount of (\$320,000) from the New York State Septic System Replacement Fund Program, and WHEREAS, the proposed county-wide program area is hereby defined as having many substandard on-site septic systems, located on the following waterbodies; Tonawanda Creek, Bowen Brook, Bigelow Creek and Oatka Creek; and

**WHEREAS,** The Committees on Human Services did review this request and does recommend approval at this time. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to enter into an agreement with the New York State Environmental Facilities Corporation, having its principal place of business located at 625 Broadway #7, Albany, New York 12207, effective April 30<sup>th</sup>, 2021 thru December 31, 2026. **Budget Impact:** \$64,000 is allocated in the 2021 4010 budget for Septic System Replacement

Fund Program reimbursements. No budget amendment is necessary to the 2021 4010 budget. Legislator Hawley seconded the resolution which was adopted by 326 votes.

WHEREAS, Homecare services are in great demand with the rising number of frail and/or chronically ill elders in our county needing in-home and community support services with homecare agencies unable to fill homecare cases due to lack of in-home workers; and

**WHEREAS,** Under Consumer Directed In-home Services, control is shifted to the consumer (or eligible consumer representative) for budgeting, care planning, decision making, arranging for services and staffing; and

**WHEREAS**, This is the third renewal of five (5) total contract renewals with potential for two (2) additional one (1) year renewals for provision of Fiscal Intermediary services with regard to Consumer Directed In-home Services and the Committee on Human Services does recommend approval at this time. Now, therefore, Be it

**RESOLVED,** That the Chairman of the Genesee County Legislature is hereby authorized and directed to execute the necessary document to award the contract to Willcare, Inc. to serve as Fiscal Intermediary for Genesee County Office for the Aging Consumer Directed In-home Services under Expanded In-home Services for the Elderly, Title III E, and other in-home services funds at a cost of \$20.51/hour for CDIS-Basic Worker and \$23.11/hour for CDIS-Enhanced Worker, not to exceed \$21,632 for the period of June 1, 2021-May 31, 2022.

<u>Budget Impact</u>: Neutral. All in-home services are already incorporated into our 2021 County budget. No additional County funds will be required. Rate is \$20.51 for CDIS-Basic Worker and \$23.11/hour for CDIS-Enhanced Worker. A total of \$21,632 is designated for CDIS for the period of 6/1/2021-5/31/2022.

### RESOLUTION NO. 195 INSURANCE RENEWALS FOR 2021-2022 - COUNTY ATTORNEY- APPROVAL OF

**WHEREAS,** The insurance policies for Pollution Liability, Cyber Liability, Crime, and Airport Liability all expired on May 1, 2021; and

WHEREAS, The Lawley Insurance Agency was able to obtain competitive quotes and was able to bind these four coverages, subject to approval by the County of Genesee Legislature, and WHEREAS, the premiums for these four policy coverages total \$65,526, as follows:

- 1. Pollution Liability Berkley Insurance Company \$7,999
- 2. Cyber Liability North River Insurance Company \$49,500
- 3. Crime Hanover Insurance Company \$3,560
- 4. Airport Liability Global Aerospace, Inc./McCredie Agency \$4,467

**WHEREAS**, the Committee on Ways and Means did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED,** that the County of Genesee Legislature does hereby approve retroactively from May 1, 2021 until May 1, 2022, insurance policy coverages to be placed with the four insurance companies set forth above for the individual amounts listed for each, totaling \$65,526, and be it further

**RESOLVED,** that the County of Genesee Legislature does hereby authorize and direct execution by the necessary individuals of all applications or other documents necessary to obtain these insurance coverages.

**Budget Impact Statement:** Cost of the policies are included in the 2021 budgets for the respective departments. Highway for Pollution and Airport and the County Attorney for Crime and Cyber.

WHEREAS, Matthew Gray submitted an application requesting reappointment to remain in the seat for the seven member board of the Genesee County Industrial Development Agency, d/b/a the Genesee County Economic Development Center ("GCEDC"), and

WHEREAS, The Committee on Ways and Means does recommend Mr. Matthew Gray be reappointed at this time. Now, therefore, Be it

**RESOLVED**, That the Genesee County Legislature does hereby reappoint Mr. Matthew Gray of Clinton Street, Batavia, New York to the Genesee County Industrial Development Agency d/b/a the Genesee County Economic Development Center effective July 1, 2021 to June 30, 2027.

Budget Impact Statement: none.

**RESOLUTION NO. 200** 

LOCAL LAW INTRODUCTORY NO. 1, YEAR 2021 OF THE COUNTY OF GENESEE, NY TO ALLOW 12 AND 13 YEAR OLD LICENSED HUNTERS TO HUNT DEER WITH A FIREARM OR CROSSBOW DURING HUNTING SEASON WITH THE SUPERVISION OF A LICENSED **ADULT** 

Legislator Yunker offered the following resolution:

**WHEREAS**, Pursuant to Environmental Conservation Law, Sec. 11-0935, (hereinafter ECL 11-0935), the County of Genesee (hereinafter "County") elects to participate in the temporary NYS program to allow for young hunters, ages twelve (12) and thirteen (13), to hunt deer with a crossbow, rifle, shotgun, or muzzle loaded firearm through December 31, 2023.

WHEREAS, the Following Proposed Local Law Introductory No.1, Year 2021 was duly introduced to the Genesee County Legislature in accordance with the Law: LOCAL LAW INTRODUCTORY NO. 1 YEAR 2021 OF THE COUNTY OF GENESEE, NY TO ALLOW 12 AND 13 YEAR OLD LICENSED HUNTERS TO HUNT DEER WITH A FIREARM OR CROSSBOW DURING HUNTING SEASON WITH THE SUPERVISION OF A LICENSED ADULT

**BE IT ENACTED** by the Genesee County Legislature as follows:

#### **Section 1. Legislative Intent**

The intent of this Local Law is to authorize the County to permit 12 and 13 year old individuals to participate in the new and safe hunting opportunities in accordance with Environment Conservation Law ECL 11-0935. The enacted 2021-2022 New York State Budget, includes a pilot program, allowing the opportunity for youth hunters, ages 12 and 13, to hunt deer with certain firearms and crossbow through December 31, 2023, if a County authorizes such action within their municipality. The County is passing this Local Law because hunting is a valued tradition for many families, and this new opportunity allows experienced, adult hunters to introduce the value of hunting to the next generation. Furthermore, teaching young people safe, responsible, and ethical hunting practices will ensure a rewarding experience for the youth, while providing quality food to families and contributing to important deer management population control practices.

#### Section 2. Definitions for the purposes of this Local Law:

- **a.** "physical control" shall mean that the physical proximity of such minor to the parent, guardian or person is such that the parent, guardian or person is reasonably able to issue verbal directions and instructions, maintain constant visual contact, and otherwise provide guidance and supervision to the minor.
- **b.** "eligible area" shall mean within the boundaries of the County.

#### **Section 3. State Requirements**

A hunting license holder who is twelve or thirteen years of age may hunt deer with a crossbow, rifle, shotgun, or muzzle-loading firearm as provided in this title in an eligible area provided that;

- **a.** Such minor is accompanied by their parent or legal guardian, or by a person designated in writing by such parent or legal guardian on a form prescribed by the Environmental Conservation Department who is twenty-one years of age or older; and
- **b.** Such parent, guardian or person has had at least three years' experience in hunting deer; and
- c. Such parent, guardian or person holds a hunting license; and
- **d.** Such parent, guardian or person maintains physical control over the minor at all times while hunting; and
- **e.** Such parent, guardian or person and the minor remain at ground level at all times while hunting; and
- **f.** Such parent, guardian or person and the minor shall each display either a minimum total of two hundred fifty square inches of solid fluorescent orange or pink or patterned

fluorescent orange or pink consisting of no less than fifty percent fluorescent orange or pint material worn above the waist and visible from all directions, or a hat or cap with no less than fifty percent of the exterior consisting of solid fluorescent orange or pink material and visible from all directions.

#### **Section 4. Local Law Filing Requirements**

A copy of this Local Law shall be sent to the New York State Department of Conservation as well as the NYS Department of State.

#### Section 5. Severability

If any clause, sentence, paragraph, subdivision, section or part of this law, or the application thereof to any person, individual, corporation, firm, partnership, entity or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgement shall not affect, impair, effect or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law or in its application to the person, individual, corporation, firm, partnership, entity or circumstance directly involved in the controversy in which such order or judgement shall be rendered.

#### **Section 6. Effective Date**

This Local Law shall take effect upon proper filing with the Office of the Secretary of State, and shall expire and be deemed repealed on December 31, 2023.

WHEREAS, The Clerk of the Genesee County Legislature did post a certified notice of Public Hearing on said proposed Local Law on the bulletin board in the Old Courthouse, and WHEREAS, The Clerk of the Genesee County Legislature did cause to be published in the Batavia Daily News, the official newspaper of the County of Genesee, the notice of Public Hearing on Local Law Introductory Number 1, Year 2021, and

**WHEREAS**, a Public Hearing was held at 5:30 on May 12, 2021 in the Legislature Chambers of the Old Courthouse, Batavia, New York and via Zoom videoconference at which time all interested persons who wished to speak were heard, Now therefore Be it

RESOLVED, that "LOCAL LAW INTRODUCTORY 1, YEAR 2021 OF THE COUNTY OF GENESEE, NY, TO ALLOW 12 AND 13 YEAR OLD LICENSED HUNTERS TO HUNT DEER WITH A FIREARM OR CROSSBOW DURING HUNTING SEASON WITH THE SUPERVISION OF A LICENSED ADULT" be known as Local Law No. 3

Year 2021, for the County of Genesee as introduced April 28, 2021, be and hereby is adopted. Prior to the vote Legislator Yunker further stated his support of this local law and was pleased to see the opportunity to opt-in included in the Governor's Budget. He further stated how this will be beneficial for deer management and provide youth in our rural community the opportunity to hunt alongside a licensed adult.
