The Board discussed moving to Phase II with Davis Design. Anderson stated he felt that before the Board decided whether to move on to Phase II something should be put in the newspaper to allow citizens to be aware of what happened with Phase I and what will happen with Phase II. Davis Design Phase II discussion and decision will be placed on next week's agenda under unfinished business.
