

The Regular Meeting of the Board of Trustees was held on Thursday, March 12, 2020 at Lawrence Village Hall, 196 Central Avenue, Lawrence, New York 11559.

WORK SESSION - Mayor Edelman called the work session to order at 7:05 p.m.

Board Action: No board action was taken.

REGULAR MEETING

Mayor Edelman called the regular meeting to order at 8:07 p.m.

PLEDGE OF ALLEGIANCE

Approval of minutes: BOT February 13, 2020
Special BOT February 24, 2020

Board Action: Trustee Goldstein moved the approval of the February 13, 2020 BOT meeting minutes and the February 24, 2020 Special BOT meeting minutes. Trustee Kaufman seconded the motion. All in favor. (Deputy Mayor Fragin abstained from voting for both minutes since he was not in attendance at either meeting.)

GOOD & WELFARE

- 1) Mayor Edelman noted that Trustee Diamond was under the weather and considerably, stayed home. He wished her well and a speedy recovery.

- 2) Mayor Edelman introduced John Cheshire, the new General Manager of the LY&CC from Kemper Sports, who will be working with Mr. Cory Menking. Mr. Cheshire was officially welcomed by all the Board members.
- 3) Mayor Edelman expressed deep condolences on behalf of himself and the Board to Trustee Uri Kaufman (and his family) on the loss of his father.
- 4) Mayor Edelman noted that the Board and Community Meeting originally scheduled for March 26th regarding disposition of the former water/sewer treatment plant site property may or may not be postponed, due to the Coronavirus. The Village has not yet made a decision.
- 5) Mayor Edelman noted that the Lawrence Association meeting scheduled for March 18th, will have George Pappas from Sanitary District #1, attending (speaking regarding sanitation).
- 6) Mayor Edelman showed those in attendance the large, bright, safety signage that the Village obtained to place in the Harborview area, as per the residents' requests.
- 7) Mayor Edelman announced that a company that provides sunscreen dispensers for hospitals (such as the former LIJ, now Northwell Health) approached the Village to provide free sunscreen "stands/dispensers" in various locations at the LY&CC, for the golfers, tennis players and marina members at no charge. It would just note that the hospital is sponsoring the program. In addition, they would take full responsibility for filling/re-filling the dispensers and maintaining them. It's a beneficial service for the community.
- 8) Mayor Edelman stated that with regard to the Coronavirus, the Village sent out an e-mail forwarding the New York State Department of Health Coronavirus information letter in addition to the myriad information being disseminated by the shuls and news. The Mayor wished everyone in the Village well and requested that everyone take the best care that they can and follow the recommended precautions to stay safe and healthy. Trustee Kaufman stated that he heard that the NYS Governor had banned all gatherings of more than 500 people; and even if it's less than 500 people, they're requesting that people bring in half the amount of people that would normally fill that venue, and thus added, "With that in mind, I would propose that we deny all tent permits for events, until further notice." Discussion ensued in this regard.

Board Action: Trustee Kaufman moved the approval to ban permits for tents for public gatherings, from the VOL Building Department, henceforth, indefinitely, until further notice; due to the NYS Governor's State of Emergency (per the Coronavirus). Deputy Mayor Fragin seconded the motion. All in favor.

- 9) Mayor Edelman noted that the Village's newest Building Inspector, James Elliott, has been patrolling the vendors along Central Avenue (and throughout the Village), and monitoring the garbage/refuse; which has been a complaint from residents and the Lawrence Association. He has issued warnings and will be issuing summonses when necessary to curtail the matter.
- 10) Mayor Edelman announced that Lawrence Village Hall has implemented a recycling program with Sanitary District #1.
- 11) Mayor Edelman stated that the "sinking bus stop area" on Central Avenue, across from Village Hall, has been repaired by the approved outside contractor (Cosenza Patitucci Construction Corp.), satisfactorily.
- 12) Mayor Edelman noted that the Nassau County Police Department has put out signage on Causeway to have the residents lock their cars for security purposes. Deputy Mayor Fragin questioned its efficacy.
- 13) Mayor Edelman stated that there are many Village residents who are happy with the sidewalk repairs. The Village has done approximately 80% of the repairs at the request of the homeowners, who will be billed/invoiced for the cost; with the remaining 20% being done by the homeowners, themselves. He added that so far the project is going beautifully.
- 14) Mayor Edelman noted that per Ms. Rochelle Kevelson's request at the last BOT meeting, a handicapped parking spot will be installed behind Traditions. The Mayor was able to locate a spot for that. He wanted to thank Ms. Kevelson for bringing this item to the Board's attention.
- 15) Trustee Goldstein stated that he has had a couple of complaints from people "regarding the people who are giving tickets in the back parking lot". He went on to say: "They're not checking for stickers to make sure the cars have them. They just give tickets and I'm asking that the ticket people be notified before they write tickets, to please walk around the car to make sure that they have their stickers on them? And if they don't, of course give a ticket; and if they do, you know, just walk away." Village Administrator Ronald Goldman responded that the

administration would remind them. Mr. Goldman confirmed that employees of Trustee Goldstein, who had received tickets in error, had their tickets resolved by the Court. Trustee Goldstein added that “we could save a lot of headache if in the first place if they would just look, they wouldn’t have to come to the Village to look at it”.

- 16) Trustee Goldstein stated that he had a couple of complaints from residents who received letters to remove their basketball hoops. He inquired if the Village had clear laws regarding basketball hoops in the driveways. Village Administrator Ronald Goldman responded that as far as he was aware, the people who received the notices were posing a threat to vehicular and pedestrian traffic. Discussion ensued in this regard. The Village Code mentions “recreational structures”, which includes the “mobile” basketball hoops, which, when moved into the street pose a potential hazard to vehicular and pedestrian traffic. Mayor Edelman stated that the Village would look into this, and per Trustee Goldstein’s request, see what other localities are doing.
- 17) Deputy Mayor Fragin, once again, inquired about improving the Village’s e-mail communication system. He had received an e-mail from the Village via Code Red, since the new MailChimp system (approved at the February 13th BOT meeting) had not yet been implemented, and had to open the attachment via a link. Deputy Village Administrator Gerry Castro responded that the registration with MailChimp is in the works and should be ready shortly for use by the Village.
- 18) Deputy Mayor Fragin mentioned that two security grant deadlines coming up, for houses of worship to get money for security (NYS on March 16th and the federal grant coming up in April).
- 19) Deputy Mayor Fragin stated that the speed radar trailer sign on Causeway was interfering and possibly causing a hazard with the alternate side of the street parking. Village Administrator Ronald Goldman responded that the Village would move the speed radar trailer to another location. It had been put there per Ms. Rochelle Kevelson’s request at the February 13th BOT meeting and had served its purpose and would now be moved.
- 20) Deputy Mayor Fragin raised the issue of the State of Emergency with regard to the LY&CC functions already booked and refunds. Discussion ensued in this regard.

- 21) Mayor Edelman noted that the Harbormaster had removed the large metal object from the Bannister inlet with his team in response to Trustee Kaufman's request at the last BOT meeting. He noted this item was a hazard in the water behind his house, on Harborview.
- 22) Trustee Goldstein's daughter-in-law, Avia, who was doing a school report on how villages run, asked questions to which the Mayor and Board responded.

Board Action: Trustee Goldstein moved the approval of General Fund Abstracts #989, #990, #991 and #992; Recreation Fund Abstracts #424, #425, #426, #427, #428, #429 and #430; and Payroll Fund Abstracts #022120 and #030620. Trustee Kaufman seconded the motion. All in favor.

Item 2 – Approve Resolution that applications for corrections of assessment on the 2020/2021 tentative assessment roll be in all aspects denied and that the tentative assessment is in all respects confirmed

Board Action: Deputy Mayor Fragin moved to approve a Resolution that applications for corrections of assessment on the 2020/2021 tentative assessment roll be in all aspects denied and that the tentative assessment is in all respects confirmed (attached hereto as "Exhibit A"). Mayor Edelman seconded the motion. All in favor.

Item 3 – Present tentative 2020 – 2021 Budget to Board of Trustees and set date for Public Hearing for April 2, 2020

Village Administrator Ronald Goldman and Village Deputy Treasurer Lina Fusco presented the tentative 2020 – 2021 General Budget to the Board of Trustees and requested that the Mayor and Board set a date for a Public Hearing for April 2, 2020.

Board Action: Trustee Kaufman moved to approve setting the date for a Public Hearing for the April 2, 2020 BOT meeting, at 8:00 p.m., to discuss the 2020 – 2021 Tentative General Budget presented to the Board of Trustees. Mayor Edelman seconded the motion. All in favor.

Item 4 - Approve/Schedule Public Hearing on Annual Stormwater Management Report for April 2, 2020 BOT meeting

Board Action: Mayor Edelman moved to approve setting the date for a Public Hearing for the April 2, 2020 BOT meeting, at 8:00 p.m., to discuss the Annual Stormwater Management Report (MS4). Trustee Goldstein seconded the motion. All in favor.

Item 5 – Resolution to appoint Election Inspectors

(1) That Inspectors of Election be employed at \$290.00 for Chair and \$240.00 for Inspectors for the Village Election to be held on June 16, 2020.

(2) That the following persons be and hereby are appointed as Inspectors of Election: Marinnette Flores, Ilana T. Snyder, Joel Goldshor, Sandra C. Goldsmith, Phyliss A. Raiola, Dawn Marie Sarro and Dr. Stephen Rand; the last three of which will be alternates

Board Action: Mayor Edelman moved to adopt the following Resolution to appoint Election Inspectors:

RESOLUTION APPOINTING INSPECTORS OF ELECTION

WHEREAS, pursuant to the Election Law of the State of New York, personal registration is required in the Village of Lawrence, for village elections, and

WHEREAS, pursuant to the Election Law, the Board of Trustees is required, at least 40 days prior to the village election, to appoint an even number of inspectors of election, and fix their compensation, and designate one of them as Chair,

NOW, THEREFORE, BE IT RESOLVED, that the following persons are hereby designated and appointed inspectors of election, and they shall meet on June 16, 2020 at the place designated for such village election, between the hours of 7 a.m. and 9 p.m., inclusive, for the purpose of the village election:

AND IT IS FURTHER RESOLVED, that Marinnette Flores be, and hereby is, designated to act as Chair of said inspectors of election, and it is further

RESOLVED, that the compensation for the Chair shall be \$290.00 and for each of the remaining aforesaid inspectors of election shall be \$240.00 for each day that said inspectors of election may be required to serve.

Trustee Kaufman seconded the motion. All in favor.

Item 6 – Approval to retain pest control vendor

Board Action: Deputy Mayor Fragin moved to approve the Mayor executing the renewal Agreement with Mosquito Seekers as the Village's pest control vendor, in the amount of \$1,000.00 per application; not to exceed a total of \$10,000.00 maximum; consistent with the Village's Procurement Policy and declare such action Type II under SEQRA. Mayor Edelman seconded the motion. All in favor.

Item 7 – LY&CC status report

Park Commission Vice Chairperson Jacqueline Handel gave a caterer's report on the LY&CC. An overview provided the following information:

- Royalton Caterer's bookings are very similar to what they had been in the past
- The Kosher Caterers' bookings are much greater now than they had been in the past
- The Grill Room (the smaller room with the bar) will be open full-time starting next week. It has been open three (3) days a week until now.
- The Half Way House should be open around April 15th, depending upon the weather
- Ms. Handel explained that the Kosher area was not secured properly so one of the caterers installed an eight (8) foot high gate/fence, that is locked. She went on to say that there is a need to enforce the litter/garbage conditions behind the locked gate, in the Kosher area; as well as granting access for the Fire Marshall, exterminator, etc. Discussion ensued in this regard.

Item 8 – Approve purchase of new asphalt hot box

Board Action: Trustee Kaufman moved to approve the purchase of a new asphalt hot box (4 ton trailer mount diesel with dump & electric brake – hot mix transporter), off of NYS contract from Trius, in the amount of \$31,131.15; as the lowest responsible quote/proposal. Trustee Goldstein seconded the motion. All in favor.

Item 9 – Update regarding EV charging stations

Deputy Village Administrator Gerry Castro gave an update with regard to the EV charging stations for the LY&CC, stating that the specs would be put out to bid within the next ten (10) days. He went on to say that the Village received an e-mail with information on a company, Chargepoint, who they have a state contract with, and offer it

out to other municipalities with no charge or restrictions attached. Mr. Castro will move forward with this endeavor.

Item 10 – Update regarding security cameras

Deputy Village Administrator Gerry Castro gave an update with regard to the security cameras, stating that the Village was going to put this out to bid within the next ten (10) days, using the grant funding of \$77,500.00; thanks to Mayor Edelman working with Legislator Kopel for the grant/funding. Discussion ensued in this regard.

Item 11 – Announce plans for Passover preparations

Mayor Edelman announced that, as in previous years, the Village would be facilitating a Chometz Burning/disposal, at the Lawrence LIRR train station, on Wednesday, April 8th, from 7:00 a.m. to 12:00 p.m.

Deputy Mayor Fragin requested an update on the Rt. 878 street lighting. Deputy Village Administrator Gerry Castro stated that the vendor had recently completed his assessment, and he is going to issue a report on what needs to be repaired so the Village can develop the specs and go out to bid for the repairs. The Mayor went on to say that the Village would be receiving money from NYS Senator Todd Kaminsky, NYS Assemblywoman Melissa (Missy) Miller and NYS Assemblywoman Stacey Pheffer Amato, to assist the Village in paying for these repairs.

Deputy Mayor Fragin inquired as to who is responsible for “trash” near the Atlantic Beach Bridge. Discussion ensued in this regard. Mayor Edelman stated that Rock Hall Road also has an issue with trash, which is a Nassau County Road. Deputy Village Administrator Gerry Castro stated that the Nassau County DPW recently changed their foreman, and that he would look into contacting the new person, to have them clean on a more regular schedule.

Mayor Edelman added that the Village sent out maintenance “warning” letters to the Business District vendors, regarding litter and trash removal.

On motion by Trustee Kaufman seconded by Deputy Mayor Fragin and unanimously approved, the Board adjourned at 9:06 p.m.
