

The Regular meeting of the Board of Trustees was held on Thursday, March 16, 2017 at the Lawrence Village Hall, 196 Central Avenue, Lawrence, New York 11559.

WORK SESSION - Mayor Edelman called the work session to order at 7:00 p.m.

No Board action was taken.

REGULAR MEETING - Mayor Edelman called the regular meeting to order at 8:05 p.m.

GOOD & WELFARE

1. Mayor Edelman extended sincere condolences on behalf of the Village and Board of Trustees to the family of former Village Historian James Thayer, who served out Village for many years. A note has been sent to the family as well, expressing sympathy on behalf of the Mayor, Board and Village. The Mayor added that the Village has a new historian, George Mallis, who had previously been introduced at a Board meeting when he was first appointed.
2. Village resident, Ms. Jacqueline Handel, commented on the beautiful and outstanding job that the Village's DPW Department, under the supervision of DPW Superintendent Robert Daniels, did regarding the snow removal throughout the Village, during and after the recent snow storm. Mayor Edelman added that the Highway Department crew came in to work at 4:00 a.m. to make sure that all of the Village roads were salted, prior to the residents waking up (and the sunrise), to melt the remaining ice and snow to keep it from freezing. The Mayor commented that he had received six or seven complimentary phone calls and six or seven e-mails as well, commending the exemplary snow removal by the Village. He added that usually, people call to complain, not give compliments.
3. Deputy Mayor Fragin stated for the record, that even though there's not much the Village can do, due to this latest snow storm ("blizzard" which did not happen),

the United States Postal Service did not deliver the mail for the second time this month. This does not quite concur with their (non-official) motto/mission; "Neither snow nor rain nor heat nor gloom of night stays these couriers from the swift completion of their appointed rounds". Deputy Mayor Fragin did call the Lawrence Post Office and was told that in the interest of safety, it was decided that they would not deliver the mail, due to the predicted storm. Although a large amount of snow was expected, the reality was that the snow storm was much less severe and with much less accumulation. He inquired if there was anything that could be done. Discussion ensued in this regard. Village resident, Paris Popack, added that the mail service is not processed locally anymore, which has increased the delivery time(s).

Village Administrator Ronald Goldman stated that he would follow-up with the U.S. Postal Service to see what, if anything could be done. Administrator Goldman added that there was another incident with regard to the late delivery of the Lawrence Association's mailing, that he would like to have addressed with the U.S. Postal Service as well. Mayor Edelman concurred and Deputy Mayor Fragin thanked Administrator Goldman for his anticipated assistance in this regard.

4. Trustee Goldstein stated that he noticed an increased police presence (police cars stationed at various Village locations and patrolling), since Inspector Lee Steinberg of the Fourth Precinct and his officers attended (and spoke with Village residents) at the January 19, 2017 Board meeting, which was a marked improvement and change for the better. Mayor Edelman added that he met two weeks ago with Captain Tara Comiskey, Deputy Commanding Officer of the Fourth Precinct, who replaced Captain Kenneth Catalani as the Village's Liaison, regarding increased patrols especially during Purim, Passover, etc. He stated that she took notes, was very engaged, cooperative and seemed to be a very fine person looking to assist the Village in its needs and the Mayor's requests. Mayor Edelman raised an issue that occurred regarding OHEL Home and Captain Comiskey's assistance in getting the matter attended to efficiently and quickly. He stated that the relationship that the Village has with the Fourth Precinct now has improved "150%", compared with the "old system". Discussion ensued in this regard.
5. Village resident, Paris Popack inquired if placing the muni-meter tickets in the vehicle's windshield was required, since she did not see any instructions to do so on the muni-meter. It was confirmed by Mayor Edelman and Village Administrator Ronald Goldman that it was not required to place the tickets/receipts in the vehicle windshield.

**ACKNOWLEDGING THE 2014 and 2015 AUDITS

WHEREAS, Section 2019-a of the Uniform Justice Court Act (UJCA) requires that village justices provide their court records and dockets to their respective village auditing boards annually, and that such records be reviewed and audited; and

WHEREAS, in accordance with Section 2019-a of the UJCA, the Village of Lawrence Justice Court provided the Village of Lawrence Board of Trustees with its records and dockets for the year(s) ending May 31, 2014 and May 31, 2015; and

WHEREAS, an audit of the Court's 2014 and 2015 records was performed by Albrecht, Viggiano, Zureck & Company, P.C.

NOW THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Lawrence, in accordance with Section 2019-a of the UJCA, hereby acknowledges that the required examination and audit of the Court's 2014 and 2015 records was conducted and completed.

Deputy Mayor Fragin seconded the motion. All in favor.

Board Action: No Board action was taken.

Item 4 – Approve Resolution that applications for corrections of assessment on the 2017/2018 tentative assessment roll be in all aspects denied and that the tentative assessment is in all respects confirmed

Board Action: Mayor Edelman moved the approval of a Resolution that applications for corrections of assessment on the 2017/2018 tentative assessment roll be in all aspects denied and that the tentative assessment is in all respects confirmed (attached hereto as "Exhibit A"). Deputy Mayor Fragin seconded the motion. All in favor.

Item 5 – Present tentative 2017 – 2018 Budget to Board of Trustees and set date for Public Hearing for April 6, 2017

Village Administrator Ronald Goldman and Village Deputy Treasurer Lina Fusco presented the tentative 2017 – 2018 Budget to the Board of Trustees and requested that the Mayor and Board set a date for a Public Hearing for April 6, 2017.

Board Action: Trustee Goldstein moved to approve setting the date for a Public Hearing for the April 6, 2017 BOT meeting, at 8:00 p.m., to discuss the 2017 – 2018 Tentative Budget presented to the Board of Trustees. Trustee Diamond seconded the motion. All in favor.

Item 6 –Schedule Public Hearing on Annual Stormwater Management Report for April 6, 2017 BOT meeting

Board Action: Trustee Diamond moved to approve setting the date for a Public Hearing for the April 6, 2017 BOT meeting, at 8:00 p.m., to discuss the Annual Stormwater Management Report (MS4). Trustee Goldstein seconded the motion. All in favor.

Item 7 – Approve Park Commission recommendations

- a. Approve installation of a Pickleball court at the LY&CC

Park Commission Chairman Howard Siskind and Vice Chairperson Jacqueline Handel made a presentation in support of installing two (2) Pickleball courts at the LY&CC. One proposal was received in the amount of \$8,500.00 for the installation of two (2) Pickleball courts, in the Tennis Court parking lot; adjacent to the Driving Range; to be used on an intermittent basis. Park Commission member Paris Popack endorsed the addition of Pickleball enthusiastically. Discussion ensued in this regard. Mayor Edelman requested that LY&CC General Manager Leo McMahon get another estimate/proposal to be discussed further at the April 6th BOT meeting.

Board Action: Deputy Mayor Fragin moved to table this item. Trustee Diamond seconded the motion. All in favor.

Item 8 – Resolution to appoint Election Inspectors

Board Action: Trustee Diamond moved to adopt the following Resolution to appoint Election Inspectors:

RESOLUTION APPOINTING INSPECTORS OF ELECTION

WHEREAS, pursuant to the Election Law of the State of New York, personal registration is required in the Village of Lawrence, for village elections, and

WHEREAS, pursuant to the Election Law, the Board of Trustees is required, at least 40 days prior to the village election, to appoint an even number of inspectors of election, and fix their compensation, and designate one of them as Chair,

NOW, THEREFORE, BE IT RESOLVED, that the following persons are hereby designated and appointed inspectors of election, and they shall meet on June 20, 2017 at the place designated for such village election, between the hours of 7 a.m. and 9 p.m., inclusive, for the purpose of the village election:

AND IT IS FURTHER RESOLVED, that Anthony J. Cascardi be, and hereby is, designated to act as Chair of said inspectors of election, and it is further

RESOLVED, that the compensation for the Chair shall be \$200.00 and for each of the remaining aforesaid inspectors of election shall be \$175.00 for each day that said inspectors of election may be required to serve.

Trustee Goldstein seconded the motion. All in favor.

Item 9 – Approve updated Building and Tax Department(s) web-based programs(s)

Board Action: Trustee Goldstein moved the approval to purchase web-based (integrated) software for the Village of Lawrence's Building and Tax Department(s) from Muncity Software Consulting Associates (the lowest responsible proposal), in the amount of \$16,700.00; plus an annual service fee of \$1,400.00 for the Tax Department/collection and \$1,860.00 for the Building Department. Deputy Mayor Fragin seconded the motion. All in favor.

Mayor Edelman noted that the municipal accounting/bookkeeping program in use by the Village is very antiquated and also needs to be updated/changed. Deputy Treasurer Lina Fusco stated that she and her staff are currently researching (with other municipalities and multiple vendors) the best and most cost effective options available, and would hopefully have a recommendation by the April 6, 2017 BOT meeting. (At the outside, it would be for the May 11th meeting.) Trustee Goldstein suggested that Deputy Treasurer Fusco call the Village of Mineola, who just updated their bookkeeping/accounting system last month. Ms. Fusco said that she would do so if they had not already been contacted.

Item 10 – Set date for Public Hearing to amend Chapter 8: Appearance Tickets - §8.2 Persons authorized to issue tickets (H) Village Inspectors

Board Action: Deputy Mayor Fragin moved to approve setting the date for a Public Hearing for the April 6, 2017 BOT meeting, at 8:00 p.m., to discuss amending Chapter 8: Appearance Tickets - §8.2 Persons authorized to issue tickets (H) Village Inspectors, of the Village Code. Trustee Diamond seconded the motion. All in favor.

Item 11 – Approval to retain pest control vendor

Board Action: Trustee Goldstein moved the approval to (continue to) retain Mosquito Seekers for the Village of Lawrence's pest control vendor, in the amount of \$1,100.00 per application; not to exceed a total of \$12,000.00 maximum. Trustee Diamond seconded the motion. All in favor.

Mayor Edelman noted his meetings with another pest control vendor as well as Mr. Gordon from Mosquito Seekers, with whom he was quite impressed. The Mayor stated that this was in addition to the black box traps that the Village distributes to many residents, which are very helpful.

Deputy Mayor Fragin inquired if there was any method of quality control to monitor the effectiveness of these applications, but Mosquito Seekers. Village Administrator Ronald Goldman responded that the Mosquito Seekers applications/treatments are mostly preventative in nature. Discussion ensued in this regard.

Item 12 - Approve Annual Spring LY&CC Tennis Court Reconditioning

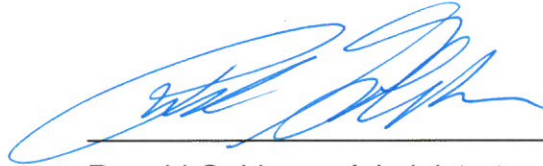
LY&CC General Manager Leo McMahon explained the annual spring resurfacing/reconditioning of the LY&CC Tennis Courts, why it is necessary every year and the various proposals. The lowest responsible proposal/estimate is from Championship Tennis Courts, LLC, (Richard Bustamante) whom the Village has used

for the past six years, in the amount of \$15,570.00. Championship last resurfaced the LY&CC Tennis Courts in 2015. Last year (2016) the LY&CC Tennis Courts were re-graded and resurfaced, which is required every 10 to 15 years and cost the Village \$26,500.00, which was also done by Championship Tennis Courts, LLC. Discussion ensued in this regard.

Board Action: Trustee Goldstein moved the approval of the annual spring resurfacing of the LY&CC Tennis Courts by the lowest responsible proposal/quote from Championship Tennis Courts, LLC, in the amount of \$15,570.00. Trustee Diamond seconded the motion. All in favor.

There being no further business, on motion by Mayor Edelman, seconded by Trustee Goldstein and unanimously approved, the meeting was adjourned at 8:52 p.m.
