Board Action: Deputy Mayor Popack moved the approval of the September 14, 2023 BOT meeting minutes. Mayor Edelman seconded the motion. All in favor.

GOOD & WELFARE

- 1) Dr. Allan Simon of 284 Central Avenue, Lawrence, announced that he was once again elected President of LY&CC Men's Tennis. He stated that he is looking to working with everyone to improve Lawrence Tennis and noted that he was interested in Item #6, the 2024 LY&CC membership rates. Mayor Edelman responded that Dr. Simon was doing a great job and Trustee Roz added that the Board was going to make Tennis great. Dr. Simon received a round of applause, congratulations and thanks.
- 2) Mayor Edelman stated that he spoke to the Deputy Mayor of Lawrence's Sister City (for approximately four years now), Ma' Ale Adumim in Israel (that borders the current conflict/war), Rachely Vasal, see how things are and give them our best wishes; and offer any means of support that the Village Lawrence and its residents can provide. - 3) Mayor Edelman reminded everyone that there is a Rally in Support of the State of Israel on Sunday, October 15th, in Andrew J. Parise Park (Cedarhurst Park), from 4:00 p.m. 5:30 p.m. The Village will also send out this announcement in an e-mail blast.
- 4) Mayor Edelman thanked Deputy Mayor Popack for the wonderful LY&CC Golf Members Appreciation Dinner.
