The Board convened in Work Session at 7:02 p.m. to discuss various agenda items.

WORK SESSION

Board Action: Deputy Mayor Landy moved to go into Executive Session at 7:03 p.m. to obtain Legal Counsel. Trustee Popack seconded the motion. All in favor.

Board Action: Deputy Mayor Landy moved to close/exit Executive Session at 7:50 p.m. Trustee Popack seconded the motion. All in favor.

Work Session ended at 7:50.

REGULAR MEETING

Deputy Mayor Landy called the Regular Meeting to order at 8:00 p.m.

PUBLIC HEARING

March 9, 2023

Public Hearing regarding proposed Local Law #2 of 2023 to amend §212 of the Village Code concerning Zoning Ordinance revisions

Board Action: Deputy Mayor Landy moved to open the Public Hearing regarding proposed Local Law #2 of 2023 to amend §212 of the Village Code concerning Zoning Ordinance revisions (attached hereto as Exhibit "A"). Trustee Popack seconded the motion. All in favor.

Board Action: Upon hearing no further comments Deputy Mayor Landy moved to close the Public Hearing regarding proposed Local Law #2 of 2023 to amend §212 of the Village Code concerning Zoning Ordinance revisions (attached hereto as Exhibit "A"). Trustee Popack seconded the motion. All in favor.

Board Action: Deputy Mayor Landy moved the approval of proposed Local Law #2 of 2023 to amend §212 of the Village Code concerning Zoning Ordinance revisions (attached hereto as Exhibit "A"). Trustee Kutner seconded the motion. All in favor; the motion passes and Local Law #2 of 2023 is adopted.

Village Administrator Ronald Goldman noted that the drafting of Local Law #2 of 2023 was the result of the efforts of a great many people. Every so often the Village reviews its Zoning Code and sees whether it's up to date and is current. There was a committee that met on August 30th; on that note, Deputy Mayor Landy acknowledged the presence of the Village's Board of Zoning Appeals Chairman, Lloyd Keilson, who has served for many, many years (despite his youthful appearance); and thanked him for his service, all of his efforts and hard work, making sure our Village stays to Code and is as beautiful as it is. Chairman Keilson received a well-deserved round of applause. Deputy Village Administrator Gerry Castro went on to say that the zoning changes presented to the Board tonight (and approved) were the result of an initial meeting on August 30th, between thirteen architects and contractors; including Shmuel Flaum, Amiel Savaldi, Joe Rothchild, Stanley Mayerfeld, Michael Kaffash, Samuel Neuwirth, John Macleod, David Freidus, Danielle Bokor, Jacob Malek, Ben Goldbaum, Morty Schiffer, David Profesorske and Evan Genack. There was also Village staff present as well as certain Village officials, where they discussed various issues, variances, needs and "after many, many months of discussion we came to the conclusion of these zoning code revisions". Village Counsel Stephen Martir noted for the record that pursuant to Section 239-L&M of the General Municipal Law; the Law was referred to the Nassau County Department of Public Works/Nassau County Planning Commission, and they deferred it to the Village to take all action as it deem necessary. Village Administrator Goldman thanked Mr. Martir for his swift and efficient efforts on the Village's behalf.

Public Hearing regarding the proposed Local Law of 2023 to amend the Village Code for Zoning

Board Action: The Public Hearing regarding the proposed Local Law of 2023 to amend the Village Code for Zoning was adjourned until the next BOT meeting, on April 20, 2023.

PLEDGE OF ALLEGIANCE

Approval of minutes: BOT February 9, 2023

Board Action: Deputy Mayor Landy moved the approval of the February 9, 2023 BOT meeting minutes. Trustee Popack seconded the motion. All in favor.

GOOD & WELFARE

- 1) Deputy Mayor Landy noted only the second absence of Mayor Edelman in all of his tenure as Mayor ("and hopefully no more").
- 2) Deputy Mayor Landy stated that the Village of Lawrence is part of the resistance, joining with other towns, mayors and villages, including the Town of Hempstead (TOH) which is under Supervisor Donald Clavin; to oppose Governor Kathy Hochul's Housing Plan. He went on to say; "We recently attended TOH Supervisor Donald Clavin's meeting to plan against it and hopefully we'll have a lot of success with keeping that in check". Deputy Mayor Landy acknowledged the presence of TOH Liaison Martin Schwartz, who is representing Donald Clavin at this meeting.
- 3) On behalf of all Village staff, Board members, himself and his family, Deputy Mayor Landy expressed condolences to Deputy Village Administrator Gerry Castro and his family on the loss of his grandfather.
- 4) Deputy Mayor Landy announced the next Lawrence Civic Association meeting will be on March 16th, and urged everyone to attend, and more importantly to join the Lawrence Association. He commended and thanked Judi Bernstein for taking over the Lawrence Civic Association, all of her hard work, efforts and the tremendous success at the last meeting with the Town of Hempstead regarding the moratorium.
- 5) Deputy Mayor Landy congratulated LY&CC General Manager Cory Menking on being appointed to serve as a member of the 2023 CMAA National Committee and noting that he is not present at tonight's meeting due to his attendance at a training conference.
- 6) Deputy Mayor Landy announced that, after a year-long delay, the amazing, new street sweeper is now operational.
- 7) Deputy Mayor Landy wished a special Mazel Tov to Trustee Paris Popack and her husband Joe Popack on the marriage of their daughter.
- 8) Deputy Mayor Landy, noting that Trustee Fragin was not in attendance, wished him and his wife Mazel Tov on their son Kalman's upcoming wedding.
- 9) Deputy Mayor Landy announced that the Village was recently inducted as a Tree City, and the Chairman of the Village's Tree City Committee, Mr. Ed Gottlieb, is currently at the conference representing the Village. Kudos to Deputy Village Administrator Gerry Castro on this accomplishment.

- 10) Village resident and leading the Lawrence Civic Association, Judi Bernstein thanked Mr. Martin Schwartz, the Village's Town of Hempstead Liaison, who was present, for his assistance; and Judge Jack Lieber for success getting the one-year moratorium (extension) at the TOH meeting. She announced that the next Lawrence Civic Association meeting is on March 16th, at 7:30 p.m., concerning public safety. Police Officer Zanni will be in attendance. Ms. Bernstein noted that Congressman Anthony D'Esposito, who is doing a fabulous job, will not be in attendance because he will be with Homeland Security at the border; however, his assistant will be in attendance.
- 11) Park Commission Vice-Chairperson Jacqueline Handel commended Congressman Anthony D'Esposito on receiving the well-deserved honor of "Man of the Year Award" at the Yeshiva of South Shore dinner on Sunday night, March 5th. She went on to say that he is doing a fantastic job, and everyone at the meeting concurred.
- 12) Village resident Howard Freundlich of 18 Wedgewood Lane stated a concern regarding his neighbor (who faces Broadway) wanting a curb cut in the back of his house onto Wedgewood Lane. All four neighbors/residents on Wedgewood Land are "not happy" about that. Somehow this got approved by the Board of Building Design without any of them knowing. This angered him. His other neighbor, Dr. Kappel, cut down several trees and bushes because he was so upset. They sent letters and spoke before the Board of Trustees at a previous meeting and now they all got notices that this item is once again on the agenda for Monday night's Board of Building Design meeting as though nothing had happened and their complaints had not been heard. This further upset Mr. Freundlich and his neighbors because they had previously spent money on attorneys, issued letters and voiced complaints, making their position very clear, as previously stated. Mr. Freundlich was trying to understand why they are now back to square one. Deputy Mayor Landy responded that the issue was before the Board of Building Design (BBD), which is the appropriate arena to have this matter addressed and not the BOT. Village Administrator Ronald Goldman explained that per his earlier conversation with Mr. Freundlich the matter was inadvertently approved by the BBD prior to the person who made the application becoming the owner of the property, which vacated the prior approval. He has now purchased the property which is now in dispute, which is the reason it is once again before the BBD. Mr. Freundlich and his neighbors could go before the Board of Building Design at Monday night's meeting and describe the issue and his concerns there; but that the Board of Trustees has no authority to decide anything in this arena. It is then up to the Board of Building Design to make a decision. "If they rule against you, you then have the option now, under a changed law, to bring an Article 78." Deputy Mayor Landy concurred that this just the wrong arena. Discussion ensued in this regard.

NEW BUSINESS

Item 1 – Approve Abstracts #'s

Board Action: Trustee Popack moved the approval of General Fund Abstracts #1160, #1161 and #1162; Recreation Fund Abstracts #735, #736, #737, #738, #739, #740 and #741; and Payroll Fund Abstracts #021723 and #030323. Deputy Mayor Landy seconded the motion. All in favor.

Item 2 – Approve Resolution that applications for corrections of assessment on the 2023/2024 tentative assessment roll be in all aspects denied and that the tentative assessment is in all respects confirmed.

Board Action: Deputy Mayor Landy moved to approve a Resolution that applications for corrections of assessment on the 2023/2024 tentative assessment roll be in all aspects denied and that the tentative assessment is in all respects confirmed (attached hereto as Exhibit "B"). Trustee Kutner seconded the motion. All in favor.

Item 3 - Present tentative 2023 – 2024 Budget to Board of Trustees and set date for Public Hearing for April 20, 2023

Board Action: Trustee Popack moved the approval to set the date for a Public Hearing regarding the 2023 – 2024 General Budget for April 20, 2023. Deputy Mayor Landy seconded the motion. All in favor.

Item 4 – Approve/Schedule Public Hearing on Annual Stormwater Management Report for April 20, 2023 BOT meeting

Board Action: Trustee Kutner moved the approval to set the date for a Public Hearing regarding the Annual Stormwater Management (MS4) Report for April 20, 2023. Deputy Mayor Landy seconded the motion. All in favor.

Item 5 - LY&CC Status Report

Trustee Popack presented the LY&CC March 2023 GM Report (attached hereto as Exhibit "C"), noting that LY&CC General Manager Cory Menking was at a conference. She stated that a Restoration Committee Task Force has been formed to compose, communicate and adhere to structured schedules that will restore the grounds to its original, pre-2022 conditions following the New York State project. Trustee Popack acknowledged the presence of Park Commission Chairperson Dr. Sheldon Genack and Co-Chairperson Jacqueline Handel.

Board Action: No Board action was taken.

Item 6 – Approval of Restoration of the LY&CC not to exceed \$650,000.00

Board Action: Deputy Mayor Landy moved the approval of restoration of the LY&CC not to exceed \$650,000.00 (Winterberry is scheduled to begin re-installation of irrigation lines and McDonald & Sons, Inc. has been hired to do the remainder of the restoration). Trustee Popack seconded the motion. All in favor.

Item 7 - Report on LY&CC Snack Bars

Deputy Village Administrator Gerry Castro stated that he is awaiting approvals from the Nassau County Fire Marshall for the ceiling sprinkler system plans and once approved they can be installed and complete the inside; cooking equipment will be installed shortly thereafter and the hood duct and Ansul System (the Ansul Kitchen System is a pre-engineered, automatic fire suppression system that can tackle large, hazardous fires without human intervention) is also in contract already. The Village is in the process of painting, installing the carpet, and the glass door has been installed in the golf simulator room.

Board Action: No Board action was taken.

Item 8 – Zion Park Update/Report

Trustee Popack stated that happily, the swings are “up”/installed and are available for use with the intention of installing additional swings and a gazebo in the near future; with a grand opening, complete with ribbon cutting on the horizon.

Board Action: No Board action was taken.

Item 9 – Approval to retain pest control vendor (and declare it Type II under SEQRA)

Board Action: Deputy Mayor Landy moved the approval to retain Mosquito Seekers as the 2023 Village pest control vendor at an annual cost of \$11,000.00 (below the threshold required for competitive bidding); and declare it Type II under SEQRA. Trustee Popack seconded the motion. All in favor.

Item 10 – Security Update – Cameras

Deputy Village Administrator Gerry Castro stated that remote monitoring and IT concerns have been resolved as of this morning and are currently being tested for active monitoring feasibility.

Board Action: No Board action was taken.

Item 11 – Announce plans for Passover preparations

Deputy Mayor Landy announced the following plans for the Passover 2023 Preparations, to be put on the Village website and sent out in an e-mail blast:

"In anticipation of the upcoming religious holidays, please note the following:

- 1) Along with Sanitary District #1 and the Lawrence-Cedarhurst Volunteer Fire Department, the Village Department of Public Works will have containers available to facilitate the religious ceremony of "Burning Chometz" as well as disposing of bread products on Wednesday, April 5th **FROM 7:00 A.M. UNTIL 12:00 P.M. at the LAWRENCE TRAIN STATION (ZION PARK)**

(Please note, no plastic bags or containers.)

- 2) Our 4th Precinct of the Nassau County Police Department, having been advised that many residents will be away for the holidays, has indicated that there will be increased patrols and surveillance during that time.

The Village has also assigned personnel to visibly patrol the area day and night, and the Auxiliary Police Units will be covering the Village at all hours.

Residents are reminded to **LOCK CAR DOORS** and suspend newspaper and mail deliveries.

"Wishing all our residents and their families a safe and joyous holiday."


Board Action: No Board action was required.

**VILLAGE OF LAWRENCE

Proposed Bill No. 2 of 2023

**A LOCAL LAW TO AMEND
CHAPTER 212 OF THE VILLAGE
CODE CONCERNING ZONING**

BE IT ENACTED, by the Board of Trustees of the Village of Lawrence, as follows:

Section 1. Section 212-35, entitled “Encroachments,” of Article V, entitled “Area Requirements.” of Chapter 212 of the Village Code, entitled “Zoning”, is hereby amended as follows (strikethrough indicates deleted language and bold/underlined indicates added language):

§212-35 Encroachments.

No building or part of a building shall be erected in, upon or over, nor shall they project into a required yard, with the following exceptions:

A. Cornices, eaves, gutters or flues projecting not more than ~~18~~ 30 inches, or windowsills, belt courses or other ornamental features projecting not more than four inches.

* * *

J. The hip or hipped edge of a sloped roof, not exceeding a pitch of 1:1.8, may encroach above a required height/setback ratio.

Section 2. Section 212-39, entitled “Building and all heights; roofs,” of Article V, entitled “Area Requirements.” of Chapter 212 of the Village Code, entitled “Zoning”, is hereby amended as follows (strikethrough indicates deleted language and bold/underlined indicates added language):

§212-39 Building and all heights; roofs.

B. Flat roofs on one- and two-family dwellings may be used in conjunction with pitched roofs on the same building, ~~but shall make up no more than 35% of the total roof area of the building or structure.~~ All pitched roofs on residential buildings also utilizing a flat roof shall have a maximum slope of ~~1:1~~ 1:1.8 (horizontal units: vertical units).

Section 3. Section 212-2, entitled “Word usage and definitions,” of Article I, entitled “General Provisions,” of Chapter 212 of the Village Code, entitled “Zoning”, is hereby amended as follows (strikethrough indicates deleted language and bold/underlined indicates added language):

§212-2 Word usage and definitions.

* * *

B. Certain words in this chapter are defined for the purpose thereof as follows:

* * *

BUILDING AREA

The maximum horizontal cross-sectional area of all buildings on a lot, excluding uncovered porches and decks; trellises; bay windows and other similar architectural features which are not more than six feet in height and do not project more than 18 inches; and eaves, gutters and chimneys projecting not more than 18 30 inches.

* * *

STRUCTURE

Any combination of materials forming any construction, including, without limitation, buildings, swimming pools and other recreational structures as defined herein, walls, fences, signs, antennas, gazebos, trellises, gate posts, platforms and towers. The word "structure" shall be construed as though followed by the words "or part thereof."

SURFACE COVERAGE

The horizontal area of a lot covered by all buildings, structures and other man-made surfaces, including but not limited to driveways, parking areas, swimming pools, patios, terraces and other similar features not less than four feet in width. If a detached garage is located in the rear yard of a dwelling, an area equal to 10 feet times the perpendicular distance from the frontmost wall of such garage to the front building line shall be excluded from surface coverage.

TRELLIS

A framework of post and beam construction whose beam width shall be no wider than 4 inches and shall be placed not closer than 5 inches apart. Trellis beams may be mechanically operated. Trellises must conform with yard regulations and may not exceed 12 feet above the mean grade along the foundation of the wall on which a building is situated.

TWO-FAMILY DWELLING

A building designed or occupied exclusively as the home or residence of two families living independently of each other.

* * *

Section 4. Section 212-2.1, entitled "Schedules of Dimensional Regulations," of Article II, entitled "District Regulations," of Chapter 212 of the Village Code, entitled "Zoning", is hereby

amended as follows (strikethrough indicates deleted language and bold/underlined indicates added language):

- A. In addition to the district regulations contained in this article, the maximum permitted height/setback ratios and minimum required front, side and rear yard setbacks in the Residence AA, A, BB, B, C-1, C-2 and D Districts are presented on the Table 212-12.1 located at the end of this chapter.
- B. In addition to the district regulations contained in this article, the maximum permitted building area and surface coverage for the Residence AA, A, BB, B, C-1, C-2 and D Districts are presented on the Table 212-12.2 located at the end of this chapter. Subsurface improvement areas in excess of ~~the primary building~~ **surface coverage areas** and greater than 450 **500** square feet and utilized for habitable, storage, or garage space shall count toward building area and surface coverage calculations.

Subsurface areas shall maintain the following minimum yard setbacks:

Front Yard: 20'

Side Yard: 15'

Rear Yard: 20'

However, subsurface area side yard requirements in C-1, C-2 and D Districts shall be equal to the side yard regulation listed in §212.

- C. The permitted surface coverage in a front yard, expressed in a percentage, shall not exceed the total percentage of lot area that is occupied by the primary building, all accessory buildings and all rear and side surface coverage on the same lot.

Section 5. Section 212-2.1, entitled “Schedules of Dimensional Regulations,” of Article II, entitled “District Regulations,” of Chapter 212 of the Village Code, entitled “Zoning”, is hereby amended to modify and replace Table 212-12.1 located at the end of the Chapter in accordance with the attached Table. The attached table hereto shall modify and replace the existing table.

Section 6. This local law is determined to be a TYPE II action under the NY State Environmental Quality Review Act (“SEQRA”).

Section 7. This local law shall take effect immediately upon filing with the Office of the Secretary of State.

Course & Grounds – Report by Adam Thomas

The past month has been spent doing a combination of indoor and outdoor work. All mowers and carts have been given their winter service, which includes fluid and filter changes, as well as grinding reels and putting new bedknives on mowers. All accessories were sanded and painted. We also continued to clear out brush left of 12 and the property line behind the house at 170 Sage Avenue. Gerry Castro, Village Resident Sam Lichtman, and I met to discuss cleaning his property line and the brush left of 12. Mr. Lichtman has requested this whole area be cleaned to open up his vista of the golf course and the bay. Due to our lack of manpower, this will be a process that requires us to complete this task incrementally over time. We have removed stump grindings and have filled stump holes with top soil and sodded. All tree work has been completed.

The upcoming week will be spent cleaning tees, fairways and greens. Once everything is cleaned, we will mow greens and green expansions at the same height. We already mowed 3 green and expansion at the same height and it looks very good. Greens expansions, which began 2.5 years ago is now complete. Greens will open back up on Friday, March 10. Winterberry is scheduled to begin re-installation of irrigation lines on either Friday, March 10, or Monday, March 13.
