

**RESOLUTION NO. 2020-11**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OAK RIDGE NORTH AMENDING RESOLUTION 2020-10 THAT CALLED A PUBLIC HEARING TO BE HELD ON MONDAY, SEPTEMBER 14, 2020, BUT PUBLISHED NOTICE OF SAID PUBLIC HEARING ON SEPTEMBER 28, 2020 AT CITY HALL, 27424 ROBINSON ROAD, OAK RIDGE NORTH, TEXAS 77385, TO HEAR ANY AND ALL PERSONS DESIRING TO BE HEARD ON OR IN CONNECTION WITH ANY MATTER OR QUESTION INVOLVING THE AMENDMENT OF IMPACT FEES FOR WATER AND WASTEWATER, AND DIRECTING SAID NOTICE BE PUBLISHED IN THE OFFICIAL NEWSPAPER OF THE CITY OF OAK RIDGE NORTH, TEXAS AND POSTING ON THE CITY'S WEBSITE, AND RATIFYING THE CORRECT DATE OF SEPTEMBER 28, 2020 FOR THE PUBLIC HEARING ON THE PROPOSED AMENDMENT OF IMPACT FEES FOR WATER AND WASTEWATER.**

**WHEREAS**, the City Council of the City of Oak Ridge North, Texas ("City Council") approved Resolution 2020-11 on August 10, 2020 calling a public hearing for Monday, September 14, 2020 to receive public comments on the upcoming proposed amendment of impact fees for water and wastewater services in the City of Oak Ridge North, Texas; and

**WHEREAS**, the "Notice of Public Hearing on Amendment of Impact Fees" actually published in the City's newspaper of general circulation noticed the public hearing for Monday, September 28, 2020; and

**WHEREAS**, the actual publication date and the public hearing date published conforms to the Texas Local Government Code Section 395.049(b) regarding the notice required for the public hearing; and

**WHEREAS**, the City Council desires to amend Resolution 2020-10 to correct the caption, all recitals, and Sections 1 and 2 of the resolution which refer to calling a public hearing for September 14, 2020, and in its place amend it to read September 28, 2020; and

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OAK RIDGE NORTH, TEXAS:**

1. That the City Council of the City of Oak Ridge North, Texas does hereby amend Resolution 2020-10 to call a public hearing to be held on the 28<sup>th</sup> day of September 2020 at 7:00 o'clock p.m. at City Hall, 27424 Robinson Road, Oak Ridge North, Texas 77385, or in the alternative via Zoom videoconference dur to the continued COVID-19 pandemic with Zoom meeting attendance credentials posted in accordance with the notice requirements of the Texas Open Meetings Act then in effect, at which time all persons desiring to be heard will be heard on or in connection the proposed

amendments to impact fees for water and wastewater improvements, and by doing so conforms Resolution 2020-10 to the "Notice of Public Hearing on Amendment of Impact Fees" attached thereto which reflected the correct public hearing date of September 28, 2020, which was published in accordance with Texas Local Government Code Section 395.049(b).


2. The City Council hereby confirms the City Secretary did correctly publish notice of a public hearing before the 30<sup>th</sup> day before September 28, 2020 in the City's designated newspaper of general circulation and sent a notice of the hearing by certified mail to any person who had previously given written notice by certified or registered mail to the City Secretary requesting notice of the hearing within the two years preceding August 10, 2020 as per Tex. Loc. Gov't Code Sec. 395.044.

3. The City Council hereby ratifies all activities of the City Secretary to publish the "Notice of Public Hearing on Amendment of Impact Fees" for the public hearing which shall occur on September 28, 2020 at 7:00 p.m. as provided therein.
