

**RESOLUTION NO. 2023-06**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF OAK RIDGE NORTH, TEXAS, RATIFYING ALL PRIOR SERVICE FEES, RATES, DEPOSITS, AND OTHER RATE CHARGES IMPOSED FOR PUBLIC SERVICES AND USE OF PUBLIC FACILITIES PURSUANT TO ANY HERETOFORE ADOPTED SCHEDULE OF SERVICE FEES, RATES, DEPOSITS, AND OTHER RATE CHARGES FOR PUBLIC SERVICES AND USE OF PUBLIC FACILITIES; REPEALING ALL PRIOR RESOLUTIONS ADOPTING OR OTHERWISE AMENDING A SCHEDULE OF SERVICE FEES, RATES, DEPOSITS, AND OTHER RATE CHARGES FOR PUBLIC SERVICES AND USE OF PUBLIC FACILITIES, AND IN ITS PLACE ADOPTING A NEW SCHEDULE OF FEES AND CHARGES FOR PUBLIC SERVICES AND USE OF PUBLIC FACILITIES; AND PROVIDING OTHER MATTERS RELATING TO THE SUBJECT.**

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OAK RIDGE NORTH, TEXAS:**

**Section 1.** The City Council of the City of Oak Ridge North, Texas (“City Council”) last amended its Schedule of Service Fees, Permit Fees, Deposits, and Other Rate Charges for public services and use of public facilities by Resolution 2023-05 adopted on March 27, 2023.

**Section 2.** The City Council hereby ratifies all prior service fees, rates, deposits, and other rate charges imposed for public services and use of public facilities pursuant to any heretofore adopted Schedule of Service Fees, Permit Fees, Deposits, and Other Rate Charges for public services and use of public facilities adopted by any Resolution so as to validate all prior service fees, rates, deposits, and other rate charges previously imposed for public services and use of public facilities.

**Section 3.** Resolution 2023-05, and all resolutions prior thereto, is hereby repealed, and in its place the new Schedule of Service Fees, Permit Fees, Deposits, and Other Rate Charges, as set forth in Resolution No. 2023-06 Exhibit "A", attached hereto and for all things made a part hereof.

**Section 4.** The "Schedule of Service Fees, Permit Fees, Deposits and Other Rate Charges" a true and correct copy of which is attached hereto as Exhibit "A," is hereby in all things adopted and the fees set forth in said Exhibit "A", shall be applicable as of May 22, 2023.

**Section 5.** All resolutions or parts of resolutions inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

**CHAPTER 6: ALCOHOLIC BEVERAGES**

There is hereby levied and there shall be collected by the city a fee equal to one-half of the state fee set from time to time by the Texas Alcoholic Beverage Code for each permit required and issued for premises located within the city pursuant to the Texas Alcoholic Beverage Code, as amended.

Such fee shall be due and payable from each permittee to the city at the time the state permit fee is due and payable to the state from each permittee, pursuant to the Texas Alcoholic Beverage Code, as amended.

Due to the different characteristics of each job, additional inspection fees may be required if additional inspections are needed that were not originally charged when the permit was issued. All fees shall be paid before a certificate of compliance, or a certificate of occupancy will be issued.

Building Valuation Table:

**NOTE:**

1. The building valuation table shall be used for new commercial building construction, commercial building additions, and residential structures or remodels that are not residential dwellings.
2. Values for permitting purposes are based off the most recent Building Valuation Table as published by the International Code Council, or as determined by the building official.
3. Alterations, remodels, and interior build outs will be based off of project valuation or as determined by the building official.
4. Swimming pool permit fees will be based off valuation.

## **Plan-Checking Fee:**

When the valuation of proposed construction exceeds \$1,000.00 and construction documents are required to be submitted by Section 106 of the City adopted Building Codes, a plan checking fee shall be paid to the City at the time of submitting constructions documents for checking. Said plan-checking fee shall equal to one-half (1/2) of the building permit fee set out herein and in accordance with Section 108 of the City adopted Building Code. Such plan-checking fee is in addition to the building permit fee. Said plan checking fee shall cover the cost of the first and second plan check (if necessary). If, after the second submittal of plans are rejected, a plan-check fee for the third and subsequent plan-check will be payable in the amount of 50% of the original plan-check fee. Plan check fees are not refundable.

## **RESIDENTIAL DWELLING BUILDING PERMITS:**

The building permit fees applicable to the issuance of residential dwelling building permits shall be based on the total square footage of the building or work area at a rate of \$0.72 per square foot of building area or work area. Plan review is included in this fee.

Payment is due by the 16<sup>th</sup> of each month, no later than 3:30 p.m. If the 16th falls on a weekend day or City-recognized holiday, payment is due on the following business day by 8:30 a.m. Payments are considered timely if they are physically received in the Water Department on or before the due date. For your convenience, a payment drop box is located at the front driveway of the City Hall Building at 27424 Robinson Road. **Please note that the drop box is checked daily and payments dropped off in the drop box on the due date after 3:30 p.m. are subject to a late fee.** NOTE: Postmarks and/or the date on your check are NOT considered proof of timely payment. **If you do not receive a bill in the mail before the 16<sup>th</sup>, please call the Water Department to determine the amount owed so that you may avoid paying a late charge.** The City deposits the checks it receives daily; it cannot hold post-dated checks. There is a six (6) day grace period for late payments.

**LATE FEE:** Utility bills that are not paid in full by the due date may incur a ten percent (10%) late fee on the water and sewer bill and a flat \$2.00 late fee for the garbage bill.

**PAST DUE NOTICE:** The City will issue a past due notice if the City has not received payment by the due date. The past due notice shall serve as a disconnection notice. The customer is subject to service disconnection on the date noted on the past due notice.

**DISCONNECTION FEE:** A disconnection fee of fifty dollars (\$50.00) shall be charged to accounts with balances of delinquent status for which service orders have been issued for meter disconnection.

**If the City has disconnected service for non-payment or any other authorized disconnection reason as set out herein, water service may be re-established subject to the following conditions:**

1. All past due account balances must be paid in full, including delinquent fees.
