Waste Type/Disposal Options & Fees

Mixed Municipal Solid Waste (MSW) can be disposed of at the Roseau County Transfer Station

Disposal Charges:

- \$37.50/ton + tax if applicable
- \$12.87/pick-up load (\$11.00 + \$1.87 Tax)
- \$5.85/car load (\$5.00 +\$0.85 tax)



Note: Unacceptable MSW includes:

Ash, Used Oil, Fluorescent Bulbs, Bio-Waste, Yard Waste, Household Hazardous Waste (paint, chemicals, etc.)

Demolition Debris can be disposed of at the Roseau County Demolition Landfill

Disposal Charges:

\$8.10/cubic yard (\$7.50 +\$0.60 tax)

Note: Demolition debris consists only of:

Concrete, Brick, Bituminous Concrete, Untreated Wood, Masonry, Glass, Plastic Building Parts, Some Construction Waste

It does not include: asbestos waste, glues, solvents, paints, caulking tubes, resins (or their containers), paper, cardboard, furniture, plastic packaging, carpet, household garbage, refuse, or rubbish, sludge, yard waste, liquid waste, hazardous waste, infectious waste and some new construction wastes.

• \$5.00/Unit

Tires can be recycled at the Roseau County Transfer Station

Disposal Charges:

- \$3.00/auto tire
- \$5.00/truck tire
