

## STANNARD TOWNSHIP RECREATION PARK RULES

- Park is open from 7 am to dusk from approximately May 1<sup>st</sup> to November 1<sup>st</sup> (weather permitting).
- ATV's must stay off all grass areas and are not allowed in Pavilions.
- Dogs must be on a lease at all times – you are responsible to pick up your animal's waste.
- Loud music is only allowed during public events such as 4<sup>th</sup> of July.
- Children under 12 years old must be supervised at all times.
- Rental of large pavilion/log building for large groups of more than 40 people requires \$100 security deposit and \$50 fee to offset; garbage, electricity, and other costs. Rental form is attached.

## STANNARD TOWNSHIP PARK FACILITIES

**Large Pavilion** - has capacity for 200 or more. Includes walk-in cooler/concession, bandstand, and lighting, this facility is used for 4<sup>th</sup> of July event and other large events.



**Small Pavilion** – Perfect for small picnics. Fits up to 30 people, 4 picnic tables, and has a BBQ grill. This facility was donated in memory of Neil Hansen.



**Log Concession Building** – Used for 4of of July and other events. Facility includes; bathrooms, full kitchen, and concession windows to sell food and drinks.



**Shower House** – Open from May 1<sup>st</sup> to November 1<sup>st</sup> based on weather. Shower House is not heated. Fee is \$3.00 per shower (no time limit, plenty of hot water) – bring your own towels and soap



**STANNARD TOWNSHIP PARK BUILDINGS LEASE**

hereinafter the lessee, of the buildings located on the Stannard Township Park Property in Bruce Crossing, MI, known as Pavilion and or Log Concession Building, agrees on the following terms:

1. RENTAL PERIOD: Beginning \_\_\_\_\_, 20\_\_ at \_\_\_\_\_ AM PM and ending \_\_\_\_\_, 20\_\_ at \_\_\_\_\_ AM PM
2. SECURITY DEPOSIT and FEE: \$100.00 Security deposit and \$50.00 fee to pay for electricity, garbage, and maintenance shall be paid on booking.  
The Lessee shall pay **\$150.00** total of which **\$100.00** of this amount shall be returned to the Lessee upon receipt of the key by Stannard Township, provided the buildings are cleaned and no unreasonable damage has occurred. (Within 30 days).
3. PROOF OF INSURANCE AND AMOUNT OF RENTAL: The Lessee shall provide Stannard Township with Proof of Insurance, pay the amount of rental and sign this agreement before a key to the building is released.  
AMOUNT OF RENTAL PAID: **\$150.00 (\$50.00 of this is Non-Refundable Fee)**

4. ALCOHOL: alcohol (SHALL) (SHALL NOT) be served at this function. If alcohol is served the Lessee shall:
  - a. Have a deputy or other law officer approved by the Township Board, present at all times.
  - b. Complete the attached agreement for serving alcohol and return before receiving a key.
5. CLEANING AND REASONABLE CARE: The leased premises and associated property shall be returned to Stannard Township in as good condition as when taken by the Lessee. Lessee is required to clean buildings and pick up all garbage before returning the key.
6. Lessee shall not allow any illegal or hazardous activity to occur on Stannard Township property while they are using it.
