IN CONSIDERATION OF THE GRANTING OF THIS PERMIT TO CONNECT TO THE MUNICIPAL WATER SYSTEM, THE UNDERSIGNED AGREES:

- To accept and abide by all the provisions of Chapter 55 of the Code of the Town of Ware, Massachusetts, the Drinking Water Regulations of the Commonwealth of Massachusetts and all other pertinent ordinances or regulations that may be adopted in the future.
- To install the water service connection according to the applicable standards and specifications of the Town of Ware, the American Water Works Association and any other professional or governmental organizations charged with establishing such standards.
- To maintain and repair any potable water service connection less than 2" (two inches) in diameter from the
  property line to the building and any potable water service connection or automatic sprinkler line in excess of 2"
  (two inches) in diameter from the building to the connection at the water main line at no cost to the Town of
  Ware.
- To notify the Superintendent or his authorized agents when the water service is ready for connection to the municipal water supply, but before any portion of the work is covered.

The current connection fee schedule, voted by the Board of Selectmen on April 13, 2010, is as follows:

\$1,250.00 per diametrical inch (the minimum service size is 1" in diameter).

All application and connection fees must be paid in full before any connection is allowed. "Connection Fees" do not include any parts or labor provided by the Ware Department of Public Works.
