

RESOLUTION 2011-12

A RESOLUTION TO AMEND FEES PREVIOUSLY ADOPTED BY THE BOARD OF MAYOR AND ALDERMEN FOR SOLID WASTE DISPOSAL.

WHEREAS, T.C.A. 6-2-201 empowers the Town to set fees for public services to be furnished by the Town; and

WHEREAS, the Town of Arlington has established certain fees related to Solid Waste Disposal within the jurisdiction of the Town of Arlington; and

WHEREAS, said fees may be modified from time to time to meet future and market conditions affecting said Solid Waste Disposal; and

WHEREAS, the Town has awarded the solid waste contract to Allied Waste to include solid waste, rubbish and recycling at curbside, beginning August 1, 2008, the costs associated with Solid Waste Disposal have increased; and

WHEREAS, Allied Waste has exercised their option per Section 13.02, Modification of Rates, to increase the solid waste fee by 3.6%, based on the Consumer Price Index, Bureau of Labor Statistics, Atlanta Office; the Town is also charged a monthly fuel/environmental surcharge that is continuing to increase, and a 2% collection fee from Memphis Light, Gas and Water; and

WHEREAS, the increased costs of these services cannot be absorbed by existing revenue sources;

NOW, THEREFORE, BE IT RESOLVED by the Board of Mayor and Aldermen of the Town of Arlington, Tennessee that Resolution 2002-07, and subsequent amendments, R2006-24, R2007-20, R2008-26, R2010-18, be amended to reflect a five percent (5%) increase in the Residential Rates based on increases as reflected by the Consumer Price Index Data for May 2011, increase fuel/environmental surcharges and the 2% collections fees charged by MLGW, the new rates are as follows:

SECTION 1. The service fee, on single family residential customers, will be \$19.00 per month once a week pick up. Single family residential customers shall be defined to include detached and attached dwellings utilizing a waste receptacle per household. The fee per household shall be included on each customer's monthly utility bill, and such fee shall be due and payable at the time and as part of the bill rendered for utility service.

SECTION 2. The multi-family flat rate of \$579.52 for Arlington Housing, M L G & W Customer Code #300915, Premise Code #1233076, address 11216 Marquis Court WILL NOT change.

BE IT FURTHER RESOLVED, that the new rates shall become effective with the first utility billing cycle beginning September 1, 2011, or as soon as applicable per M L G & W billing.
