### **COUNTY PLANNER - JESSIE POWERS CR24A BIKEWAY EXTENSION**

Updates on the course of action for the CR24A Bikeway Extension. She discussed a call she had with ODOT, with ODOT stating they have concerns with any changes to the design at this point in the process. Due to it being in a wetland, an Army Corp of Engineers Permit will be needed There are two areas that have been proposed to raise the elevation. With the impact already being at its maximum, with the current permit, it would be required to be re evaluated. Commissioner Adkins stated that after talking with County Engineer Jeff Maiden, who feels that the Project Engineer may hold some responsibility for this project. Commissioner Eliason feels that the complaint may be with ODOT and not the Engineer, with ODOT approving the plans that they submitted. County Planner Powers suggested that moving forward, the county can set a higher standard for soliciting quotes for Engineering proposals, with the minimum height of a trail going into a flood plain area to be elevated. The storm water best management practices and flood plain analysis would need revised, and tree clearing would need done, but due to being in a bat habitat area, that would delay the project until September. The option that ODOT proposed is to leave portions of the trail (low lying) as a compacted stone surface, suitable for bikepaths. This would mean no design changes would be needed, and portions of the trail could be elevated easier than the paved ones. She would like to talk to ODNR to possibly alter the contract with them to include the new stone aggregate base in the low lying areas and get with an Engineer to see what the proposed cost would be to elevate the low lying areas, while using part of the \$58,000.00 remaining in the grant to cover those costs.

The Commissioners then discussed what the least expensive option would be, and they feel it would be best to proceed as is, and let ODOT finish the project, and to look at any future options there might be at a later date. County Planner Powers will let ODOT know of their decision.

### PLANNER - FROST ROAD / ATHENS-BELPRE RAIL TRAIL Extension

Discussion with the County Planner, Jessie Powers, regarding this project. She stated that the ABRT group feel they can possibly get the Engineering donated for this project, by a retired Engineer. If not, the Engineering cost would be approx. \$17,750.00, with the portion of the 5% construction match that the county would need to provide, it would be a total of \$47,366.00. Total Project Cost: approx. \$609,842.00. This extension will consist of a 5.79 mile, geotech style trail for horses, hiking and biking, and will be the only equestrian trail in the county. Commissioner Adkins questioned how many individuals would be using this Trail extension and the return on investment of the project, and the possibility of widening a portion of the bikepath for equestrian use. Commissioner Chmiel stated that there is more trail counting being done on the bikepath. County Planner Powers feels there may be some user conflicts between the bicycles and the horses, or the right of

Please accept this letter of commitment for Rural Actions' application Asset Based Entrepreneurship, Trails Towns and Tourism in the Appalachian Ohio Economy for the Appalachian Regional Commission Partnerships for Opportunity and Workforce and Economic Revitalization (POWER) Initiative grant to revitalize local communities by diversifying our economy through outdoor recreation and ecotourism.

The Athens County Commissioners have been awarded multiple grants to support the development of the Bailey's Trail System in Athens County, Ohio. Rural Action's application mentioned above utilizes portions of Athens County's 2018 CDBG Village of Chauncey Neighborhood Revitalization Grant in the amount of \$415,000 (total award \$500,000) as project match. This grant provides funding to improve the Village of Chauncey Park which is the primary Trail Head for the Bailey's Trail System.

Additional grant funds leveraged to support the development of the Bailey's Trail System and Rural Action's application to diversify the Appalachian Ohio Economy total \$3,516,668.
