Mr. Eliason discussed possibly using ARPA funds for this project and asked Mr. Brooks to review this with the Engineer, work on a budget, and come back next week to discuss this further.

US50 SEWER WEEKLY UPDATES - W&S Supt. Rich Kasler, Gary Silcott Dlz

Discussion with Mr. Silcott from DLZ, regarding the EPA and what can be done if the required separation distances for sewer and water lines cannot be met. The following options are what he received from the EPA regarding this: Gary,

As per our conversation last week about the methods to be employed if the required separation distances for sewer and water lines can not be met, I am sending this email to answer your additional questions.

- 1. 2" water main replacement. I asked our DDAGW group if it would be alright to replace a 2 inch water main with new 2 inch line and they said it was. There was a push to upgrade 2 inch mains when replacing them but it is not a requirement and in this case a replacement 2 inch line could be used.
- 2. Manhole closer than the 10 feet isolation distance. According to the other district permitting supervisors, when the manhole ends up closer then the 10 foot isolation distance, extra information would be required on the sealing ofthe manhole to minimize the risk of it leaking in the vicinity of the water line. This goes along with the methods used when the 10 foot horizontal isolation can not be maintained between the sewer and water lines (moving the sewer line, using pressure pipe, or encasing the sewer line). Extra care must be used to minimize the risk of the sewer line leaking in the vicinity of the water line.

Let me know if you have any other questions. Thanks.

- ~ Mr. Adkins asked Mr. Kasler about the Ervin Road and Stagecoach Road. Mr. Kasler has been in contact with Atty. Frank Lavelle regarding an Easement. He stated that after speaking with the individual regarding the Easement, it would be until the end of September before he would be back in town. Mr. Kasler recommended to the Commissioners that if they did get the Easement, they could include the six additional customers through a re route of the project, and if they do not get the Easement, they could consider omitting that portion of the project.
- ~ University Estates / Fisher Road area: Mr. Adkins questioned being able to keep the road open. Mr. Kasler stated they can shift the road, to stay further from the water line, to maintain the traffic flow, it will be a slower process however.

The areas will be notified by letter. Mayor Gooseman expressed to the Commissioners, the Business's need for Commerce in town. They wish to get a guarantee from the County for a funding match in the amount equivalent to twenty (20%), up to \$250,000.00 of the total project cost.
