AGREEMENT BETWEEN THE ATHENS COUNTY BOARD OF COMMISSIONERS AND THE ATHENS COUNTY SHERIFF'S OFFICE AS THE ATHENS COUNTY DOG WARDEN

THIS AGREEMENT, made and entered into this 3 day of January, 2019, by and between the Board of Commissioners of Athens County, Ohio, hereinafter called "Board", and Athens County Sheriffs Office, hereinafter called "ACSO".

WITNESSETH:

SECTION 1: Term of Agreement.

Pursuant to R.C. 955. 121 (A)(I) the Board has appointed ACSO has county dog warden

by way of Resolution # I03-109. The agreement for ACSO to be the county dog

warden shall be for an initial period of two (2) years commencing on January 7th , 2019 and ending on

December 31, 2021. SECTION 2: Duties.

ACSO shall faithfully perform all necessary and customary duties and shall further enforce sections 955.01 to 955.27 and 955.50 and 955.53 of the Ohio Revised Code.

SECTION 3: ACSO Appointment Abilities.

The parties agree that ACSO may appoint sheriff deputies or persons other than peace officers as deputy dog wardens. ACSO shall be responsible for the hiring and any other employment matters involving the county dog warden and the county dog shelter.

SECTION 4: Training

The parties agree that ACSO and any deputy dog warden must comply with the following: (1) Any training requirements appli cable to county dog wardens and deputy dog wardens appointed or employed under section 955.12 of the Ohio Revised Code; and

(2) The requirements established in section 955.1 2.

SECTION 5: Athens County Dog Shelter.

In addition to being county dog warden, ACSO shall be in charge and be responsible for the operations at the Athens County Dog Shelter.

SECTION 6: Supervision of Humane Officer

The parties agree that ACSO or the assigned deputy dog warden(s) shall supervise the Athens County Humane Officer which shall also include but is not limited to assigning tasks, coordinating department functions, providing direction and standards in compliance with state and local laws.

SECTION 7: Indemnification

ACSO shall defend, save harmless and indemnify the Board against any tort, professional liability claim or demand or other legal action, whether groundless or otherwise, arising out of an alleged act or omission occurring in the performance of ACSO's duties as Dog Warden. The Board may compromise and settle any such claim or suit and pay the amount of any settlement or iudament rendered thereon.

SECTION 8: General Provisions

- I) The text herein shall constitute the entire agreement between the parties.
- 2) This Agreement shall be binding upon and insure to the benefit of the successors of ACSO.
- 3) This agreement shall become effective commencing on January 7th, 2019.
- 4) If any provision, or any portion thereof, contained in this Agreement is held unconstitutional, invalid or unenforceable, the remainder of this Agreement, or portion thereof, shall be deemed severable, shall not be affected and shall remain in full force and effect.

We are pleased you have asked us to serve as your legal counsel to handle the engagement described in this letter and appreciate the opportunity to serve you. Please take a moment to review this letter (and the enclosed standard Ice Miller terms and conditions) to confum our mutual understanding regarding your retention of Ice Miller LLP ("Ice Miller"), the scope of the engagement and the basis on which we will provide legal services to you. Background

We understand that we will be providing legal counsel services to Athens County, Ohio (the "County") with respect to the County's consideration of allowing a telecommunications company or telecommunications companies to place conduit in the trench(es) that are to be opened in the construction of the updated sewer system within the County. Allowing telecommunications companies to utilize these trenches in order to place conduit would reduce the cost of broadband build out and ultimately enhance connectivity in the County. Per our discussion on April 18, 2018, we envision that a Request for Proposals ("RFP")/ Request for Information ("RFI")/Public Notice will be necessary to attract companies that may be interested in participating in the project, and will ensure that this is a nonexclusive opportunity to access the trench(es) for conduit expansion. Historically, there have been instances in which Ice Miller has successfully accounted for its fees in the amounts paid by an RFP awardee. We will work with the County to attempt to replicate this type of benefit with the RFP contemplated by this Engagement Letter.

Scope of Engagement

Ice Miller proposes to do the following in furtherance of the project:

- Draft an RFPIRFI/Public Notice to solicit responses from broadband/ telecommunications companies for use of the trenches in the County to install conduit. It will be the responsibility of the County to determine compliance of the RFP/RFI Public Notice with its procurement/purchasing requirements.
- 2. Assist with reviewing the responses received by the County from broadband/telecommunications companies to the RFP/RFI/Public Notice in order to award access to the trenches available for conduit construction/placement in the sewer system project. It will be the responsibility of the County to negotiate terms with any awardee in the project.
- Draft the contracts necessary once terms are agreed to in order to effectuate the purpose of the RFP with the awarded broadband telecommunications company or companies.

Payment Terms

Ice Miller will bill the County a flat fee of \$15,000 for services. Travel, expenses and in person meetings will be billed at the agreed upon negotiated hourly amount between Ice Miller and Athens County in addition to the flat rate.

Additional payment terms are included in Addendum A (General Terms of Service) attached to this letter.

Engagement Terms

This engagement will begin when the agreement is signed by all parties and will be for a period of 12 months or until such time that the Scope of the Engagement is complete, whichever is longer. The General Terms of Service outlined in Addendum A are incorporated herein and made a part of this letter of engagement.

Unless a different engagement letter is executed in the future, the basic terms of this engagement letter will also be applicable to, and govern our professional relationship on all subsequent matters, on or in which we may become involved or engaged on your behalf. Please let us know if there is anything you do not understand or would like to discuss changing. Otherwise, please confirm for our records your acceptance of these terms and

~ Richard Hodges, from O.U.; Hocking County Sheriff's Office; Commissioner Adkins, who is on the Regional Jail Board, discussion regarding the old Hocking County Correction Facility and the hopes of a section of it becoming an all female treatment center. Commissioner Adkins stated that the Jail Board is not on board yet with allowing females from the regional jails to become a part of the Hocking County Sheriff's operation of the old Correction Facility as a treatment center. Mr. Hodges stated that it is an opportunity to do something different with substance abuse and get people into a treatment facility and using the concept of the jail to make a meaningful impact on long term cost implications for the region. Ohio University got involved early on with goals to provide a substance abuse treatment facility in collaboration with the S.E. Ohio Regional Jail. The Hocking County Sheriff's Office has met with the Regional Jail, they are exploring options to collaborate for ways to save money for combined purchase services. The Commissioners are concerned about the jail bed costs and the inability to afford to run two facilities, and feel they need to find a way to operate and pay for what they commit to.
