The Benzie County Board of Commissioners met in a regular meeting on Tuesday, June 23, 2015, at the Benzie County Government Center, 448 Court Place, Beulah, Michigan.

Laura Galbreith, Venture North explains Part 1 application for \$463,000 – this is the citizens' opportunity to ask questions or to comment; primary focus of CDBG is to eliminate blight. Crystal Mountain plans to hire 48 full time workers over the next two years; the total cost of the project will be \$10 million; it will include mixed use commercial and residential of 27,000 additional square feet; this grant will help with infrastructure improvements; there will be no displaced persons as a result of this expansion. There is a 10% minimum contribution -- \$46,300 local unit contribution which Crystal Mountain will cover those costs. There will be 15 days to look at Part 1 application at the County Administrator's Offices, Monday – Friday.

Kirk Davidson, Crystal Mountain, explains the plans and drawings to the public.

Comm Griner stated regarding the Maples that we need to get that building open; the housing summit was really good; Northern Michigan Counties went to Onaway to the Industrial Arts Welding School; he heard the Mayor of Detroit speak in Traverse City.

Comm Walterhouse stated that he attended two finance meetings; Buildings and Grounds; two Homestead Township meetings; over 2,300 people have medical marijuana cards in Benzie County; Homestead Park is up and running – he has been park manager for 38 years.
