Marlene Wood, Recycling Coordinator, stated that they had another successful Hazardous Waste collection; August 29 we will have two more semis for tires; August 8 is the next Household Hazardous Waste clean-up date scheduled at the Road Commission; FY 2014 report.

<u>Burt Gale, Building Official</u>, provided the June 2015 Building Code and Safety Enforcement report and stated that the numbers are above 2013 but just under 2014; preliminary drawings have been received from Crystal Mountain for their expansion project.

Sheriff Schendel, stated that Troy Lamerson was sworn in as Undersheriff last week.

<u>Troy Lamerson, Undersheriff</u>, stated that the last road patrol position has been filled -6 of 10 are new this year; they are also fully staffed in the jail; he stated that the making of meth is moving into Benzie County.

Sheriff Schendel also stated that he will be working with Colin at the Record Patriot to introduce all new deputies by way of the paper; they will hold the second meeting of the Sheriff Coalition tomorrow to start discussions on ways of dealing with the substance abuse problems.

Frank Post, Emergency Management, provided the June 2015 report; 10 CERT members were dispatched to Frankfort for the fireworks.
