PUBLIC INPUT

Purpose: The Benzie County Board of Commissioners is a public policy setting body and subject to the Open Meetings Act (PA 267 of 1976). The Board also operates under a set of "Benzie County Board Rules (section 7.3)" which provides for public input during their meetings. It continually strives to receive input from the residents of the county and reserves two opportunities during the monthly scheduled meeting for you the public to voice opinions, concerns and sharing of any other items of common interest. There are however, in concert with meeting conduct certain rules to follow.

Speaking Time: Agenda items may be added or removed by the board but initially at least two times are devoted to Public Input. Generally, however, attendees wishing to speak will be informed how long they may speak by the chairman. All speakers are asked to give their name, residence and topic they wish to address. This and the statements/comments will be entered into the public record (minutes of the meeting). Should there be a number of speakers wishing to voice similar opinions, an option for a longer presentation may be more appropriate for the group and one or more speakers may talk within that time frame.

Group Presentations – 15 minutes Individual Presentations – 3 minutes

Board Response: Generally, as this is an "Input" option, the board will not comment or respond to presenters. Silence or non-response from the board should not be interpreted as disinterest or disagreement by the board. However, should the board individually or collectively wish to address the comments of the speaker(s) at the approval of the Chair and within a time frame previously established, responses may be made by the board. Additionally, the presenter may be in need of a more lengthy understanding of an issue or topic and may be referred to a committee appropriate to address those issues.

Public Input is very important in public policy settings and is only one means for an interchange of information or dialogue. Each commissioner represents a district within the county and he/she may be individually contacted should greater depth or understanding of an issue be sought. Personal contact is encouraged and helpful to both residents and the board.

<u>Doug Durand, Council on Aging</u>, provided written report; started community ride along yesterday; tonight Hungry Tummy will be donating part of their sales, and tomorrow night Geno's; the collaboration between DHHS, BACN, Father Fred Foundation and Veterans has been instrumental in Benzie County.

<u>Jennifer Berkey, MSU</u>, introduced Patty Roth to fill the educator vacancy; Kurt Schindler has transferred to Manistee County where he lives, but will still be actively programming here in Benzie County.

I have included this year's budget of the Tri County Medical Examiner and Benzie County's contribution to that budget. Benzie County is currently sending all forensic autopsies to Kalamazoo and have listed those prices. If we were to contract with Genesee County, the forensic autopsy would be performed at the Mecosta/Newaygo Morgue in Big Rapids. Those costs are provided for you as well.

Benzie County Administrator Deisch has been in contact with Mecosta and Newaygo counties about potentially joining as authority for the forensic autopsies in Big Rapids.

Emergency Management ActivitiesJanuary 2016

Below are outlined many of the activities I have been involved in for the month of January 2016.

1. Benzie County Fire Chief's

On Wednesday January 5th, 2016 I attended a meeting of the Benzie County Fire Chief's to finalize the FEMA Assistance to Firefighter Grant Application for approximately \$531,000 in radio equipment to transition both fire and EMS to the MPSCS Radio System.

2. Benzie County Fire Chief's Meetings

On Tuesday January 5th, 2016 we had another county wide Fire Chief's Meeting to discuss our upcoming proposed AFG Grant Application. We continued finalizing the projected application request and just obtained equipment costs. The grant application is nearly complete and was reviewed over the next couple of weeks for correctness. The submission date is January 15th, 2016. The application appears to be for around \$550,000 but is still being refined.

If you will recall, the City of Frankfort has agreed to act as the host agency which will give us a bite at approximately \$75M. in funding dollars.

3. Region 7 Homeland Security Planning Board

On Thursday January 7th, 2016 I attended the R7HSPB meeting in Grayling.

4. Benzie County Firefighters Association Meeting

On January 12th, 2016 I attended a meeting of the Benzie County Firefighters Association Meeting held at the Board of Commissioners Chambers. There were around 30 people in attendance to discuss the formation of the association in Benzie County and the purpose it would serve.

5. MI-CIMS Training

On January 13th, we hosted Michigan Critical Incident Management System (MI-CIMS) training in the EOC. We held a refresher class that was attended by 6 individuals from 2:00pm to 4:00pm and a new users training from 5:30pm to 9:30pm that was attended by 7 individuals.

The goal of the Michigan Critical Incident Management System (MI CIMS) is to provide the state of Michigan with a state-of-the art, web-based, secure, electronic information management system that supports Planning/Preparedness, Response, Recovery and Mitigation

6. AFG Grant Submitted

On Friday January 15th, 2016 I met with Josh Mills from the City of Frankfort to finalize the Regional Grant Application that they agreed to host. We went over some of the final details and submitted the grant that totaled \$530,710 of which \$505,439 was the federal share and \$25,271 was the required local match.

If you will recall we are proposing to replace its emergency communications for fire and EMS services with the State of Michigan 800MHz Public Safety Communications Network (MPSCS). The move is intended to eliminate the communications interoperability gap that exists between the emergency first responders in Benzie County. Currently, law enforcement, hospitals, state and federal emergency services are on the 800MHz MPSCS communications platform and the six (6) fire departments and two (2) non-affiliated EMS services in Benzie County are operating on a VHF radio system. The VHF radios currently in use are all 15 to 20 years old and we intend to abandon that system.



7. After Action Review of Chemical Spill at the Graceland Fruit – Forrester Rd. Plant On January 25th, 2016 I facilitated an After Action Review of a chemical spill response that occurred on January 19th, 2016 at the Graceland Fruit Plant on Forrester Rd. in Gilmore Township. We discussed what went well in the response as well as what needed to be improved upon.

8. Incident Command System (ICS) Training

On Sunday January 31st, 2016 I taught an ICS refresher for Homestead Township Fire Department. ICS is a standardized on-scene incident management concept designed specifically to allow responders to adopt an integrated organizational structure equal to the complexity and demands of any single incident or multiple incidents without being hindered by jurisdictional boundaries.

An Incident Command System enables integrated communication and planning by establishing a manageable span of control. An Incident Command System divides an emergency response into five manageable functions essential for emergency response operations: Command, Operations, Planning, Logistics, and Finance and Administration.

Below are outlined many of the activities I have been involved in for the month of February 2016.

1. **EMT Training**

On Monday, Tuesday and Wednesday February 1st, 2nd and 3rd, 2016, I attended training offered by the Sleeping Bear Dunes National Lakeshore Law Enforcement and Benzie County Emergency Medical Services. These were continuing education classes intended for emergency medical licensing.

Region 7 Homeland Security Planning Board 2.

On Thursday February 4th, 2016 I attended the R7HSPB meeting in Grayling.

Meeting with Benzie County Firefighters Association 3.

On Tuesday February 9th, 2016 the newly created Benzie County Firefighters Association met and discussed some of the needs of the firefighting community in Benzie County. The purpose of the association is to develop a local firefighter training system.

Revenue Sharing Awards Ceremony-Grand Traverse Resort 4.

On Wednesday February 10th, 2016 I attended the Revenue Sharing Awards from the Grand Traverse Band of Ottawa and Chippewa Indians at the Grand Traverse Resort in Acme.

CONTINUATION OF EMERGENCY AUXILLARY RADIO IMPROVEMENTS

This was a grant request for completion of our emergency communications equipment improvements that the GTB approved partial funding for back in February of 2015. This application is requesting funding for our ARES (Amateur Radio Emergency Services)/ RACES (Radio Amateur Civil Emergency Services) equipment we utilize in emergencies in the amount of \$11,630.

COMMUNICATIONS EQUIPMENT FOR OUR CITIZENS EMERGENCY RESPONSE TEAM (CERT)

Our second application requested funding the same communications equipment that is identified above for our Citizens Emergency Response Team (CERT) members in the amount of \$5,800. This equipment will bring all of our emergency volunteer groups onto the same communications platform, thus streamlining emergency communications.

COUNTYWIDE FIREFIGHTER PERSONNEL ACCOUNTABILITY SYSTEM

Finally, this grant application was for a countywide system of firefighter accountability. I work very closely with all the fire departments in Benzie County and our goal is to make firefighting as safe as possible be providing accountability at a fire scene. Because it is a countywide initiative, I was asked to administer this grant on behalf of all the counties fire departments. The request was for \$5,500 for this project.

Benzie County CERT Meeting 5.

On Wednesday February 10th, 2016 we had a monthly meeting/training of the CERT Program.

Active Shooter Exercise Design Team Meeting 6.

On Thursday February 11th, 2016 we had another Active Shooter Exercise Design Team meeting. This exercise is an active shooting event in the Benzie County Government Center. While we are planning for approximately 6 to 7 hours of training, we will be running 3 exercises lasting 45 minutes to 1 hour long each. Exercise play is limited to a suspect search, patient care, building clearing and perimeter security in a defined area where there will be an organized effort to locate an active shooter, establishing a perimeter and treating is injured. Because of the expected number of responders, we hope to conduct 3 scenario's that will allow for different participants and change up the response to a certain degree.



7. Court Security Meeting

On Tuesday February 16th, 2016 I participated in a meeting regarding some concerns about Court Security. It was agreed to come up with some solutions and pricing for the security improvements that were talked about and we would schedule another meeting.

8. Dispatcher Testing

On Wednesday February 17th, 2016 I assisted Director Ron Berns in testing candidates for a vacant dispatcher position.

9. Auxiliary Communications Interoperability Conference (AUX COMM)

From Monday February 22nd through Thursday February 25th, 2016 Dispatch Director Ron Berns and I attended the AUX COMM Conference at the Great Wolf Lodge in Traverse City. The conference was sponsored by the Michigan Public Safety Communications System (MPSCS) and was attended by 911 Directors and staff members as well as members or Amateur Radio who operate the AUX COMM system. Interoperable Communications Conference has merged with the Auxiliary Communications (AuxComm) Conference. By combining the two events, it is hoped to improve communications, interoperability and information sharing between public safety agencies across the state.

1. Speaking Engagement at Grow Benzie

On Tuesday March 1st, EMS Director Craig Johnson and I spoke to Grow Benzie at their evening dinner. I spoke on the mission of Emergency Management and some of the activities I have been involved in since I started in Benzie County as well as some of the recent activities.

2. Region 7 Homeland Security Planning Board

On Thursday March 3rd, 2016 I attended the R7HSPB meeting in Grayling.

3. Meeting Regarding Nostwick Road Bridge

On Wednesday March 9th, 2016 I met with the Colfax Township Board, Benzie County Road Commission and the Public regarding the replacement options for the Nostwick Road Bridge whose weight limit was recently reduced to 6 tons. This eliminates fire apparatus, service trucks, propane deliveries, etc from crossing to serve the 6 homes across the bridge. They were inquiring if their might be some type of state or federal assistance that might be available in efforts to repair or replace the bridge.

4. Benzie County CERT Meeting

On Wednesday March 9th, 2016 we had a monthly meeting/training of the CERT Program.

5. Active Shooter Exercise Design Meeting

On Thursday March 10th, 2016 we had a meeting of the Exercise Design Team to finalize some of the Active Shooter Full Scale Exercise that we will be holding on Saturday May 14th, 2016. We will be sending out a survey to the to all the emergency first responder agencies who we hope will be participating in the exercise.

6. Meeting with Graceland Fruit-Forrester Rd. Management on SARA Title III Off-Site Response Plan

On Wednesday March 16th, 2016 I meet with the management of the Graceland Fruit Forrester Rd. Plant regarding our Superfund Amendments and Re-Authorization Act (SARA Title III) Off-Site Response Plan that has been developed by the Local Emergency Planning Committee. We discussed some of the EHS Chemicals on site and how they are used and stored. We went over the plan and made some minor corrections and added a significant amount of information from their onsite plan.

7. City of Frankfort Public Safety Committee Meeting

On Tuesday March 22nd, 2016 I attended a meeting of the City of Frankfort Public Safety Committee and discussed the role of the city's emergency services in the Countywide Emergency Management scheme.

8. Meeting with Jordon Development

On Tuesday March 22nd, 2016 I had a meeting with a representative of the Jordon Development Co. Jordon Development operates several gas wells in the southern county area as well as a pipeline system the feeds the gas to the MichCon system. We have developed specific off-site response plans that deal with a release of natural gas from a pipeline break.



9. Meeting with Benzie County Firefighters Association

On Tuesday March 22nd, 2016 the newly created Benzie County Firefighters Association met and selected an initial slate of officers to oversee the interests of firefighters in Benzie County. The purpose of the association is to develop a local firefighter training system.

10. National Weather Service-Spring Spotter Training

On Tuesday March 22nd, 2016 we held a Spring Weather Spotter Training Class in the Government Center. This was the same night that we had a Winter Storm Warning and that reduced attendance significantly. Last year we had 36 in attendance, this year we had 12. The meteorologist that gave the presentation talked a lot about the August storm event that hit Leelanau, Grand Traverse and Kalkaska Counties. He had several still photos and video of the storm as it was unfolding and gave the weather service analysis of what occurred. It was an excellent program and provided me with a better understanding on what occurred.

- 11. Meeting of the Local Emergency Planning Committee (LEPC)/Local Planning Team (LPT)
 On Wednesday March 23rd, 2016 we held our LEPC/LPT meeting in the EOC. We have been discussing moving the LEPC to a different time and date from the LPT Meeting. I proposed it to the committees because having both makes for an extremely long meeting and we need to have chemical users, transporters and manufacturers in attendance that we do not currently have.

Mitch will get ahold of Peter Cohl, and once we start getting number (MERS, Insurance, etc), we will start setting up meetings.


Jade Adams – Grievance:

THE GENERAL PROPERTY TAX ACT (EXCERPT) Act 206 of 1893

211.24f Proposal authorizing bond issuance or millage rate; ballot; maximum number of elections; submitting single question on renewal and additional millage.

Sec. 24f.

- (1) If a taxing unit submits a proposal on the question of authorizing the issuance of bonds, imposing a new millage, or increasing or renewing an existing millage, except an ad valorem special assessment millage for police or fire protection under 1951 PA 33, MCL 41.801 to 41.813, the ballot shall fully disclose each local unit of government to which the revenue from that millage will be disbursed. As used in this subsection:
- (a) "Local unit of government" means a county, city, village, township, school district, intermediate school district, community college district, public library, or local authority created under state law.
- (b) ""Public library"" means that term as defined in section 2 of the state aid to public libraries act, 1977 PA 89, MCL 397.552.
- (2) In addition to the requirement set forth in subsection (1) and any other requirement provided by law, when submitting a proposal on the question of authorizing a millage rate to be levied under this act, the ballot shall state all of the following:
- (a) The millage rate to be authorized.
- (b) The estimated amount of revenue that will be collected in the first year that the millage is authorized and levied.
- (c) The duration of the millage in years.
- (d) A clear statement of the purpose for the millage.
- (e) A clear statement indicating whether the proposed millage is a renewal of a previously authorized millage or the authorization of a new additional millage.
- (3) In addition to any other requirement provided by law, when submitting a proposal to authorize the issuance of bonds, the ballot shall state all of the following:
- (a) The principal amount to be borrowed.
- (b) The maximum number of years the bonds may be outstanding, exclusive of any refunding.
- (c) A clear statement of the purpose for which the proceeds of the bonds will be used.
- (d) For bonds other than bonds that are intended to be paid from a separate revenue source or from taxes levied in less than the entire taxing unit, the estimated millage that will be levied for the proposed bonds in the first year that the levy is authorized and the estimated simple average annual millage that will be required to retire the debt. Inaccuracies in the estimates provided under this subdivision shall not affect the validity of the bonds, the general obligation unlimited tax status requiring the levy of taxes sufficient to pay the bonds, or the results of an election.
- (e) For bonds that are intended to be paid from a separate revenue source or from taxes levied in less than the entire taxing unit, the primary source of the revenue that is intended to be used to retire the bonds.
- (4) A taxing unit shall hold not more than 2 elections in a calendar year concerning the authorization of a millage rate greater than the product of the immediately preceding year's reduced maximum authorized rate or rates as defined in section 34d(16) multiplied by the current year's millage reduction fraction, regardless of the number of questions presented at the election.
- (5) A taxing unit that levies millage under this act shall not submit a single question to the electors of the taxing unit requesting both the renewal of voter authorized millage and the authorization of new additional millage if the additional millage is greater than 0.5 mill. If authorization to levy millage has expired and the taxing unit submits to the electors the authorization of millage greater than the number of expired mills reduced pursuant to the millage reduction in section 34d(11), and if the additional millage is greater than 0.5 mill, the taxing unit shall submit 1

question for authorization of the number of expired mills reduced pursuant to the millage reduction in section 34d(11) and 1 or more additional questions for the authorization of millage in excess of that amount.

AGREEMENT FOR VETERANS' SERVICES

The parties, Grand Traverse County, located at 400 Boardman Avenue, Traverse City, MI 49684, and Benzie County, located at 448 Court Place, Beulah, MI 49617 agree as follows:

- 1. Purpose. Benzie County agrees to purchase, and Grand Traverse County agrees to provide, veterans' services. This agreement is authorized by 124.1, et. seq. Intergovernmental Contracts Between Municipal Corporations.
- H. Term. The term of this Agreement is from January 1, 2016 through December 31, 2018, inclusive.
- III. Responsibilities of Grand Traverse County Veterans' Affairs Department. The Grand Traverse County Veterans' Affairs Department shall provide the following services to Benzie County veterans:
 - (A) an open, staffed office one day each week with regular business hours in Benzie County at a location to be designated and provided by the Benzie County Board of Commissioners. The Grand Traverse County Veterans' Affairs Director may, at his discretion, cancel Benzie County Office operations due to inclement weather or mandatory staff training. The Director shall notify the office of the Benzie County Board of Commissioners as soon as possible in advance when any such suspension is necessary:
 - (B) an open, staffed office the other four days of the week with regular business hours at its office in Grand Traverse County:
 - (C) transportation, when possible, for Benzie County veterans to and from an appropriate veterans' hospital:
 - (D) administrative and management services to process and obtain veterans benefits and claims from the United States Department of Veterans' Affairs or any State or local veterans programs for Benzie County veterans:
 - (E) administrative and management services to process applications for benefits from the Benzie County Soldiers' Relief Fund and Michigan Veterans' Trust Fund, and veterans' burial allowance applications: and
 - (F) it is understood by both parties that Benzie County veterans have historically constituted 7-9% of the total Veterans' Affairs Department caseload.

- IV. Benzie County Responsibilities. In exchange for the above described services. Benzie County shall:
 - (A) pay Grand Traverse County \$31,484.00 in 2016, \$32,429.00 in 2017, and \$33,401.00 in 2018; and
 - (B) provide office space to the Grand Traverse County Veterans' Affairs Department as described in paragraph III(A), above.
- V. Termination. This Agreement may be terminated by either party. The party seeking to terminate the agreement shall provide written notice of its intent to terminate the agreement at least 60 days prior to the date it seeks to terminate. Notice shall be provided to the other party at the business address noted above. Any sums due and owing for services rendered shall be paid within 30 days of the last date of service provided under this Agreement. Any property purchased by a party for the use of the other shall be returned within 30 days of the last date of service provided under this Agreement.
- VI. Amendment. This Agreement may be amended at any time, in writing, by mutual agreement of the parties.
- VII. Whole Agreement. This Agreement constitutes the entire agreement between the parties and shall be deemed to supersede and cancel any other agreement between the parties relating to the transaction contemplated in this Agreement.
- VIII. Governing Law. This Agreement shall be governed by and interpreted in accordance with the laws of the State of Michigan. In the event any provision of this Agreement is in conflict with any statute or rule of any law in the State of Michigan or is otherwise unenforceable for any reason whatsoever, then that provision shall be deemed severable from or enforceable to the maximum extent permitted by law, as the case may be, and that provision shall not invalidate any other provision of this Agreement. Venue for any action brought under this Agreement shall lie in either Grand Traverse or Benzie Counties.
- IX. Effective Date. The parties have signed this Agreement in duplicate and it shall be effective as of January 1, 2016.

Dear Governor Snyder:

It has come to our attention that Marcus Abood was recently reappointed to the Michigan Tax Tribunal. For the reasons discussed below, we oppose this appointment and ask the appointment be withdrawn. We urge you to fill the At Large position with qualified assessors who show an understanding of both residential and commercial assessing.

Mr. Abood was a judge of the decision in *Home Depot v Breitung Township*. In that decision, Mr. Abood approved the use of sales of vacant properties to value a new Home Depot. The Home Depot serves as a regional market and is within a very competitive commercial strip. Yet, the vacant properties that Mr. Abood used were outside of the U.P. and were deed restricted abandoned properties. Mr. Abood reached a valuation for Home Depot stores (\$25 per square foot) that is not found anywhere in the United States. In Home Depot's home state of Georgia, the same stores have an average value of \$65 per square foot, roughly the same average value that is found in Wisconsin.

Mr. Abood has gone further and determined in the *Menards v City of Escanaba* case that seller-imposed deed restrictions do not affect marketing of the property or its sale price. Mr. Abood is the only tax professional, litigant or judge, to have adopted this point of view. This view is contrary to Michigan law.

Mr. Aboud is notable for his rejection of traditional methods of assessment, either because he does not understand assessing or because of his bias.

The appointment appears to reject the concerns of local government that the Tribunal has become biased and that Tribunal decisions are far outside the range of reasonable decisions and valuations found anywhere in the United States. These concerns have been voiced in the newspapers in Michigan and outside the state for over a year. We hope that your office simply made a mistake and urge the withdrawal Mr. Abood's appointment.

We have urged our legislators to have the Senate hold a hearing and deny its consent to Mr. Abood's appointment. The lack of qualified persons in the executive branch of government causes serious damage to local units. The damage done by the policies embraced by Mr. Abood will have a lasting effect on local government throughout the State of Michigan. It is our hope that Mr. Abood does not represent your view of local government or a rejection of the assessment practices from the State Tax Commission. At the point when a legislative fix may be on the horizon, the last thing the State of Michigan needs is to add to the irreparable harm that has already been caused by Mr. Abood.

Project Plans. Please clarify whether the plan view dimensions are for the entire pond or are the dredge area within the pond. If there are any wetlands adjacent to the pond, please show them as well.

Cross-sections. Provide two typical cross-section drawings A-A1 (lengthwise) and B-B1 (crosswise) showing the existing width and depth profile, and the proposed profile as seen along that dimension.

Provide one set of 8½ by 11 or 11 x 17 plans. Please provide the existing stream flow volume (at the time of proposed dredging) in CFS (cubic feet per second) and

demonstrate that the proposed pumping system has adequate volume capacity above the identified flow. Show what materials will be used for a cofferdam and the installation and removal methods.

WHEREAS, requiring local governments and MDOT to notify the entities one year in advance of any relocation of utilities or transmission lines is unnecessary, burdensome potentially costly, and punitive to the extent that it levies a fine in the form of paying for relocation costs for failure to timely notify the entities; now

THEREFORE, BE IT RESOLVED that the Kalkaska County Board of Commissioners firmly opposes HB 5016 and respectably asks the support of Senator Casperson and Representative Kivela in our opposition; and

KALKASKA COUNTY BOARD OF COMMISSIONERS EPA AND ARMY CORP OF ENGINEERS IMPLEMENTATION FOR REGULATION FOR DEFINED WATERS OF THE US UNDER THE CLEAN WATER ACT RESOLUTION #2016-10

WHEREAS, in August 2015, the U.S. Environmental Protection Agency (EPA) and the Army Corps of Engineers (Corps) implemented a regulation for the Definition of Waters of the U.S. under the Clean Water Act, which has since been temporarily halted by the 6th U.S. Circuit Court of Appeals; and

WHEREAS, both agencies are seeking a rule change to give the federal government more authority by expanding the definition of "navigable waters" in the Clean Water Act; and

WHEREAS, the rule change would subject almost all physical areas with a connection to downstream navigable waters, including features such as ditches, natural or man-made ponds and flood plains, to the jurisdiction of the Clean Water Act; and

WHEREAS, that under the rule change, Michigan's Wetlands Law will be in violation of the Clean Water Act; and

WHEREAS, if Michigan loses delegated authority and must work directly with the Corps, the agency can take months or years to answer a permit application, and can even deny permits with impunity; and

WHEREAS, the change will cause significant harm to local farmers, stall the development of businesses, take control of land used for sustainable food production out of our local providers' hands, and negatively impact county-owned and maintained infrastructure such as roadside ditches and county drains; and

WHEREAS, Michigan has robust programs to protect water quality in our state; and

WHEREAS, the rule change would bring enormous costs to our farms, municipalities and taxpayers.

THEREFORE, in consideration of the foregoing, BE IT RESOLVED that the Kalkaska County Board of Commissioners of Kalkaska County wholly support preventing the furtherance of the U.S. Environmental Protection Agency and the Army Corps of Engineers proposed rule expanding the definition of "Waters of the United States" and requiring these agencies to work with state and local governments on rule development; and

BE IT FURTHER RESOLVED that copies of this Resolution be provided to all Michigan counties, Gov. Rick Snyder, the Michigan Association of Counties and representative members of the Michigan congressional delegation.

1. Audit Report Presentation: Ken Talsma from the auditing firm of Anderson, Tackman and Company passed out a graphical presentation of the financial statements and reviewed the highlights of the fiscal year 2015 audit report. Ken stated that the best audit finding is that of the unmodified/unqualified opinion meaning that everything was found to be good in terms of documentation of accounting principles and rules. For fiscal year 2015, the Health Department received an unmodified/unqualified audit. A single audit was also done this year as the Health Department went over the \$500,000 federal funding limit. Ken explained the new liability reporting rule for pensions and the Health Department's defined benefit pension is funded at 80 percent.

Motion: by Rentenbach to acknowledge receipt of the 2015 audit report. Seconded by

Sauer. Voice vote: 4 ayes

Motion Carried.

2. Medical Director Presentation: Dr. Joshua Meyerson presented a PowerPoint on raising the minimum age of legal access to tobacco. Statistics have found that most adults begin smoking before the age of 21. Increasing the minimum age of legal access to 21, decreases the likelihood of teens trying tobacco and thus reduces the risk of nicotine addiction. Dr. Meyerson is asking the Board of Health to adopt a resolution in support of increasing the age of tobacco access to 21.

Discussion followed.

Motion: by Rentenbach, seconded by Griner to support the resolution increasing the minimum purchase age of tobacco and other nicotine products from 18 to 21.

Ayes: Griner, Sauer, McCulloch, and Rentenbach Nays: One Excused: Ryckman and Lautner Motion Carried.

3. Health Officer Update-

Peacock commented on the following programs

Northern Michigan Public Health Alliance

- The Immunization project headed up by District Health Department #10 continues. Our Health Department will be working on reminder and recall to improve coverage of the 2 childhood Hep A dose as well as coordinating a school-based immunization clinique each county. DHD #10 also recently submitted a grant to fund a partnership between local schools and health departments in the region to improve healthy food choices in schools and specifically targeting sodium intake.
- The Jobacco Dependence Health Systems Change project led by the Health Department of Northwest Michigan has been focusing on: Clinical staff training on the Clinical Practice Guidelines for treatment of tobacco dependence as well as working on standing orders, for treatment, policy and procedure review and EMR workflow preparation.
- MDHHS issued a press release last week (see attached) indicating that the "Northern Region" has been selected to move forward as a Community Health Innovation Region of the State Innovation Model (SIM). We have had some phone interviews related to this and are beginning some preliminary planning to be prepared for when further implementation guidelines are released.
- Representatives from the NMPHA have also been involved in a workgroup
 with the Northern Michigan Health Network who is writing a large CMS grant
 to fund an Accountable Health Communities project which will ultimately
 contribute to the work of the SIM in identifying health risks in our population
 and providing linkages to community resources and navigation services to
 reduce barriers and improve health outcomes.
- The Alliance was awarded the Robert Wood Johnson funding for the Cross Jurisdictional Sharing Implementation and Impact Program which will involve measuring the efficiency and effectiveness of conducting community

health needs assessment across multiple jurisdictions.

Please see the attached updated summary of NMPHA activities.

Public Health Emergency Planning (PHEP): The project team continues to meet regularly and coordinate exercise and training. Planning is underway for the two large scale regional exercises in June and September. The second will focus on school-based community flu clinic and will allow to gain valuable experience in mass immunization, dispensing and logistics while providing an important community service.

Community Health Needs Assessment (CHNA): Community conversations are complete and "What Matters To You" surveys are being distributed widely. If you have not had the opportunity to give input through either process please let us know and we will provide the survey for you. It is important to have many voices represented. The data for the entire northern region will be compiled and priorities identified which will contribute to the next phase of community health improvement planning.

Regional Insight Software Project: Workgroups consisting of representatives from all partner agencies have been meeting with the Netsmart project team to identify roles and responsibilities as well as determine timeline for implementation of the Mylnsight EMR software. The timeline planned is for go-live in the spring of 2017. There is a lot of work to be done developing consistent and efficient workflows for all of the personal health programs.

Benzie Resource Center: Lisa reported that renants involved in the remodel project met with the NHF architect and building project manager to further explore the possible options for renovation of the building to make space for NMHSI dental operatories. Details are being finalized however we have arrived at a "not to exceed cost" for rental amounts under the new financing in which a new resolution needs to be approved at this meeting. The dental services have already been in demand and MMHSI has been working with a waiting list of adults in need of dental storative work many of whom are in pain. Together with our partner tenants we have come up with a plan to temporarily locate a full size chair in a private space so that dental services beyond hygiene can be delivered until construction is finished. An adequate space on the upper level has been identified for this and the transition will be happening within the next week to free up that space. Gerry Chase, NHF corresentative, was able to be available via telephone to answer questions. The proposed resolution would be to amend the current lease agreement and have a not to exceed cost of \$400,000 which is the known projected cost of the remodel project at this time. The proposed resolution also gives authority to Lisa Peacock and Roger Griner to act on behalf of the Board of Health in the financing of the remodel project.

Discussion followed.

<u>Motion:</u> by Sauer, seconded by Rentenbach to approve the resolution to amend the lease agreement between the Health Department and NHF Sub Benzie-

Leelanau dated December 18, 2002. Ayes: Sauer, Griner, Rentenbach, and McCulloch. Nays: None. Excused: Ryckman and Lautner. Motion Carried

BLDHD Program Highlight: In response to BOH members request for increased information about services provided we will continue to highlight 1-2 programs per meeting to provide the program details without causing the meetings to become too lengthy. This month we will focus on the WIC program which provides nutritional support and education to hundreds of women and children in the district and has a significant impact on local economy with \$396,279.28. spent in local businesses.

4. Personnel and Finance Committee Report:

A. Accounts Payable-

Motion: by Sauer, seconded by McCulloch to approve the accounts payable in the amount of \$193,918.68. Ayes: Griner, Sauer, McCulloch, and Rentenbach Nays: Excused: Ryckman and Lautner Motion carried

B. January 2016 – Financial Statements-

Motion: by Sauer, seconded by Rentenbach to place the January 2016 financial statements on file. Ayes: Griner, Sauer, McCulloch, and Rentenbach Nays: None Excused: Ryckman and Lautner Motion Carried

C. Creation of Part-Time Account Oler Position —
Putney reported that this is a result of us moving in the direction of private insurance billing and shifting of some job duties within the administration section of the Health Department. I am asking for a .60 FTE account clerk The reimbursement specialist position would reduce to a .80 FTE creating an overall increase of a 40 FTE. The Health Department received State funding to help offset start up costs associated with accepting private insurance and this additional funding will help with the new position.

Motion: by Griner, seconded by Rentenbach, to approve the request to create a part-time account clerk position Ayes Griner, Sauer, McC Excused: Ryckman and Lautner Motion Carried. Ayes Griner, Sauer, McCulloch, and Rentenbach Nays: None

D. Increase EH Secretary Positions to 1.0 FTE -

Putney reported that in conjunction with part-time account clerk position, we are asking to reinstate the Engecretary positions back up to a 1.0 FTE. The demand of secretarial needs have increased with the changes with the new computer software, Type II regulations as well as the increase in permit activity. This will reopen the EH window back to the public for five days a week.

Motion: by Rentenbach, seconded by Sauer to increase the environmental health secretary positions back to a 1.0 FTE. Ayes: Griner, Sauer, McCulloch, and Rentenbach Navs: None Excused: Ryckman and Lautner. Motion Carried.

E. Creation of Public Health Nurse Position -Klein reported the need for a .80 FTE nurse primarily working in the Leelanau office. The

Health Department has received increased funding in the healthy futures program, family planning and HIV prevention programs to help fund this position. Having an additional nurse will allow the Health Department to increase immunization clinics and billable home visit services.

Motion: by Rentenbach, seconded by McCulloch to create a public health nurse position. Ayes: Griner, Sauer, McCulloch, and Rentenbach Nays: None Excused: Ryckman and Lautner. Motion Carried.

F. Acceptance of Credit Cards -

Putney reported that in starting to bill private insurance comes the need to accept credit/debit cards from clients that would like to pay for their office co-pay. Putney stated she has found a clearing house that would provide us a free USB reader, no cancelation fees, no set up fees with a month to month agreement through a company called Pay Anywhere. Is asking to have the Health Department absorb the processing fee of 2.69 percent of the charge. In looking at other clearinghouses, this is truly the most economical and easiest for the us. In checking with other health departments throughout the State, most absorb the processing fee in exchange for an increase in clinic payments.

<u>Motion:</u> by Rentenbach, seconded by Sauer to accept credit cards with the Health Department absorbing the processing fee of 2.60 percent. Ayes: Griner, Sauer, McCulloch, and Rentenbach Nays: None Excused: Ryckman and Lautner.

Motion Carried.

G. Personnel Policies' Updates Putney stated that now the court case has been settled we need to revamp our personal

policy and sexual harassment policy. Asking for Board approval to contract with Lisa Vogler to rewrite these policies. In talking with our current legal counsel, Jim Young, he was in favor of having a work on this project as she has extensive knowledge of labor law. Lisa Vogler stated that one of the concerns is that the policy is outdated, and did not have express the lat-will" employment. Explained the next steps of updating. Lisa Peacock thought that his would be a good topic for the Northern Public Health Alliance. Advocate to incorporate the sexual parassement policy be incorporated into the Personnel Policy. Reasonable notice to alert employees that their positions are "at-will" employees. Lisa estimated that the price would be approximately \$1500 to \$2000.


5. Staff Reports:

- A. Administrative- Dodie Putney reported that she is putting lawn care services for the Leelanau building out for bid now with the snowplowing bids out in the fall.
- B. Environmental Health- Tom Fountain reported that Maro Grossnickle, who use to work with us and was laid off eight years ago, has agreed to come back. This is good for the Department as he is already trained and familiar with the counties. Tom also reported on getting data transferred from our electronic software, CMHC, into Health Space. Mentioned that the Flift water crises still has a lot of finger pointing. The EPA just finished the audit of the Drinking Water Division of DEO and identified some critical issues. One of which is that the program is severely underfunded.
- C. Personal Health Michele Klein reported that Leelanau County Early Childhood Committee (LCEDC) is holding a silent and live auction fundraiser on April 28 at Aurora Winer. Tickets are \$40 and can be purchased at the door or online at http://sjecdc.wix.com/lecdo. Reported on the Day at the Capitol and was reported that there would be flat funding in FY 2017 which is still less than FY 2003 funding. Michelle passed out talking points pur out by MALPH regarding the funding of health departments. Also passed out was the County Health Rankings in which Benzie is ranked 30th in health outcomes and 14th in health factors and Leelanau is ranked 2nd in health outcomes and 9th in health factors.
- D. Medical Director- Dr. Joshua Meyerson, MD, MPH Followed up on the Zika virus; there have been around 200 requests for testing primarily by pregnant women who traveled to the impacted area. There has been two confirmed cases but unknown if they were pregnant women. Dr. Meyerson feels the amount of requests have peaked.

Board Comments: Griner reported on a MAC transportation committee member, from

Genesee County, stating there are 4 million people in America today that miss doctor's appointments because of transportation issues. Griner talked about the need within our own community. Griner also commented that there are 10,000 people a day turning the age of 65. When talking about healthy initiatives, these issues need to be looked at. Griner mentioned that any money not being used should be invested to earn the highest interest earning potential. Dodie agreed to investigate and contact the Benzie County Treasurer on what the County's practice is and report back to the Board.





Re: The League of Women Voters of Michigan opposition to the continued operation of the Enbridge pipeline.

Our purpose in contacting you is to ask that the Benzie Board of Commissioners pass a resolution opposing the continuous operation of Pipeline 5, and send a letter to Michigan's Attorney General Schuette, asking that the Pipeline be shut down now. Attorney Schuette, himself, has said: "We would not allow this pipeline to be placed in the Great Lakes today and its days are certainly numbered." (February 1, 2016)

This Enbridge pipeline is 64 years old; it stretches 645 miles from Canada to Detroit and Toledo carrying twenty three million gallons of oil every day under the Mackinac Straits which, as you know, connect Lakes Huron and Michigan. We are very concerned that this pipeline may burst.

A recent University of Michigan study concluded that the Straits of Mackinac is the "worst possible place for a burst oil pipe." Last summer, results of a thorough investigation by the State of Michigan revealed that this pipeline, known as "Line 5," poses an unacceptable risk to the Great Lakes. (See enclosed clippings referring to a second U. of M. study released only the end of March.)

As members of the League of Women Voters in Benzie County we ask the Benzie County Commissioners to urge Attorney General Schuette to take action to safeguard the high quality of Lake Michigan water-- the drinking water source for forty million people. We are including a second page with additional details about the condition of the pipeline as well as points to support the immediate need to close it down.



- 1. Corrosion is the primary cause of pipeline failure, and Enbridge's data reveals that a portion of the pipeline in the Straits has lost 41% of its original (8 feet) wall thickness. Additionally, currents in the Great Lakes are devastating.
- 2. A catastrophic oil spill would have a record detrimental effect on Michigan tourism, agriculture, drinking water, fishing, shipping, and commercial enterprises.
- 3. It was an Enbridge pipeline that burst in Kalamazoo, dumping nearly a million gallons of heavy tar sands for 17 hours before it shut down the line.
- 4. Since 1988. Enbridge has had 15 known failures on Line 5, spilling about 260,00 gallons of oil; Enbridge's pipeline network, between 1999 and 2010, has had 804 total failures that spilled a total of 6.8 million gallons of oil.
- 4. The Coast Guard has testified that it does not approve of Enbridge's Emergency Response Plan.
- 5. Enbridge lacks a credible plan to recover oil during winters when the lakes are covered with ice.

Thank you for taking a stand on safeguarding the high quality of Lake Michigan water—the drinking water source for 40 million people.

Concern over the twin pipeline at the Straits has increased since the state's Michigan Petroleum Pipeline Task Force published its recommendations.

The latest controversy was last week over a study conducted by the University of Michigan Water Center and the National Oceanic and Atmospheric Administration's Great Lakes Environmental Research Laboratory.

The study, supported by the National Wildlife Federation, concluded that more than 700 miles of Great Lakes coastline are in danger of potential contamination from a Line 5 oil spill.

Enbridge spokesman Ryan Duffy, as quoted in the Detroit Free Press, said the study's model and illustrations "focus on an unrealistic volume of oil released." He said "Line 5 has operated safely across the Straits of Mackinac for 63 years and continues to do so."

STATEWIDE **ELECTED OFFICIALS**

A champion on a current Great Lakes issue is Attorney General Bill Schuette, who is fighting Waukesha's effort in southeast Wisconsin to slurp a huge 10 million gallons of water a day from the Great Lakes.

This is not a solo effort by Schuette. He's drawing on the diversions authority of the Great Lakes-St. Lawrence River Water Resources Body and the Great Lakes-St. Lawrence River Basin Water Resources Compact Council.

Schuette made the point to both groups that "The Great Lakes are one of the greatest resources not only for Michigan, but for the entire country. Waukesha's request to divert millions of gallons is very serious and, unless the serious exception is met, should be denied.

Great Lakes issues loom in campaigns

hankfully, Great Lakes issues are likely to become prime factors in 2016 congressional, gubernatorial and presidential campaigns in Michigan — maybe more this year than ever before.

In the First Congressional District race to replace retiring U.S. Rep. Dan Benishek, R-Crystal Falls, former Democratic State Chairman Lon Johnson of Kalkaska County, at an event last week in Suttons Bay, called for immediate closing of the Enbridge Line 5 pipeline across the Mackinac Straits and an immediate assessment of alternatives for the transmission of that oil.

(Benishek is among a bipartisan group of representatives and senators pushing legislation to combat the threat of Asian Carp in the Great Lakes. As he noted: "From fisheries to recreation, so much of our economy rests on health of the Lakes.")

Johnson, among contenders for the office Benishek has held since January 2011, has been vocal on Line 5, but others are weighing in on the issue as well.
