PUBLIC INPUT

Purpose: The Benzie County Board of Commissioners is a public policy setting body and subject to the <u>Open Meetings Act (PA 267 of 1976)</u>. The Board also operates under a set of "<u>Benzie County Board Rules (section 7.3)</u>" which provides for public input during their meetings. It continually strives to receive input from the residents of the county and reserves two opportunities during the monthly scheduled meeting for you the public to voice opinions, concerns and sharing of any other items of common interest. There are however, in concert with meeting conduct certain rules to follow.

Speaking Time: Agenda items may be added or removed by the board but initially at least two times are devoted to Public Input. Generally, however, attendees wishing to speak will be informed how long they may speak by the chairman. All speakers are asked to give their name, residence and topic they wish to address. This and the statements/comments will be entered into the public record (minutes of the meeting). Should there be a number of speakers wishing to voice similar opinions, an option for a longer presentation may be more appropriate for the group and one or more speakers may talk within that time frame.

Group Presentations – 15 minutes
Individual Presentations – 3 minutes

Board Response: Generally, as this is an "Input" option, the board will not comment or respond to presenters. Silence or non-response from the board should not be interpreted as disinterest or disagreement by the board. However, should the board individually or collectively wish to address the comments of the speaker(s) at the approval of the Chair and within a time frame previously established, responses may be made by the board. Additionally, the presenter may be in need of a more lengthy understanding of an issue or topic and may be referred to a committee appropriate to address those issues.

Public Input is very important in public policy settings and is only one means for an interchange of information or dialogue. Each commissioner represents a district within the county and he/she may be individually contacted should greater depth or understanding of an issue be sought. Personal contact is encouraged and helpful to both residents and the board.

THE BENZIE COUNTY BOARD OF COMMISSIONERS February 23, 2016

The Benzie County Board of Commissioners met in a regular meeting on Tuesday, February 23, 2016, 448 Court Place, Government Center, Beulah, Michigan.

The meeting was called to order by Vice Chairman Frank Walterhouse at 9:00 a.m.

Present were: Commissioners Bates, Carland, Sauer, Tucker, Walterhouse and Warsecke

Absent: Excused: Chairman Griner

The invocation was given by Comm Bates and the pledge of allegiance was led by Comm Sauer.

Agenda:

Motion by Bates, seconded by Sauer, to approve the agenda as amended, adding potential OMA violation at 10:15. Ayes: Bates, Carland, Sauer, Tucker, Walterhouse and Warsecke Nays: None Exc: Griner Motion carried.

Minutes:

Motion by Bates, seconded by Sauer, to approve the regular session minutes of February 9, 2016 as presented. Ayes: Bates, Carland, Sauer, Tucker, Walterhouse and Warsecke Nays: None Exc. Griner Motion carried.

9:03 a.m. Public Input

Ted Wood, Joyfield Township Clerk and member of Lakes to Land, stated that he supports your consideration for the AES proposal; at the Benzie Summit last October and they had very positive comments regarding AES and economic development.

Josh Mills, Frankfort Superintendent, says thank you for your dedication to this fine community that we call home; he stated he is in support the proposal of AES; this requires strong leadership; he doesn't feel we need more studies, we need to implement the strategies in place and he is confident that we will see immediate rewards.

Betsy Evans, Director of Business Development for AES has provided the board with one-page of additional information and stated that the EDC has been supportive as well.

Eric VanDussen, Benzonia, says he doesn't understand how this board does not grasp that Cohl Stoker & Toskey has an absolute conflict of interest in representing the Sheriff and the county in regard to David Tucker's grievance and the lawsuit; there was a secret HR meeting on August 31, 2015 with Mr. Tucker where you went into closed session and no minutes were taken; why wasn't Ms. Olney in that meeting or Tammy Bowers her assistant clerk to take minutes and record the open session of that meeting; where are those minutes for the August 31, 2015 HR meeting where a decision was made by that HR committee. Also, December 22, 2015 closed session which is the subject of my lawsuit where MMRMA had already assigned another attorney to represent the county – why would you go into closed with Bonnie Toskey by phone – she doesn't even represent the county in that threat of action; why the secrecy – that is the biggest question here.

Mike Worden, Chair of EDC, stated that he supports the AES; it was an easy decision for EDC; if we want to have consistent economic development in the county we need this; there needs to be a commitment by the county.

Katie Osborn stated that she works for the Prosecuting Attorney and before that worked for the County Clerk; she stated she will be running for County Clerk this election.

Bev McCarthy, AES Board, we are very excited about the potential of working together. Our board is very interested.

Deb Lindgren, Joyfield Twp, spoke of her concerns about AES – you have been elected to represent the people; you need to do your research; did you post this service that you are looking at; did you give Networks Northwest the chance to bid on this. Where is the money coming from? Very concerned about this going to AES.

ELECTED OFFICIALS & DEPT HEAD COMMENTS:

Sheriff Schendel, passed out some information for the board regarding point of clarification regarding the county vehicle policy – Comm Bates was confused, it should be all elected officials not just the Sheriff Dept. The Sheriff Dept is not bound by the Personnel Policy adopted by the Board of Commissioners.

Comm Tucker asks if the policy language was changed to bothe sole discretion of the Sheriff.

Doug Durand, Council on Aging, provides the February 2016 report; last year we saved over \$14,000 with the Feeding America Program with the purchase of dry goods and we are also now working with Food Rescue; last Thursday they met with Paul Oliver Hospital and are working on partnership collaboration on educational services – it was a great meeting; January was a good month for the agency and they continue to look forward to an early Spring.

Amy Bissell, Register of Deeds, updated the board for the last IY stating that we moved close to \$1.1 million through her office; of that \$721,000 went to the state transfer tax; \$26,430 went to the Register of Deeds Automation Fund for the upgrading of technology \$17,970 went to the State Survey and Remonumenation Fund to reset the corners in the State of Michigan; \$237,500 went to the county General Fund Four office is a revenue generator. Revenues for this FY are up 7.69% over last year at this point; Passports -- \$4,750 last year of 190 passports with an average of 15 minutes each; they have been notified by the Dept of State to expect an increase in passport applications over the next two years. They have two search engines to use records on-line 1) Loredo – for the title companies independent searchers they sign up pay a fee and can use the records 24 hours per day; and 2) Tapestry – those are for customers that are occasional users; split the fee with the software company SB 599 is out there – this is known as the flat-fee bill and is a restructuring fee passed the senate and is now at the house. If it passes, it could bring about \$67,000 to Benzie County.

Marlene Wood, Recycling Coordinator, stated that the bins have settled from the holidays and the county has community events and education is very important and to have recycling bins available to them; she has been attending festivals already -- Water Festival, Shiver by the River and Winterfest.

<u>Dawn Olney, County Clerk</u> stated that she is running for re-election for County Clerk and not retiring as some have said.

Comm Bates said that Platte Township meets quarterly but they did have a budget meeting.

Comm Tucker stated that she has attended the Benzie Transportation and they are negotiating Bill's contract renewal; she also attended the Council on Aging meeting; she restated that anything that is in front of the Board of Commissioners concerning her husband, she will recuse herself.

Comm Tucker asked that the meetings with the Jail Administrator and Sheriff that are being held start having detailed information to the Board tegarding those meeting. She would like to see it at each BOC meeting.

Michelle Thompson, County Treasurer, stated that they are just gathering data at this point.

Michelle Thompson, County Treasurer, presented the cash fund by summary report with a couple of funds in the red; she provided an update regarding the Remonumentation Program — we are about 75% redone 15% of the remaining 25% is federal property or swamp land. She commented on SB 599 that was discussed by the Register of Deeds and stated that the County Treasurers are lobbying to get an exemption from that flat-fee.

Taxes are due to the townships in Pebruary 16 and delinquent to the county treasurer March 1.

#2: Comm Bates stated that he is not comfortable with where we are heading with item 2; this change should be done during the budget process; we are making accommodations that could come

back to bite us; don't understand why we continuing to play this revolving game; let's get the sheriff's budget in control; why do we continue to go down this road.

Comm Sauer stated that we were under the impression there was four positions there; hesitant to do this; concern is contract issues; the Sergeant without the Undersheriff being an Undersheriff, the Sergeants are run by seniority; there could be one Sergeant overseeing the Undersheriff; we had status quo during contract negotiations; still not sure of this.

Sheriff Schendel stated the reason we are in this position is because of a promotion with a reduction in benefits; one of six surrounding counties have an outside Undersheriff – not hired from within; the Undersheriff is not a union position; other counties are doing what we are asking.

Comm Tucker says you have been violating; you have the verbiage that allows you to put the U/S back in the union and he would not lose his time.

Mitch Deisch says we are stuck in this endless game of a temporary scenario; a continuous cycle of Undersheriff – Sergeant – Undersheriff. We are Walting for a decision from MERS regarding leaving the Undersheriff in the bargaining unit for retirement purposes only.

Comm Bates asks what the cost is; we have a budget and need to live within that budget; we are back to making exceptions.

Comm Warsecke says that until we get it straightened out, how will anyone want to promote, they will make less money.

Vice Chair Walterhouse says we will put this issue on hold and bring back at a later date; get all of the questions asked.

#3: Comm Bates asks how the board make-up at ASE will be. Yes, Benzie County will be added to the board, but we don't know yet how many—we will look at a total restructuring of the board. Comm Tucker stated that she hasn't been involved in a lot of the committee presentations, and doesn't fully understand it. Deb has some good questions; can you get it on an agenda for a full presentation.

Comm Bates says he concurs with the length of the contract and is happy with the 60-day out; How many will be on the board from Benzie.

Beth McCarthy indicated that they are looking at a 15-18 member board but we are open to what you feel is fair representation.

Vice Chair Walterhouse says EDC should be two of the people on it together with a Commissioner. Comm Sauer asks if you provide reports to the City and County of Manistee now.

Ms. McCarthy stated yes, they used to have an annual meeting and have increased it to twice per year; they also send a monthly update to them.

Comm Tucker inquired – is this a 3-year agreement; and with a 60-day out in the first year only? Yes three year, no not only 60-day out in the first year.

Mitch Deisch says he will start finalizing the agreement.

Motion by Bates, seconded by Warsecke, to support the Alliance for Economic Success proposal in conjunction with the City of Frankfort, not to exceed \$20,000, funds to come from Fund Balance with a 60-day cancellation notice; the agreement to be brought back before the full board for approval.



RE: Alleged Violation of the Open Meetings Act

Dear Chairperson Griner and Board members:

You have asked for my opinion as to whether or not Sheriff Schendel has violated the Michigan Open Meetings Act (OMA) as a result of statements he made publicly about discussions that occurred during a closed meeting of the Board of County Commissioners (BOC) on December 22, 2015. This letter is in response to that request.

By way of background, at its December 22, 2015 meeting the BOC unanimously voted (with Commissioner Tucker abstaining) to conduct a closed session for the stated purpose of "discussions regarding attorney opinion with Bonnie Toskey by telephone, to include County Clerk Dawn Olney, Sheriff Ted Schendel and County Administrator Mitch Deisch." The motion to go into the closed session for the stated purpose was made sometime after 5:15 p.m. (The minutes do not state the exact time the motion was made or when the closed session began.) The minutes then indicate that the BOC went back into the open meeting at 6:17 p.m.

Subsequent thereto, a citizen, Eric VanDussen, filed a request under the Freedom of Information Act (FOIA) for copies of any public records discussed in the closed session. That request was denied. Mr. VanDussen then filed an appeal of that denial to the BOC. The BOC upheld that denial and Mr. VanDussen subsequently filed a lawsuit in the Benzie County Circuit Court seeking disclosure of the requested information under the FOIA.

An article in the February 18 edition of the Traverse City Record Eagle reported that a federal lawsuit had been filed against the Sheriff by former Under- Sheriff David Tucker. That article also reported that Sheriff Schendel acknowledged that the December 22 closed session related to a potential civil lawsuit threatened by Mr. Tucker. Sheriff Schendel is quoted as saying, "That's what this is all about." As a result, certain members of the BOC feel that Sheriff Schendel may have violated the OMA by disclosing what transpired in a closed session. Youy have referred that issue to me and have asked for my opinion as to whether or not the OMA has been violated and, if so, what the BOC's remedy is.

Section 8 of the OMA [MCL 15.268] sets forth the permissible purposes for which a public body such as the BOC may meet in a closed session. One of those purposes is found at subsection (h) which authorizes a closed session "To consider material exempt from discussion or disclosure by state or federal statute." Pursuant to subsection (g) of section 13 of the FOIA [MCL 15.243(g)], "Information or records subject to the attorney-client privilege" is exempt from disclosure under FOIA. Therefore, pursuant to subsection (h) of section 8 of the OMA [MCL 15.268(h)], the BOC was authorized to meet in a closed session to discuss a written opinion from legal counsel submitted pursuant to the attorney-client privilege. *Booth Newspapers*, *Inc.*, v. Wyoming City Council, 168 Mich. App. 459; 425 N.W.2d 695; 1988 Mich. App. LEXIS 239.

Accordingly, the closed session held at the December 22, 2015 BOC meeting was properly authorized for the stated purpose of discussing with counsel a legal opinion written by said counsel.² Once a public body goes into a closed session for the purpose of discussing an opinion subject to the attorney-client privilege, the scope of that discussion in the closed session is not defined by the amount of detail contained in the written legal opinion but, instead, by the legal matter raised and addressed in the writing. *Booth Newspapers*, p.469.

It would appear from Sheriff Schendel's statement in the Record Eagle that he spoke of the matters discussed in the closed session and that, by doing so, he disclosed information which would be in the minutes of that closed session. Pursuant to subsection 2 of section 7 of the OMA [MCL 15.267(2)], the minutes of a closed session "are not available to the public, and shall only be disclosed if required by a civil action filed under section 10, 11, or 13." The OMA goes on to provide that those minutes "may be destroyed 1 year and 1 day after approval of the minutes of the regular meeting at which the closed session was approved."

² It should be pointed out that, while Sheriff Schendel is quoted as saying that the closed session was about a threatened lawsuit, the OMA does not permit a closed session for the purpose of discussing threatened litigation. It only permits a closed session to discuss trial or settlement strategy in connection with "specific pending litigation." The closed session was not called for the purpose of discussing threatened litigation, however. It was called for the purposes of discussing with its attorney a written legal opinion. While that written legal opinion may have concerned a threatened lawsuit, that fact did not, in my opinion, prevent the BOC from meeting in a closed session to discuss that written opinion from legal counsel.

I spoke with Sheriff Schendel who indicated that when he made the statement he assumed the matter was then public knowledge and he had no idea that his statement might be construed as a violation of the OMA. Regardless, assuming that Sheriff Schendel, by his comments, disclosed information that was discussed in the closed session and contained in the minutes of that closed session, the question is whether or not those comments constitute a violation of the OMA and, if so, what is the penalty for that violation?

The OMA has two sections which address OMA violations. Section 12 of the OMA [MCL 15.272] provides for a criminal penalty and section 13 [MCL 15.273] provides for civil liability.

Section 12 [MCL 15.272] provides as follows:

- Sec. 12. (1) A public official who intentionally violates this act is guilty of a misdemeanor punishable by a fine of not more than \$1,000.00.
- (2) A public official who is convicted of intentionally violating a provision of this act for a second time within the same term shall be guilty of a misdemeanor and shall be fined not more than \$2,000.00, or imprisoned for not more than 1 year, or both.

Section 13 [MCL 15.273] provides as follows:

- Sec. 13. (1) A public official who intentionally violates this act shall be personally liable in a civil action for actual and exemplary damages of not more than \$500.00 total, plus court costs and actual attorney fees to a person or group of persons bringing the action.
- (2) Not more than 1 action under this section shall be brought against a public official for a single meeting. An action under this section shall be commenced within 180 days after the date of the violation which gives rise to the cause of action.
- (3) An action for damages under this section may be joined with an action for injunctive or exemplary relief under section 11.

With respect to the criminal liability imposed by MCL 15.272, that is a matter outside of my jurisdiction as that is something wholly within the jurisdiction of the county prosecutor. I would, however, point out that guilt under MCL 15.272 is based on someone **intentionally** violating the act, and a specific intent can be difficult to prove.

With respect to civil liability under MCL 15.273, there is the same requirement of showing that the violation was intentional. Intent can be just as difficult to prove in a civil case as in the criminal liability context.

What is most significant, however, is that there may not be a punishable violation of the OMA at all. While the OMA gives the BOC the right to meet in a closed session for certain purposes set forth in the statute, I am unaware of any provision of the OMA which specifically prohibits anyone who participates in such a closed session from publicly disclosing what was said in that closed session. The BOC could at any time, for example, publicly release information

discussed in a closed session if it chooses to do so by a majority vote of its members. Absent such a vote to make public that information, the confidentiality of which is protected by the OMA, all members of the public body and other persons who participate in such a closed session have, at a minimum, a moral and ethical, as well as a fiduciary, duty to honor that confidentiality and to refrain from disclosing what was said in the closed session.

While the OMA itself does not provide a penalty for such conduct, if the person who violates that duty is an employee of the public body, he or she could be disciplined for their action. If, however, the person who violates that duty is an elected official, there is no penalty which can be imposed on said individual. Instead, he or she is answerable to the voters. It is the power of the ballot box either in a regular or a recall election which decides if the elected official's actions deserve the ultimate penalty of removal from office.

Therefore, except for the disciplinary action it could impose against an employee, there is no action the BOC can take against an elected official who discloses information discussed in a closed session. All the BOC can do, at most, is adopt a resolution of public censure or rebuke, an action which carries no penalty and is mostly taken for the sake of public appearance only.

I trust this answers the question presented. Please advise if I can be of any further assistance.


Tom Longanbach said they talked about sending a memo to the department heads to see if there are funds that they have spoken for or not, could those funds be used for these expenses.



If they agree, we'll split the cost with them and do the entire 1,200 ft instead of just a 50' patch.

The board previously approved county-funded primary road improvements. They were presented a list of projects with county-funded primary road improvements estimated to be about \$370,620.00 for 2016. Motion by Comm Mick and supported by Comm Nuske to put the county-funded primary road improvements out for bids. Ayes: Rosa, Nuske and Mick. Motion carried.

Crystal Lake Township - They have submitted a list of road improvements for 2016 to be paid for from the township's road millage. Their millage will bring in about \$158,000 this year. The estimates have been completed and the estimated cost is about \$188,000 depending on bid prices. The township would like the Road Commission to pay for the difference between their millage and the actual costs. Because these are local roads, the Road Commission Local Road Policy does not allow Road Commission participation.

In keeping within the guidelines of the Local Road Policy a motion was made by Comm Rosa and supported by Comm Nuske that the BCRC agrees to provide additional funds for 2016 Crystal Lake Township millage projects with the understanding that the BCRC's funds be reimbursed by Crystal Lake Township in the next fiscal year. BCRC will waive the normal 10% administrative charge, perform necessary preparatory work, and restore shoulders after the 2016 project paving is completed at no cost to Crystal Lake Township. New Employees - We can hire 2 full-time employees for the crew.

Correspondence/Information/Discussion:

Local Road Committee meeting update-the Local Road Committee met on 2/2. The Committee approved the millage local road list presented. Also, they voted to establish a contingency fund of 10% of the local road half of the millage not to exceed \$50,000 for emergency use.

Inland Township projects - Inland Township would like to clear and improve Fewins Rd between Lake Ann Rd and Reynolds Rd and Miller Rd from Cinder Rd to Aylsworth. We are getting the roads surveyed.

Building Improvements - Skiver Construction just finished up putting a steel ceiling in the Tire Room. Some electrical, plumbing and restorative corrections were necessary.

Fuel System- We would like to get the fuel tanks replaced in the fall.

Forest Funds - An explanation was handed out regarding Category E- Forest Road funding - Which counties receive it, how much they receive and how much they receive.

Cole vs Benzie County - The judgment from the State Court of Appeals came in.
