PUBLIC HEARING - Stormcloud Brewing Co.

Laura Galbraith, Executive Director of Venture North, is present together with Rick Schmitt, Co-Owner of Stormcloud Brewing.

Ms. Galbraith updated the board and the public that is present of the purpose of this request. Stormcloud Brewing is requesting a loan through the CDBG Loan Fund in the amount of \$70,000; will be used to purchase equipment and hire two full-time positions over the course of two years of which at least 51% will be available for low to moderate income individuals. On November 14, 2018, the loan committee unanimously approved this loan.

Comm Carland asked what the mechanics are of this fund. The money is loaned out and when repaid, does it go back into the Benzie County pot? No it goes to the defederalized pot to be used by anyone in the regional area.

Comm Jeannot asked if when loans are repaid, those funds then go into the federal pot? Yes Comm Griner asked if the \$400,000 is for Benzie County, how often does it have to draw? One project each calendar year.

Comm Jeannot to Rick – seasonality of your business and how to maintain payments. Purpose of this project is to help offset the seasonality. Meijer stated they would offer more shelf space, but they need a third product.

ELECTED OFFICIALS & DEPARTMENT HEAD COMMENTS

Doug Durand, Executive Director for Benzie Senior Resources, provided a written report and also reported that November 13 BSR received the Community Impact Award from the Chamber of Commerce, together with Stormcloud as the business of the year. Medicare/Medicaid assistance program last year (FY 18) saved the Benzie County citizens \$71,615; just under \$40,000 was saved for the seniors as well. October In-Home Services showed an increase of just over 40%, with most seniors are 85+ years old, which require more services.

Tom Longanbach, Equalization Director, presented a revised L-4029 due to the SRO being approved on the November 6, 2018 ballot and the Headlee Millage Reduction of .9955 to .9953. Also request to amend the Apportionment Report due to the SRO and Blaine Township millage.

Eric VanDussen, Chair of the Building Authority (BA), stated that the BA is participating in the second round of mediation with ELA on Friday; the rest of the board will meet in a special meeting and will meet in closed session to discussion the proposed settlement and hopefully will come out of closed session to make a final decision if he can accept a settlement. Second issue: was here a couple of weeks ago to seek \$500,000 cash flow for the BA from the DTRF.
