COMMISSIONER REPORTS

Comm Sauer reported that the Maples are at 95% occupancy; DHHS is required to take one day off per week; attended a workers comp meeting – the fund is doing well; COVID is a w/c claim, however the burden is on the employee to show that they got it at work. Attended the Betsie River Zoning Board of Appeals meeting and heard two appeals with both being for Manistee County properties. Road Commission reported that the MTF fund are down 12% which is equal to \$340,000. Elmer's have nearly completed all projects. Blaine Twp held their meeting outside, also a public meeting on the water issue on Lower Herring Lake was held outside. The Village of Thompsonville meeting went well.

Comm Warsecke provided a written report (attached); also stated, regarding the issue at the last meeting regarding Hazard Pay, he is in solidarity with the BOC on the denial, he didn't feel as a group, they can't bring something back to this board. Comm Jeannot explained that another request could be brought forward, however the same request cannot per Roberts Rules of Order.

Comm Taylor reported that the Homestead Township meeting was held via teleconference and stated that the park is now open, and they are hoping to hold their July meeting at the township hall. The township sexton has resigned so a new one has been hired. Village of Honor held an in-person meeting and passed a resolution for a Notice of Intent for sewer bond.

Comm Nye provided a written report (attached) and also stated regarding the Benzie Central superintendent search, that the Executive Search Services group stated that it would be hard to get another superintendent to come to Benzie County due to the salary/benefit package and candidates will likely be principals and high administrative professionals.

Comm Farrell reported that she attended the Human Services Collaborative meeting and stated that Michigan Works are helping people to apply for unemployment. Grow Benzie stated there will be no farmers markets this year. Census update – we are behind prior reporting periods. Benzie Bus will discontinue their grocery shopping but will continue with delivery of groceries. Other meetings she has attended were Health Department held a special meeting on May 28; Airport Authority; Centra Wellness.

Comm Jeannot provided a written report (attached) and reported that the townships he represents will be open to the public no later than June 15. Will ask the Friends of Point Betsie Lighthouse to come to the board with a presentation of what has happened there and the cost with respect to rising water levels – what, if any, roll the county will play.

Chair Roelofs reported that the Village of Lake Ann guardrail project is complete and asks that any police reports include that there is property damage so the village can file a claim with the insurance company. Veterans Affairs met and they are having discussions about an upcoming outing perhaps Labor Day, since Memorial Day was missed with their event.

COUNTY ADMINISTRATOR'S REPORT – Mitch Deisch

A written report was provided; attorney interviews discussed – they will be scheduled for June 17 from 1:00 pm to 5:00 pm; Mitch will talk with Karen Korolenko regarding plexiglass for her office; stated we need to keep the Headlee committee moving forward – will be placed on the June 23 Committee of the Whole meeting for further discussion.

Comm Jeannot asked that a timeline be updated as to how to continue to move forward.

Rhonda Nye District IV – Benzonia Township Commissioner Report June 9, 2020

May 27 - Centra Wellness Planning & Finance Committee:

Committee reviewed balance sheet, income statement, and credit card statement. Recommendation to full Board to approve a budget amendment for \$30,000 for the purchase of laptop instead of desktop computers, this fiscal year instead of next, to provide employee flexibility. Deferred Revenue (Projected Lapse) line added to the 'Liabilities and Fund Balance Sheet' to indicate Medicaid monies slated to send back to the NMRE at the FY end — monies remain available if needed.

June 4 - Village of Benzonia:

Village Council set the tax rate; remains the same as previous year. Approved payoff of the EDC loan. Planning Commission holding a public hearing on June 25th at 6:30 to inform and receive input on the three new ordinances; call in phone number will be posted on the website: villageofbenzonia.com.

June 5 - Centra Wellness Executive Committee:

All Centra Wellness staff will be back in the office by June 15. Meeting discussion centered on recent defense attorney filings of 'not guilty by reason of insanity'. Once a judge decides to grant a petition for evaluation, defendant then waits for an opening at the forensic center in Ypsilanti; this wait in jail time is sometimes longer than the sentence would have been. Cost to the counties can be excessive. Centra Wellness will attempt to intervene early in these cases with behavioral health care which will mitigate costs.

June 7 - Village of Beulah:

Village Council set the tax rate. Village attorney, Kerrie Zeits, walked the Council through the steps that need to be taken for a Covid-19 Preparedness and Response Plan. Ad hoc committee was established to address the opening of Village public areas; bathrooms will remain closed until plan is in place. Campground tentative opening June 12th. Crystal Lake Business Association Update of summer events:

- All 4th of July events are cancelled decorations of homes and boats and such is encouraged.
- All Music in the Park is cancelled the Accidentals are booked for the 2021 event.
- 52nd Beulah Art Fair is cancelled.

Japanese Knotweed is going to be treated at the mouth of the Cold Creek. AT&T contracts are being re-negotiated at a significant savings. New street striping in the Village is complete and streets have been swept.

Art Jeannot Commissioner Report June 9, 2020

- Participated in 2 meeting since our May 26th meeting.
- **6/8 Headlee Discussion** Conference call with Ogemaw County officials. The take away from that discussion continues to be communication to the public. I anticipate Mitch will talk about this at greater length.
- 6/8 Almira Township Township office will be open to public starting Monday, June 15th.
- Other
 - As most citizens, I have participated in several conference calls regarding the Governor's executive orders and updates on COVID-19.
 - I have stayed in contact with many of my assigned committees and agencies by phone. The
 purpose is to share information regarding the current situation (COVID-19) and determine if the
 BOC needs to act on any issues on the group's behalf.
 - Friends of Pointe Betsie Chuck Clarke has served on the board from the its inception and in the capacity of treasurer for many of those years. He will be term limited at year end 2020.Cost to repair and shore up base at lighthouse may run into the millions. The cost would be prohibitive for the FPBLH. The BOC and FPBLH will need to consider next steps. As a reminder, the County owns the property.
 - Platte Township The Ironman competition slated for later this summer has received the township approvals. I was told that the township hall will re-open Thursday, June 11th.
 - Benzie County Chamber Office is re-opening week of June 8th. The CVB transition to Traverse City Tourism Bureau was to be completed June 1st.
 - o Lake Township Office will open Monday, June 15th. Safety measures will be followed.
