**PLEASE READ THE FOLLOWING REGULATIONS:**

1. Tags must be placed on the rear-view mirror with the permit number facing outward. Branchburg Township Police monitor the lot daily and will issue summonses to owners of vehicles where a valid permit is **NOT** displayed **OR** displayed improperly as per municipal ordinance number 3-7.2. of the Township's Code.
2. Vehicles must be parked within the designated parking spaces. Anyone taking up multiple parking spots will receive a summons.
3. For vehicles that park on the perimeter of the lot, please back into the space so the permit is displayed outward and easily viewed.
4. Please utilize the proper entrance and exit routes in the lot.
5. Vehicles must be registered, inspected and insured.
6. Parking is on a first come, first-serve basis and no overnight parking is permitted.
7. No vehicles over 8,500 lbs. gross vehicle weight may park in the lot.
8. Please lock your vehicles and remove valuables to reduce vehicle theft.
9. No parking between the hours of 12:00 a.m. and 4:30 a.m.

**PERMIT HOLDERS ARE SUBJECT TO SUMMONSES IF ANY OF THE ABOVE REGULATIONS ARE NOT ADHERED TO.**
