As we emerge from the pandemic, I hope this letter finds you and your family doing well. The Covid-19 Pandemic has changed all our lives and businesses, but that does not mean we have stopped improving ourselves or the township. This year the township took the steps to preserve and open "Branchburg's Silver Saddle Community Pool". This was the site of the former Silver Saddle Swim Club which is full of township history and was almost sold to a developer for yet another high-density development. We also continue with improvements to our roads, parks and other facilities.

Dealing with the financial ramifications of the pandemic has been no easy task for any of us. Based upon our current projections we should be able to reduce our spending for this year and have no affect on your future taxes. We are also taking steps to make sure that as much government services and transactions are available online so you may "Skip the Trip" to town hall for municipal matters.

Enclosed you will find your 2021-2022 property tax bill which shows how your tax dollars are being spent. The Township has taken careful steps over the past few years to ensure that our financial "house" is in order.

While the State and other communities have experienced a decline in their tax base and a reduction in their financial ratings, over the past years Branchburg has seen an increase in local employment and an improved ratable base. We are especially proud that our bond rating remains "AAA" status. The best any town can receive. There are only 18 communities in the State of New Jersey and only 250 nationwide and who have earned this prestigious financial status. This ranking has been conferred upon us by independent bond rating firms and is a result of a solid financial plan, a healthy ratable base and sound management both fiscally and administratively. Maintaining this financial ranking will result in lower borrowing rates and therefore save countless taxpayer dollars.

Additionally, your tax dollars are helping to fund our volunteer fire and rescue squad services. These volunteer organizations are the heart of our emergency management team and are fully staffed by your friends and neighbors. Please remember to support these volunteers during their annual fundraising activities.

The members of the Township Committee, and the Township staff, recognize the trust you have placed in us to manage your local government. We have made it our daily goal to produce the most cost effective and efficient organization possible.
