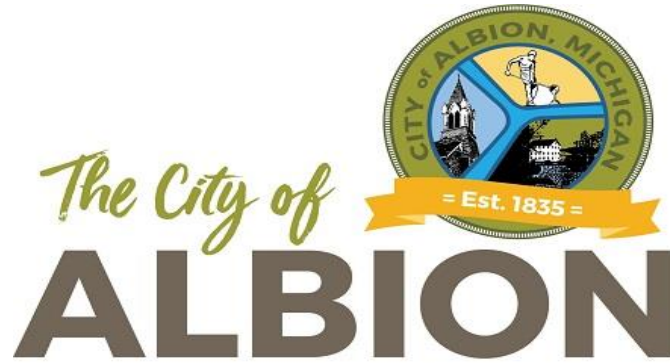

I CALL TO ORDER

The meeting was called to order by Eric Tobin, Income Tax Administrator for the City of Albion, as we were just organizing.

II ROLL CALL

Cullen Harkness, City of Albion Attorney, was present via Zoom, also present in person were Eric Tobin, Holly Zblewski, and Nidia Wolf

III ELECT A CHAIR AND SECRETARY

Eric Tobin related the purpose, and the history of the City Income Tax Board as regards the collection of Income Tax from Albion residents and those persons working within the City of Albion. He also entertained questions from Holly and Nidia.
