The Township of Denville encourages all Anglers to use the Catch and Release philosophy while fishing at Holstein Lake. This will insure a health fish population for all to enjoy!

STATE FISHING REGULATIONS

- 1. All persons 16 and older must possess a New Jersey Fishing License to fish any waters in this area
- 2. Persons over 70 years old do not need a license but must be able to show proof of age. (Driver's License, Birth Certificate)
- 3. No trout stamp is needed by anyone.
- 4. License must be displayed on hat or outer clothing at all times while fishing.
- 5. Bass fishing is allowed all year long—however, between April 15th and June 15th <u>ALL</u> bass must be released unharmed back into the water. This is spawning season.
- 6. Size of bass—Keepers must be a minimum of 12 inches long.
- 7. Number of bass—5 per day may be kept except during spawning season.

Denville Township Regulations for Holstein Lake

- 1. Badges must be displayed at all times for inspection by Denville Township Employees.
- 2. Anglers under the age of 16 must be accompanied by an adult at all times.
- 3. There is a limit of 2 (fish) per day per angler.
- 4. No Boats are allowed.
- 5. Children under 7 do not need a badge, all other need a badge.
- 6. NO alcoholic beverages or illegal drug use of any kind.
- 7. NO Dogs are allowed.
- 8. No gas powered toy boats.
- 9. No fishing off any private property around the lake.
- 10. Any violations of the above listed rules are grounds for immediate loss of fishing privileges.
