AN ORDINANCE TO AMEND CHAPTER II-A, FEES, RATES AND CHARGES OF THE GENERAL ORDINANCES OF THE TOWNSHIP OF DENVILLE

BE IT ORDAINED, by the Municipal Council of the Township of Denville, in the County of Morris and State of New Jersey, as follows:

SECTION 1. Chapter II-A, Fees, Rates and Charges, Section 2A-6, Health, of the General Ordinances of the Township of Denville is hereby amended to read as follows:

SECTION 2. Chapter IV, General Licensing, §4-12, Retail Food Establishments and Food and Beverage Machines, is hereby amended in the following particulars only:

a. §4-12.4, Fee established, is hereby amended to read as follows:

“There shall be a fee established for a license or license approval issued pursuant to this section as set forth in Chapter IIA, Fees, of the Code of the Township of Denville.”

b. §4-12.5, Reinspection Fee, is hereby amended to read as follows:

“Retail food establishments that fail to receive a satisfactory rating on their inspection will be subject to a reinspection fee as set forth in Chapter IIA, Fees, of the Code of the Township of Denville.”

SECTION 3. Chapter IV, General Licensing, §4-13, Massage, Bodywork and Somatic Therapy Establishments, is hereby amended in the following particulars only:

- a. §4-13.4, Massage, Bodywork and Somatic Therapy Establishment Permit Fee is hereby repealed.
- b. §4-13.7, Massage, Bodywork and Somatic Therapist Permit Fee and Renewal is hereby repealed.

SECTION 4. All Ordinances of the Township of Denville which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 5. If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 6. This Ordinance shall take effect immediately upon final passage, approval and publication as required by law.
