Background

- On February 22, 2021, Governor Phil Murphy signed into law a bill establishing the legal status of "regulated cannabis" in New Jersey for individuals 21 years of age and older.
- ▶ The state has empowered local municipalities to determine their own regulations and zoning ordinances governing the number, type, and operations of cannabis businesses within their borders.
- ► The state Cannabis Regulatory Commission (CRC) will not issue a license to any cannabis-related business that would be in violation of a local ordinance or regulation.
- ▶ Dunellen has taken the initial step of "opting out" and not allowing any cannabis-related businesses until a full assessment can be done of public opinion and potential regulations.

Background Mayor's Cannabis Taskforce

- Mayor Cilento created the Mayor's Cannabis Task Force:
 - community members ranging from:
 - municipal and school officials,
 - business owners,
 - residents,
 - civic organization leaders and
 - law enforcement
- Purpose: To assist in the reviewing of available information regarding having a cannabis business in-town; evaluating the potential impact a cannabis business may have on the Borough of Dunellen.
- ▶ The following slides summarize what the task force has come to understand and culminates in a recommendation to council.

What Efforts Have the Task Force Taken to Evaluate?

- Tracked state regulations
- Reviewed other municipalities' ordinances
- Spoken with folks involved in cannabis-related businesses
- Gathered data from available sources
 - Collected public comments

Examples of Efforts

- Sat in on state Cannabis Regulatory Commission meetings
- Reviewed ordinances from other municipalities who have opted-in
- Monitored cannabis businesses that have opened
- Spoke with/ interviewed people who work in the cannabis industry
- Mayor and Councilmembers attended cannabis sessions at the League of Municipalities event
- Followed litigation related to cannabis businesses both in state and out of state
- Engaged the community on the topic of having a cannabis business in Dunellen via:
 - Community Survey (Summer of 2022)
 - Town Hall Meetings 12OCT2022 and 29NOV2023
 - Booth Hosted at Dunellen HarvestFest OCT2023
 - Periodic/ recurring Council Reports

Dunellen Town-Wide Survey Recap

- Dunellen residents' response to NJ State referendum on cannabis-related businesses was about 2:1 in favor of cannabis-related businesses
- Dunellen residents' response to this current town survey on cannabis-related businesses in the town of Dunellen was about 1:1, neither for, nor against
- Of the Dunellen residents who indicated support for cannabis-related businesses in town, support was based on:
 - ▶ anticipated revenue 93%
 - economic development 79%
 - ▶ health 58%
- For Dunellen residents who favor cannabis-related businesses in town, support appears to be heavily dependent on revenue to Dunellen; an economic advantageous stance.
- ▶ But, that should NOT come at the expense of quality of life as there was a strong community response to maintain the family-oriented atmosphere that currently exists in Dunellen.


Risks vs Benefits of Cannabis Business in Town

Risks

Benefits







Benefits

- Two percent (2%) revenue on sales from a cannabis business and economic development
 - ► Example: \$20k from \$1M in cannabis business revenue
- ► Health Equity | Social Justice
- Convenience of having a cannabis related business in town









Risks

Mandatory 5 years

▶ Can "Opt-in" at any time, but once opted-in, committed for 5 years

▶ Saturation

- Increasing number of businesses statewide and more importantly locally, eg. Greenbrook, Middlesex, and Plainfield.
- ▶ But, demand is not increasing proportionally → diminishing revenue per business

▶ Litigation

- ▶ Metuchen, Keyport, and Flemington are currently engaged in litigation with business owners over how licenses are being issued, as well as other issues.
- ▶ A small town like Dunellen cannot afford to make expensive mistakes
- ▶ Safety, Traffic/Parking, Quality of Life voiced in the town-wide survey
- Costs to Borough to setup infrastructure
 - ▶ Hiring of new employees to support, eg. Police officer(s), tax assessors, etc.

Recommendation to Council

- ► Continue to "Opt-out" of having a cannabis business in Dunellen, at this time.
- ► The <u>perceived risks</u> based on the information gathered <u>outweigh</u> the <u>anticipated benefits</u> a cannabis business might provide.
- If new data become available at a later date, perhaps a new effort to evaluate could take place.

The Survey

- ► The survey was a 15-item tool used to gather information from the Dunellen Community on perspectives regarding having a Cannabis business in town.
- ► The survey was opened in July 2022 and responses were collected through August 2022.
- The survey was available online and was also available via paper completion.
- ▶ Invitations to complete the survey were made via social media outlets as well as direct e-mails to those subscribed to Dunellen community distribution lists.
- ▶ A total of 281 participants completed the survey.



Back-Up

Types of cannabis related businesses

Class 1 – Cannabis Cultivator/ Grower

means any licensed person or entity that grows, cultivates, or produces cannabis in this State, and sells, and may transport, this cannabis to other cannabis cultivators, or usable cannabis to cannabis manufacturers, cannabis wholesalers, or cannabis retailers, but not to consumers.

Class 2 – Cannabis Manufacturer –

means any licensed person or entity that processes cannabis items in the State by purchasing or otherwise obtaining usable cannabis, manufacturing, preparing, and packaging cannabis items, and selling and optionally transporting, these items to other cannabis manufacturers, cannabis wholesalers, or cannabis retailers, but not to consumers.

Class 3 – Cannabis Wholesaler –

• means any licensed person or entity that purchases or otherwise obtains, stores, sells or otherwise transfers, and may transport, cannabis items for the purpose of resale or other transfer to another cannabis wholesaler or to a cannabis retailer, but not to consumers.

Class 4 – Cannabis Distributor –

means any licensed person or entity that transports cannabis in bulk intrastate from one licensed cannabis cultivator to another licensed cannabis cultivator, or transports cannabis items in bulk intrastate from any of class of licensed cannabis establishment to another class of licensed cannabis establishment and may engage in the temporary storage of cannabis or cannabis items as necessary to carry out transportation activities.

Class 5 – Cannabis Retailer –

means any licensed person or entity that purchases or otherwise obtains usable cannabis from cultivators and cannabis items from cannabis manufacturers or cannabis wholesalers, and sells these to consumers from a retail store, and may use a cannabis delivery service or certified cannabis handler for the off-premise delivery of cannabis items and related supplies to consumers. A cannabis retailer shall also accept consumer purchases to be fulfilled from its retail store that are presented by a cannabis delivery service which will be delivered by the cannabis delivery service to that consumer.

Class 6 – Cannabis Delivery –

• means any licensed person or entity that provides courier services for consumer purchases of cannabis items and related supplies fulfilled by a cannabis retailer in order to make deliveries of the cannabis items and related supplies to that consumer, and which services include the ability of a consumer to purchase the cannabis items directly through the cannabis delivery service, which after presenting the purchase order to the cannabis retailer for fulfillment, is delivered to that consumer.
