

Rates and Parking Information Hours of enforcement for on-street parking and all lots are Monday thru Friday from 8 am to 5 pm. Parking is free on the streets and in all lots on Saturdays, Sundays and Holidays.

Metered Parking rates are \$0.25/hour with a 2 hour maximum.

Daily Parking is available in Skinner Plaza (train station) and Towne Plaza (the corner of S. Washington and North Ave.) in the numbered spaces at the rate of \$4.00/day. ***Fee will be raised to \$5.00/day beginning June 1, 2015.** Numbered spaces are located in Skinner Plaza along the embankment to the right of the train station entrance, and the second and third rows parallel to S. Washington Ave. They are also located along the embankment at the Towne Pharmacy parking lot and on the side of the building by the Dry Cleaner. Meters for this are located at the train station entrance and at the corner of Towne Plaza along S. Washington Ave. They accept coins, bills and credit cards and the ability to pay from your phone once on the train. Instructions on the pay-by-phone feature are located on the machines. Instructional flyers are also available at the Parking Authority Office and can be mailed to customers upon request by calling the office at **732-968-3663**.

Two-Hour Parking on Residential Streets

In order to reduce and/or eliminate the number of commuters that park on Dunellen streets an ordinance was enacted to ensure that the residents of Dunellen and their visitors will always have a parking space in front of their home. Parking is limited to 2 hours on the streets included in the ordinance for non-residents. To avoid being ticketed, residents are encouraged to obtain free of charge Resident decals for their cars by contacting the **Parking Authority at 732-968-3663** and producing proof of residency. They can be picked up in person at the 345 Front Street location, or delivered to your home by a member of the Parking Authority upon request. Also available are guest passes that are to be displayed on the dash board of a visitor's vehicle.
