#### ORDINANCE NO. 2020-07

# AN ORDINANCE TO APPROVE A LONG-TERM TAX EXEMPTION AND FINANCIAL AGREEMENT BETWEEN THE BOROUGH OF DUNELLEN AND 528 NORTH AVE URBAN RENEWAL, LLC

**WHEREAS**, the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1, *et seq.*, as amended and supplemented (the "**Act**"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment; and

**WHEREAS**, in accordance with the criteria set forth in the Act, the Borough Council (the "**Borough Council**") of the Borough of Dunellen (the "**Borough**"), acting as the Borough's redevelopment entity pursuant to N.J.S.A. 40A:12A-4, designated certain properties identified on the Borough's tax map as Block 69, Lots 1, 1.01, 2, 2.01 and 3; Block 70, Lots 13 and 13.01; Block 85, Lots 1 and 2; Block 83, Lot 1; Block 1, Lots 14, 15.01, 15.02, 16, 17, 18, 19, 20, 21, 22 and 23; Block 2, Lots 10, 11.01, 11, 12, 13, 14, 15, 16, 17, 18, 19 and 20; Block 32, Lots1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14.01, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 24.01, 25, 26, 27 and 28; Block 33, Lots 14, 14.01, 15, 16, 17, 18, 19, 20, 21, 22 and 23; Block 34, Lots 10.01, 22, 23, 24, 24.01, 25, 26, 27.01, 27.02, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 38, 38.01 and 38.02; Block 48, Lots 16, 17,18,19, 20, 21, 22, 23, 24, 25, 26, 27 and 28; Block 49, Lots 25, 26, 27.01, 28, 29, 30, 31, 32, 33, 34, 35, 37, 38, 39.01, 39.02, 40, 41, 43 and 44; Block 50, Lots 1, 2, 3, 4, 5 and 6; Block 51, Lots 1, 2 and 3 (NJ Transit Property); Block 65, Lot 1; Block 66, Lots 1, 2, 3, 4, 5, 6.01, 7, 8, 9, 10.01, 10.02, 11, 12,13, 14, 15.01, 15.02, 16, 17, 17.01, 18, 19 and 20; and Block 86, Lots 1, 2, 3, 4, 4.02, 4.03 and 5 as an area in need of redevelopment under N.J.S.A. 40A:12A 5 (collectively, the "**Redevelopment Area**"); and

**WHEREAS**, pursuant to <u>N.J.S.A.</u> 40A:12A-7, the Borough Council adopted by ordinance on May 16, 2016, the Restated and Amended Dunellen Downtown Redevelopment Plan, Phase 1, and subsequently amended by ordinance on November 6, 2017 and September 4, 2018 (the "**Redevelopment Plan**") for the Redevelopment Area; and

**WHEREAS**, 528 North Ave Urban Renewal, LLC (the "**Entity**") is the owner of certain parcels within the Redevelopment Area commonly known as 528 North Avenue and identified on the Borough's tax map as Block 34, Lots 31, 32, 33 and 34 (collectively, the "**Property**"); and

**WHEREAS**, on March 16, 2020, the Borough Council passed a resolution authorizing the execution and delivery of that certain Redevelopment Agreement (the "**Redevelopment** Agreement"), which sets forth the respective obligations for the Borough and the Entity with respect to the redevelopment of the Property in accordance with the Redevelopment Plan; and

**WHEREAS**, the Redevelopment Agreement provides for, <u>inter alia</u>, a residential rental redevelopment project at the Property consisting of 40 rental housing units, of which 34 will be market-rate rental housing units and 6 rental housing units will be low income and moderate income housing units, as those terms are defined by <u>N.J.S.A.</u> 52:27D-304, allocated per the Uniform Housing Affordability Control regulations, <u>N.J.A.C.</u> 5:80-26.1 *et seq.*, as well as

infrastructure improvements and related remediation (collectively, the "Project"); and

**WHEREAS**, the Project as set forth in the Redevelopment Agreement conforms to the Redevelopment Plan and the master plan of the Borough; and

**WHEREAS**, pursuant to the Act, improvements to property located within an area in need of redevelopment may qualify for long term tax exemptions under the Long Term Tax Exemption Law, <u>N.J.S.A.</u> 40A:20-1 *et seq.* (the "**LTTE Law**"); and

**WHEREAS**, the Entity is authorized to do business as an urban renewal entity under the laws of the State of New Jersey pursuant to the provisions of the LTTE Law; and

**WHEREAS**, despite the Entity's substantial investment of equity and borrowed funds, such amounts are insufficient to pay for all of the costs associated with the development and construction of the Project; and

**WHEREAS**, the provisions of the Act and such other statutes as may be sources of relevant authority, if any, authorize the Borough to accept, in lieu of real property taxes, an annual service charge paid by the Entity to Borough as set forth in such laws; and

**WHEREAS**, in order to enhance the economic viability of and opportunity for a successful project, the Entity has submitted an application for the approval of a long term tax exemption for the Project (the "**Exemption Application**"), attached hereto as <u>Exhibit A</u>, and a form of financial agreement (the "**Financial Agreement**"), attached hereto as <u>Exhibit B</u>, to the Borough, all in accordance with the LTTE Law; and

**WHEREAS**, the mayor of the Borough has provided his recommendations with respect to the Exemption Application to the Borough Council; and

**WHEREAS**, upon review of the proposed Project, the Exemption Application and the Financial Agreement, the Borough has made the following findings with respect to the Project pursuant to N.J.S.A. 40A:20-11:

- 1. The development and construction of the Project, including infrastructure improvements as set forth in the Redevelopment Agreement and the Redevelopment Plan will be beneficial to the overall community; will achieve the goals and objectives of the Redevelopment Plan; will help revitalize the Property; will improve the quality of life for the community; will serve as a catalyst for further private investment in areas surrounding the Property; will facilitate the remediation of environmental contamination and the revitalization and productive reuse of land currently in a blighted, stagnant, unproductive and fallow condition; will enhance the economic development of the Borough by alleviating existing blight conditions of the Property; and will further Redevelopment Plan objectives and contribute to the economic growth of the Borough in general and specifically the Property;
  - 2. The Project will result in the creation of six (6) units of affordable housing;

- 3. The aforesaid benefits of the Project exceed the cost, if any, associated with granting the tax exemption provided by the Financial Agreement;
- 4. The Financial Agreement is a material inducement to the Entity to undertake the Project in the Borough and facilitate the redevelopment of the Property; and

**WHEREAS**, the Borough is agreeable to granting a long term tax exemption to the Entity for the Project and, in connection therewith, the Borough and the Entity will utilize the Act and such other statutes as may be sources of relevant authority, if any, to facilitate financing of the Project; and

WHEREAS, in accordance with the provisions of the Act and the LTTE Law, the Borough desires to approve the Project, the Exemption Application and the Financial Agreement.

### NOW THEREFORE, BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF DUNELLEN, NEW JERSEY AS FOLLOWS:

- Section 1. The Recitals are incorporated by reference as if set forth in full.
- Section 2. The Exemption Application submitted by the Entity is hereby approved in accordance with Section 8 of the LTTE Law.
- Section 3. The Mayor, in consultation with counsel to the Borough, is hereby authorized to execute the Financial Agreement following the execution thereof by the Entity and prepare, amend or execute any other agreements necessary to effectuate this ordinance, subject to modification or revisions, as deemed necessary and appropriate, with such execution to occur only simultaneous with the full execution of a redevelopment agreement for the Project.
- Section 4. The Clerk of the Borough is hereby authorized and directed, upon execution of the Financial Agreement by the Mayor, to attest to the signature of the Mayor and to affix the corporate seal of the Borough upon such document.
- Section 5. An exemption from taxation as set forth in the Financial Agreement is hereby granted to the Entity, with respect to the Project for the term set forth in the Financial Agreement; provided that in no event shall the term of the Financial Agreement exceed the earlier of (i) thirty-five (35) years from the date of execution of the Financial Agreement or (ii) thirty (30) years from the Annual Service Charge Start Date, as said term is defined in the Financial Agreement, and only so long as the Entity remains subject to and in compliance with the Financial Agreement and the LTTE Law.
- Section 6. The executed copy of the Financial Agreement shall be certified by and filed with the Office of the Borough Clerk. Further, the Clerk shall file certified copies of this ordinance and the Financial Agreement with the Tax Assessor of the Borough and the Director of the Division of Local Government Services with the Department of Community Affairs, in

accordance with Section 12 of the LTTE Law. Further, the Borough Clerk shall, within ten (10) days of the later of (i) the effective date of this Ordinance, or (ii) execution of the Financial Agreement, transmit certificated copies of this Ordinance and the Financial Agreement to the chief financial officer of, and legal counsel for, Middlesex County, New Jersey.

Section 7. The Project shall conform with all federal, state and Borough laws, ordinances, regulations, the Redevelopment Plan and the Redevelopment Agreement relating to its construction and use.

Section 8. The Entity shall, in the operation of the Project, comply with all laws so that no person of race, religious principles, color, national origin or ancestry will be subject to discrimination.

Section 9. Without limiting the terms of the Financial Agreement, the Entity shall submit Auditor's Reports to the Borough in accordance with Article V of the Financial Agreement.

Section 10. This ordinance shall take effect in accordance with all applicable laws.

#### **ORDINANCE 2020-05**

This ordinance, the summary terms of which are included herein, was introduced for first reading at a meeting of the governing body of the Borough of Dunellen, in the County of Middlesex, State of New Jersey, on March 16, 2020. It is now being further considered for final passage, after public hearing thereon, at a meeting of the governing body being held at the Borough Council Chambers, in the Borough on April 20, 2020 at 7 o'clock p.m. During the week prior to and up to and including the date of such meeting, copies of the full bond ordinance have been available at no cost and during regular business hours at the Clerk's office for the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

AN ORDINANCE SUPPLEMENTING CHAPTER 269 OF THE MUNICIPAL CODE OF THE BOROUGH OF DUNELLEN TO DESIGNATE PARK PLACE AS A ONE-WAY STREET AND TO PERMIT ANGLED PARKING ON BOTH SIDES OF PARK PLACE IN THE BOROUGH OF DUNELLEN, COUNTY OF MIDDLESEX AND STATE OF NEW JERSEY.

**WHEREAS,** Park Place in the Borough of Dunellen is a public roadway under municipal jurisdiction, and it is one block in length, running north and south between Dunellen Avenue and First Street in the Borough; and

WHEREAS, pursuant to N.J.S.A. 39: 4-137 and N.J.S.A. 39:4-138, a municipality may, in the case of any street under municipal jurisdiction, and without the approval of the Commissioner of the Department of Transportation, make, amend, repeal and enforce ordinances designating one-way streets as well as ordinances establishing angled parking on such streets within municipal control, as it may deem necessary and proper for the good of the government, order and protection of person and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants, and as may be necessary to carry into effect the powers and duties conferred and imposed by these subtitles, or by any law; and

WHEREAS, the Borough has considered the issue of converting Park Place into a one-way street going north, as well as the separate issue of designating angled parking on both sides of Park Place; and

WHEREAS, the governing body of the Borough of Dunellen has determined that the designation of Park Place as a one-way street going north, as well as the designation of angled parking along both sides of Park Place is consistent with the current standards prescribed by the Manual on Uniform Traffic Control Devices for streets and highways; and

WHEREAS, the governing body of the Borough of Dunellen has also determined that the designation of Park Place as a one-way street going north, and separately that the designation of angled parking along both sides of Park Place to each be in the interests of safety and the expedition of traffic on the public roadways including both Park Place and surrounding roadways, and further that such designations shall not place an undue traffic burden or impact on streets in any adjoining municipality or negatively affect the flow of traffic on the State highway system;

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of Dunellen, in the County of Middlesex and State of New Jersey, as follows:

1. Chapter 269-18 of the Borough of Dunellen Municipal Code entitled "One-Way Streets" is hereby supplemented to read as follows:

2. Chapter 269-9 of the Borough of Dunellen Municipal Code entitled "Angled Parking" is hereby added and shall read as follows: Angled parking is hereby permitted on Park Place in all spots so designated on both sides of the street.

- 3. Should any provisions of this ordinance be inconsistent with the provisions of any prior ordinances, the inconsistent provisions of such prior ordinances are hereby repealed, but only to the extent of the inconsistencies.
- 4. In the event that any provision of this ordinance is declared invalid by a court of competent jurisdiction, such declaration of invalidity shall not affect any other provision or application of this ordinance which may be given effect, and, to realize this intent, the provisions and applications of this ordinance are declared to be severable.
- 5. This ordinance shall be effective immediately upon final adoption, approval and publication in accordance with law.

At this point, Mayor Cilento opened the meeting for public comment on this ordinance. No one from the public spoke. This portion was closed.

Dr. Dunne asked when this ordinance will go into effect? Dr. Robins responded that it is effective immediately. She then asked when striping would occur. Dr. Robins replied that the contract would need to be awarded, but we could act on that now.

CALENDAR YEAR 2020
ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS
AND TO ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS**, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the two succeeding years; and,

**WHEREAS**, the Mayor and Borough Council of the Borough of Dunellen, in the County of Middlesex, New Jersey, finds it advisable and necessary to increase its CY 2020 budget by up to 3.5 % over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Mayor and Borough Council hereby determines that a 1.0 % increase in the budget for said year, amounting to \$55,593.84 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary.

**WHEREAS**, the Mayor and Borough Council herby determines that any amount authorized herein above that is not appropriated as part of the final budget shall be retained as an exception to the final appropriation in either of the next two succeeding years.

At this point, Mayor Cilento asked that we have a moment of silence for those impacted by the COVID-19.

Reports:

Mayor Cilento: Good evening everyone, thanks for joining us this evening for this virtual Council meeting. Before we go on to tonight's council reports, I would like to make my Mayor's Report. I want to take this moment to recognize a few people and agencies who have been vital throughout this entire crisis. First and foremost, our emergency services who are at the frontline of this COVID-19 pandemic. We extend our gratitude to the Dunellen Rescue Squad who is on call 24/7 during this crisis and has been doing an exceptional job under unprecedented circumstances. We extend our thanks to the Dunellen Fire Department and Police Department for their service and protection. I would like to extend appreciation to the Dunellen Office of Emergency Management and its coordinator, Homer Mosley and his team of volunteers. I believe Homer has been doing a great job for only having been OEM Coordinator for two months before COVID-19 hit us. I applaud his patience and willingness to learn and execute on the job. A big thank you should be given to Alex Miller, our Recreation Director and Senior Coordinator, who since day one has been by my side to ensure we continue to provide services to Dunellen's most vulnerable: our senior citizens and disabled individuals, and later in my report you will hear how he has stepped up once again. A thanks should be given to our borough administration under the management of Bill Robins, our Clerk's Office, Tax Office, Court, Construction/Zoning and DPW, all of whom have been working remotely and on alternating schedules to ensure government still functions the best it can under these circumstances. I also extend thanks to each of the council members who have stepped up to the plate to assist throughout this pandemic, whether it be volunteering to drop off groceries to seniors, assisting the various emergency service agencies you are liaisons to, helping me with scientific information, or starting volunteer initiatives around town, all while making sure committee assignments are getting done or answering constituents questions and concerns; we have all pulled together as team for the betterment of our constituents and community. Thank you for that.

We should also recognize all the nurses, doctors, and healthcare workers who are fighting COVID-19 every day. We thank you, as well as essential workers who are helping make the world go around for all of us. We should also recognize our teachers and school administration, who had to quickly adjust to a remote learning system, adapting at a very rapid rate to ensure our students not only in Dunellen, but across the state receive the education they so rightfully deserve. Another recognition I would like to give is to the Dunellen School District who assisted the Borough on IT matters during this crisis, including this meeting this evening. We thank them for helping us in this area. We also thank the local businesses who gave us PPE equipment and cash donations. They

include Ray's Pharmacy, Gentle Family Dentistry, WeatherTek, Ponti's Petals, and Lowder Electric and Construction. We thank the residents for practicing social distancing.

#### **Confirmed COVID-19 Cases in Dunellen:**

To date, there have been 86 confirmed cases of COVID-19 in Dunellen. Middlesex County Public Health Department is the lead Agency in all investigations regarding confirmed COVID-19 cases, including all close contacts. If it is determined that a member of the community has been in close contact with any individual who has tested positive for COVID-19, the County will reach out to the individual(s).

Please note that the State of New Jersey is not currently releasing recovery data, and therefore, neither is the Middlesex County Public Health Department. Middlesex County will be reconciling the cases recorded so the number of confirmed cases in Dunellen may change. Furthermore, the Middlesex County Public Health Department has confirmed that they will be releasing confirmed deaths this week to municipalities. However, as a community we have become aware recently through social media posts and through communication with neighbors, that there have been death(s) possibly related to COVID-19. We extend our deepest condolences to these families.

Middlesex County officials, in partnership with the New Jersey Motor Vehicle Commission, have been operating drive-through COVID-19 testing for Middlesex County residents. These sites are in South Brunswick and Edison. Those wishing to be tested will be required to make an appointment and meet a set of criteria. For more information, go middlesexcountyni.gov/COVID19testing to register and receive a time to report to the testing site. If a resident wishing to be tested does not have access to the Internet or has connectivity problems, he is instructed to call 732-745-3100 to make an appointment.

My office will continue to be in contact with the Middlesex County Public Health Department and will share whatever information is permitted by law. If residents should have questions regarding COVID-19, they are encouraged to call the NJ State Health Call Center at 1-800-222-1222 or you may call the Middlesex County Health Department 24/7 at (732) 745-3100. You may also visit the New Jersey COVID-19 Information Hub at: www.covid19.nj.gov.

Also, during this time of emotional and yes, physical crisis, I remind you that your family, friends and neighbors are also frightened and confused. Keep an eye out for them; call them regularly by telephone or Skype or Facebook; let them know that if they are in trouble, to let you know and you can make a call. You can also reach the crisis text line by texting "NJ" to 741741; call the family helpline at 1-800-843-5437; the domestic violence hotline at 1-800-572-7233; or the mental health line at 1-866-202-4357. We encourage you to utilize these resources during this challenging time. You matter, and we want you to be safe. Also, join the Dunellen Municipal Alliance for their "It's ok to not be okay" virtual town hall on April 30<sup>th</sup>. More information can be found on their Facebook page.

Today I was on a conference call with Senator Corey Booker. It was noted that the PPP program under the last stimulus bill was exhausted quickly. The new bill being negotiated plans to have up to \$250 billion in stimulus and about \$50 billion directly allocated to small businesses.

I encourage small businesses and non-profits in Dunellen that once the bill is passed and these funds are available to please go to your bank and apply immediately as these funds will go quickly but will be available to smaller businesses. The last round of stimulus did not make it directly to smaller businesses and were instead eaten up by bigger businesses, mainly due to the banks not being prepared for SBA lending at the time. So, this is a glimmer of light, that money will be available to the small business owner. It was also noted that there may be another bill in the coming weeks that will provide funding to state and local governments. So, fingers crossed on relief coming to the towns soon.

#### Dunellen Updates:

Borough Directives During COVID-19:

- Municipal buildings remain closed to the public until further notice.
- All public events and borough programs are on hold until further notice.
- Our senior bus services are still suspended.

Mr. Sigmon: 1) thanked all the emergency services people and Homer in OEM; 2) he has been in contact with the Dunellen Rescue Squad and he is very impressed with their spirit and dedication. The Squad is looking for volunteers including a driver.

Homer Mosley: 1) thanked Mayor Cilento; 2) he is working with the County OEM to stock-pile essential equipment. He found a company in Edison that can decontaminate N95 masks.

Chief Smith: thanked the front-line people for their hard work as well as the businesses who have made donations of equipment and food.

Alexander Miller: thanked everyone and especially Ray's Pharmacy which donated \$650.00 of supplies.
