WHEREAS, the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1 et seq., as amended and supplemented (the "Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment; and

WHEREAS, in accordance with the criteria set forth in the Redevelopment Law, the Borough identified and designated various property within the downtown area, including the properties identified as Block 65, Lot 1, commonly known as 501-513 North Avenue, and Block 50, Lot 2, commonly known as Bound Brook Road, as set forth on the tax maps of the Borough as an "area in need of redevelopment" (collectively, the "Redevelopment Area") and adopted a redevelopment plan for the Redevelopment Area entitled the "Amended and Restated Dunellen Downtown Redevelopment Plan Phase 1" as amended and supplemented, and as the same may be further amended and supplemented from time to time (the "Redevelopment Plan"); and

WHEREAS, the Borough has determined to act as the "redevelopment entity" for the Redevelopment Area; and

WHEREAS, the Redevelopment Law authorizes the redevelopment entity to arrange or contract for the planning, construction, or undertaking of any development project or redevelopment work in an area designated as an "area in need of redevelopment" pursuant to N.J.S.A. 40A:12A-8; and

WHEREAS, Estates of North, LLC (the "Entity") seeks to be designated as the "redeveloper" (as defined in the Redevelopment Law) of the Redevelopment Area, so as to redevelop the Redevelopment Area in accordance with the terms of the Redevelopment Plan and the Redevelopment Law; and

WHEREAS, the Borough has determined that in order to coordinate the redevelopment of the Property in the most timely and efficient manner, it is in the best interests of the Borough to designate the Entity as the conditional redeveloper (the "Conditional Redeveloper") of the Redevelopment Area, pending the negotiation and execution of, among other agreements, a redevelopment agreement (the "Redevelopment Agreement") with the Borough and satisfaction of other obligations of the Conditional Redeveloper; and

WHEREAS, the Borough desires to authorize the execution of a conditional redeveloper's agreement with the Entity (in the form attached hereto as Exhibit A, the "Conditional Redeveloper's Agreement") for the purpose of creating a framework for the negotiation and execution of a Redevelopment Agreement and to memorialize related obligations of the Conditional Redeveloper and Borough set forth therein.

NOW THEREFORE BE IT RESOLVED by the Borough Council of the Borough of Dunellen, in the County of Middlesex, New Jersey, as follows:

Section 1. The foregoing recitals are hereby incorporated by reference as if fully set forth herein.

Section 2. The Entity is hereby designated as the Conditional Redeveloper of the Property pending the execution of a Redevelopment Agreement with the Borough and satisfaction of the obligations set forth in the Conditional Redeveloper's Agreement.

Section 3. The Mayor of the Borough is hereby authorized and directed to execute the Conditional Redeveloper's Agreement, in the form attached hereto as <u>Exhibit A</u>, with such changes, omissions or amendments as the Mayor deems appropriate in consultation with the Borough's redevelopment counsel, planner and other professionals.

Section 4. This resolution shall take effect immediately.

WHEREAS, the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1 et seq., as amended and supplemented (the "Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment; and

WHEREAS, in accordance with the criteria set forth in the Redevelopment Law, the Borough identified and designated various property within the downtown area, including the properties identified as Block 70, Lots 13 and 13.01, commonly known as the South Side Train Station Parking Lot and Borough Library, as set forth on the tax maps of the Borough as an "area in need of redevelopment" (together, the "Redevelopment Area") and adopted a redevelopment plan for the Redevelopment Area entitled the "Amended and Restated Dunellen Downtown Redevelopment Plan Phase 1" as amended and supplemented, and as the same may be further amended and supplemented from time to time (the "Redevelopment Plan"); and

WHEREAS, the Borough has determined to act as the "redevelopment entity" for the Redevelopment Area; and

WHEREAS, the Redevelopment Law authorizes the redevelopment entity to arrange or contract for the planning, construction or undertaking of any development project or redevelopment work in an area designated as an "area in need of redevelopment" pursuant to N.J.S.A. 40A:12A-8; and

WHEREAS, Mas Development Group (the "Entity") seeks to be designated as the "redeveloper" (as defined in the Redevelopment Law) of the Redevelopment Area, so as to redevelop the Redevelopment Area in accordance with the terms of the Redevelopment Plan and the Redevelopment Law; and

WHEREAS, the Borough has determined that in order to coordinate the redevelopment of the Property in the most timely and efficient manner, it is in the best interests of the Borough to designate the Entity as the conditional redeveloper (the "Conditional Redeveloper") of the Redevelopment Area, pending the negotiation and execution of, among other agreements, a redevelopment agreement (the "Redevelopment Agreement") with the Borough and satisfaction of other obligations of the Conditional Redeveloper; and

WHEREAS, on March 1, 2021, the Borough adopted Resolution 03-01-2021: #5A, authorizing the Borough to enter into a conditional redeveloper's agreement with the Entity for the purpose of creating a framework for the negotiation and execution of a Redevelopment Agreement and to memorialize related obligations of the Conditional Redeveloper and Borough set forth therein; and

WHEREAS, on March 10, 2021 (the "Effective Date"), the Entity and the Borough entered into the Conditional Redeveloper's Agreement (attached hereto as <u>Exhibit A</u>, the "Conditional Redeveloper's Agreement"); and

WHEREAS, pursuant to Section 2.01(d) of the Conditional Redeveloper's Agreement, the Conditional Redeveloper had 120 days from the Effective Date to complete certain due diligence activities within the Redevelopment Area (or July 8, 2021) (the "Due Diligence Period"); and

WHEREAS, pursuant to Section 2.01(a) of the Conditional Redeveloper's Agreement, the Conditional Redeveloper had 120 days from the end of the Due Diligence Period to undertake and complete the activities set forth therein (or November 5, 2021); and

WHEREAS, the Conditional Redeveloper has been diligently performing the activities set forth in the Conditional Redeveloper's Agreement and the Parties continue to work to satisfy the conditions set forth in the Conditional Redeveloper's Agreement throughout period from the Effective Date through to the date hereof; and

WHEREAS, pursuant to the terms of the Conditional Redeveloper's Agreement, the Parties may mutually agree to extend the term of the Conditional Redeveloper's Agreement and the Conditional Redeveloper's designation as the conditional redeveloper; and

WHEREAS, the Borough and Conditional Redeveloper wish to extend the term of the Conditional Redeveloper's Agreement and the designation of the Conditional Redeveloper for an additional 180 days from the end of the original term of the Conditional Redeveloper's Agreement.

NOW THEREFORE BE IT RESOLVED by the Borough Council of the Borough of Dunellen, in the County of Middlesex, New Jersey, as follows:

Section 1. The foregoing recitals are hereby incorporated by reference as if fully set forth herein.

Section 2. The term of the Conditional Redeveloper's Agreement and the Conditional Redeveloper's designation as "conditional redeveloper" of the Redevelopment Area are each hereby extended for a period of 180 days from the end of the original term of the Conditional Redeveloper's Agreement, subject to all other terms and conditions of the Conditional Redeveloper's Agreement. All other terms and conditions of the Conditional Redeveloper's Agreement shall remain unchanged and in full force and effect.

Section 3. The Mayor of the Borough is hereby authorized and directed to enter into any written undertaking with the Conditional Redeveloper necessary to evidence the extension of term authorized hereby as the Mayor deems appropriate in consultation with the Borough's redevelopment counsel, Borough counsel and other Borough professionals.

WHEREAS, the Dunellen Fire Department has mutual aide understandings with many nearby municipalities and emergency services departments, in all three counties; and

WHEREAS, it is vital to the health, safety and welfare of the residents of Dunellen, and those residents in nearby communities with which we have mutual aid understandings, that communications equipment be modern, up-to-date and interoperable so that it can be used to connect with all partner agencies; and

WHEREAS, the current radio communication system employed by the Dunellen Fire Department has inherent weaknesses that hamper operations at the local and county level; and

WHEREAS, the Dunellen Fire Department is applying for an Assistance to Firefighters grant for a Motorola P25 compliant band system upgrade; and

WHEREAS, the Motorola P25 compliant system will allow the Fire Department's radios to operate on all bands on any of the systems of its mutual aid by providing such new equipment as all band radios for each apparatus riding position, new all band mobile radios for each apparatus, a new all band base radio system for the Communications Center, new repeaters for local operations and new pagers to dispatch firefighters when needed for emergencies.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Dunellen, that the Dunellen Governing Body heartily endorses the Dunellen Fire Department's application for an Assistance to Firefighters grant to obtain a new radio system.

Mr. VanDermark expressed some concerns regarding the Fire Department's discussions with other agencies for the use of loaner trucks and the system of approvals for such. Mayor Cilento commented that these are two separate issues. The present resolution is for a Council endorsement of the application for equipment. Mrs. Burke noted that during the Hurricane Ida debriefing the problem of intercommunications was raised. Mayor Cilento responded that this grant for radios would serve to alleviate that.

He is working with SHI (hardware vendor) on the Microsoft licenses; 2) thanked the PBA for the Polar Express; thanked the Police Department for working with the School District on alternate routes to schools during road work; 3) the Police Department is working to solicit on-call community members to work with their Domestic Violence Response Team. The requirements include a background check and several hours of training. If you have any questions, you can reach out to Lt. Beenders; 4) she noted that there are currently three police vehicles out of service while they are being worked on. Our newly purchased car is being outfitted. This means that we have multiple cars not in service and this puts a strain on other vehicles.

Dr. Dunne: 1) there was a Finance Committee meeting last week and she spoke with Chief Smith today regarding the vehicle situation; 2) the Finance Committee is reaching out to department heads regarding capital needs; 3) she asked about extending the forgiveness of Construction Office permit fees. She asked the Council for their thoughts. The consensus was that it should be extended until March 31, 2022, with Scott Luthman using his professional judgment; 4) the next Parking Authority meeting will be Wednesday at 6:00 pm; 5) last week she and Mr. Pinder attended the Green Brook Flood Control Commission meeting. They are planning for a February/March public meeting. Letters may have been distributed to residents requesting right of entry. Ray Murray will send the list to Dr. Robins; 6) the Diversity and Inclusion Committee are developing a Survey which is under review; 7) noted that many municipalities are developing their policies and procedures regarding cannabis, and this is something for us to keep an eye on. Mr. Sigmon: 1) the 39th Annual Tree Lighting Ceremony was last night and there was a large audience. The Recreation Department is grateful to all the people who made this night happen, including April Burke and Girl Scout troops 65248 and unit 62 for decorating the tree, the Imperial Brass Band, Isabel Pombrio for her singing, Mike Luthman, Ken Baudendistel, the Dunellen-Green Brook Rotary Club, and our emergency agencies including the CERT Team, and Alex Miller as MC; 2) the Holiday House Decorating Contest is from December 16—21, and you must register by December 14th; 3) asked if we could waive the charge for Gold Star families for the Hometown Heroes program? Mr. Miller will bring the suggestion to the Recreation Commission. Mr. Pinder: 1) the Board of Education meeting will be on December 16th at 7:00 pm and on YouTube; 2) DPW report:

DPW crew has been maintaining daily cleaning of the downtown and all our Borough Properties & Parks.

Along with the following:

- Took down our Hometown Heroes Banners and put up the wreaths throughout the downtown area.
- Put up the Christmas Trees @ Washington Memorial Park and Columbia Park and installed all the holiday decorations @ Washington Memorial Park.
- Leaf Bag pick-up throughout the town and leaf clean up in the parks. ** Reminder leaf bag pick up goes through December**
- After Christmas we will be picking up Christmas trees; please remember to remove all lights and ornaments and do not have the tree in a tree bag.

Winter is here: Snow Reminder about Parking Restrictions During Snow Emergencies In order to permit snowplows to operate freely and unimpeded for the purpose of keeping the Borough streets and highways open for essential and emergency functions, during the period of time commencing one hour after snow has been continuously falling and ending 12 hours after snow ceases to fall, no person shall park, stop, stand or leave abandoned a vehicle on any streets within the Borough of Dunellen.

In numbers these statistics are: adults with at least one dose totals 5,106; adults with dose 1 of a 2 dose course totals 4,706; adult population with Dose 2 totals 4,180; adult population with Janssen totals 400; the overall totals administered for adults is 9,286. There have been 629 booster

(3rd dose) shots administered in Dunellen which equals 22% of the 2,840 eligible population. Taking into the consideration of vaccines administered to Dunellen's overall population ages 5+ we have 65% of residents with the course completed and 9% of the 5+ population that have begun the course.

Capital Improvements:

Paving for the Middlesex County Mill & Pave Project was completed on Friday, December 3rd. Line striping started on Saturday, December 4th and could be completed on Wednesday December 8th, weather permitting.

NJAW - the 2022 Water Main project is slated to start this winter (estimated to begin as soon as January). NJAW will be replacing water mains, installing new water services to homes, installing new hydrants, and paving the following streets:

- · Madison Avenue and Washington Avenue (from First Street to Mountainview Terrace)
- · Mountainview Terrace (from Lincoln Ave to the 200 block)
- Fourth Street (from Third Street to the 200 block)
- · Third Street (from Sanford Avenue to Washington Avenue)
- · North Ave Extension & Pulaski Street (from North Ave to Railroad embankment)
- · All of Lincoln Avenue will have NJAW work completed, however, this road will be milled and paved with additional improvements due to the NJDOT grant funds awarded to Dunellen

Extension of time request for Lincoln Avenue is being processed by the NJDOT. This will allow for the completion of the water main improvements prior to paving the roadway.

Kline Place NJDOT project is anticipated for 2022; we are waiting on the plans from CME Engineers. With this project we will be adding storm drain catch basins to this street, sump pump tie into the storm drains, and Mill & Pave the Street.

PSE&G will also be upgrading gas mains in town; we are waiting on their street list, so this information will be forthcoming.

Contractor for the South Madison Avenue improvements is investigating the issues with the operation of the flashing signs at the Walnut Street intersection, as they appear to have not been working.

Dunellen Station Development:

Work associated with the Dunellen Station Redevelopment Project continues. The North Washington Pump Station improvements as well as the Prism and K Hovnanian site improvements are all underway. The roadways in the Prism portion of the development may be base paved this year, weather permitting.

Council Discussion

The Council discussed the Dunellen Citizen of the Year Award and the Lifetime Achievement Award. Various persons were nominated, and it was decided that Diana Starace would be honored as Citizen of the Year and former mayor John Gibney with the Lifetime Achievement Award.

Public Comment

Terri Albertson, 412 New Market Road, in regard to a recent incident that happened to her next-door neighbor, expressed concern about the long time it took for a Rescue Squad ambulance or other agency ambulance to arrive. Dispatch contacted 6-8 agencies and it took over thirty minutes for an ambulance to come.
