Mayor Robert J. Seader called the meeting to order at 7:00 p.m. and he led the Pledge of Allegiance.

NOTICE OF PENDING BOND ORDINANCE AND SUMMARY

The bond ordinance, the summary terms of which are included herein, was introduced for first reading at a meeting of the governing body of the Borough of Dunellen, in the County of Middlesex, State of New Jersey, on June 18, 2018. It is now being further considered for final passage, after public hearing thereon, at a meeting of the governing body being held at the Dunellen Council Chambers, in the Borough on July 2, 2018 at 7 o'clock p.m. During the week prior to and up to and including the date of such meeting, copies of the full bond ordinance have been available at no cost and during regular business hours at the Clerk's office for the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

Title: "BOND ORDINANCE PROVIDING FOR SEWER CAPITAL REPAIRS IN AND BY THE BOROUGH OF DUNELLEN, IN THE COUNTY OF MIDDLESEX, NEW JERSEY, APPROPRIATING \$250,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$237,500 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF"

Purpose: Various sewer capital repairs to the sewer utility throughout the Borough, including but not limited to, on South Washington Avenue and Orange Street, including all work and materials necessary therefor and incidental thereto.

Appropriation: \$250,000
Bonds/Notes Authorized: \$237,500
Grants Appropriated: N/A
Section 20 Costs: \$25,000
Useful Life: 40 years

Reports:

Mr. Petracca: no report.

Mr. Baudendistel: 1) discussed the sponsorship of the park signs. He has received so far three responses: Avellino's for Washington Park, Ray's Pharmacy for Gavornik Park, and Weather-Tek for the Maurer House. He wondered if the borough might want to purchase the sign for Morecraft Park, in case he does not find a sponsor? John Gibney would work with us on the price. Ken could have John start making the signs now and we could settle the sponsors issue later; 2) he exchanged emails with John Bruder and at this point we are not likely to get additional funds to clean up the Strip Joint property so Mr. Bruder is considering putting together a document leading to selling the property; 3) the tunnel under the train tracks was reported as peeling but by time of tonight's meeting it had already been cleaned and repainted by NJ Transit; 4) he talked with John Bruder about the sign ordinance which should be discussed at a future Council meeting.

Mr. Bayer: no report.

Dr. Dunne: 1) there have been resident questions about redevelopment. "A handful of residents have expressed [to her] their concern about the lack of proper responses." An example is the plan to eliminate the feral cats and rats on the redevelopment property. Mayor Seader responded that that issue has been addressed at both the Planning Board presentation meetings. There were only a handful of people at those meetings and none brought that question up so he did. Mr. Robins related the substance of conversations that he has had with both the property owner, Richard Brudner, and his selected demolition company and the vermin eradication will be done by a licensed extermination company with a full report and a "certificate of abasement" being made to the Construction Office. Mr. Robins also has been speaking with Highground, the demolition company, and is preparing a summary of the demolition process. Dr. Dunne asked about a possible FAQ on redevelopment. Mr. Baudendistel said he would work with others on such a FAQ. Dr. Dunne will forward questions she has received. Mr. Bayer asked about the minutes of Planning Board Meetings. Mr. Robins responded that he posts on their web page whatever they send to him, but they have not been sending the minutes.

Mr. Cilento: 1) 24 kids registered for Recreation Summer Camp; 2) Summer Travel Baseball is underway; 3) August 7th is National Night Out, Columbia Park, 5:30 pm; 4) Dunellen Arts and Culture Commission has 15 kids signed up for their Summer Arts program. A resident wishes to donate, anonymously, \$100.00 to sponsor a child for this camp; 5) there will be a theatre bus trip on Sunday, July 22nd; 6) *Dunellen Report* articles due by September 1st; 7) Music in the Park begins on July 25th, free concerts in Washington Memorial Park.

Mr. Lowder: 1) parking lot lights in Columbia Park have been replaced with LEDs and two more lights were added to the path leading up to the Grand Stand/Stadium; 2) lights behind the Fire House have also been replaced; 3) reported on the fire the prior night at 139 South Washington Avenue. One member was sent to the hospital for heat exhaustion. All Dunellen Fire turned out and also trucks from Middlesex, Green Brook, South Plainfield and Piscataway; 4) DPW filled some of the potholes at the Fire House.

Mayor Seader: 1) He and Chief Nelson met with School Superintendent Gene Mosley about the District's request to add a police officer as a School Resource Officer. They covered topics such as how to enact an SRO in light of the terms of the PBA contract. Mr. Baudendistel asked if

such a request was as a result of recent school shootings? Mayor Seader noted that there is a concern among parents and District personnel. The District wants a full-time person and they prefer an active police officer instead of a retired police officer.

At this point, Julie Grof from the Dunellen Arts and Culture Commission made a presentation on the results of the recent Survey that DACC conducted titled: "2017 Dunellen Community Survey: A Snapshot in Time." The Survey results can be found on the DACC page of the Dunellen website:

Survey Design

On behalf of the Dunellen Arts and Culture Commission, Julie Grof and Autumn Barbato created the **2017 DUNELLEN Community Survey** to capture meaningful data for **three main purposes**:

- Gather general information about community members' perspectives on arts and culture in our community;
- Capture preferences and interests in activities, events and programs; and
- Collect data to help DACC meet the needs of potential patrons and audiences.

Input which influenced the final survey questions was collected from DACC commissioners, the Honorable Mayor Seader, Councilman Jason Cilento, former Councilman Kevin Bachorik and a select group of "test" survey takers.

Ms. Grof is a licensed planner and a member of DACC. Her presentation covered survey design, distribution and outcomes from the survey. Her presentation also covered the major parts of the survey which included:

1. Who were the respondents
2. When did they visit Downtown Dunellen
3. The demand for retailers and services
4. Amenities
5. What attracts you to Dunellen
6. Lifestyle influences
7. Activities
8. Causes to attend arts and cultural activities more often
9. Communication
10. What to invest in financially
11. Forms of transportation
12. A little bit about the respondents themselves
13. Most frequented services and retailers

14. Favorite destinations for date night or family entertainment
15. Recommendations
16. Demographic picture
17. DACC goals for 2018 and 2019
18. Arts and culture assets inventory

The Survey found that arts and culture were very important to the residents of Dunellen and that they provided an opportunity for volunteerism.

Mayor Seader thanked Julie and DACC for the comprehensiveness of the Survey and noted the tremendous amount of time that obviously went in to its compilation and analysis.
