PROCLAMATION

Supporting the Click It or Ticket Mobilization of May 21 – June 3, 2018

WHEREAS, there were 626 motor vehicle fatalities in New Jersey in 2017; and

WHEREAS, a large percentage of the motor vehicle occupants killed in traffic crashes were not wearing a seat belt; and

WHEREAS, use of a seat belt remains the most effective way to avoid death or serious injury in a motor vehicle crash; and

WHEREAS, the National Highway Traffic Safety Administration estimates that 135,000 lives were saved by safety belt usage nationally between 1975-2000; and

WHEREAS, the State of New Jersey will participate in the nationwide *Click It or Ticket* seat belt mobilization from May 21 – June 3, 2018 in an effort to raise awareness and increase seat belt usage through a combination of enforcement and education; and

WHEREAS, the Division of Highway Traffic Safety has set a goal of increasing the seat belt usage rate in the state from the current level of 94% to 95.5%; and

WHEREAS, a further increase in seat belt usage in New Jersey will save lives on our roadways;

NOW THEREFORE BE IT RESOLVED that the Mayor and Council of the Borough of Dunellen declare their support for the *Click It or Ticket* seat belt mobilization both locally and nationally from May 21 – June 3, 2018 and pledge to increase awareness of the mobilization and the benefits of seat belt use.

ORDINANCE 2018-04

The following Amendment to Section 7.2, Relationship of the Plan to the Borough Land Development (Zoning) Regulations of Dunellen's Redevelopment Plan is being Introduced for first reading on May 21, 2018. It will be presented for Public Hearing and Adoption on June 4, 2018 at 7:00 p.m. in the Dunellen Borough Municipal Building, 355 North Avenue, Dunellen, New Jersey, or at an appropriate time thereafter subject to Dunellen Planning Board review. Notice will be given in advance of the date for the Public Hearing and Adoption. Copies of this ordinance will be posted on the Municipal Bulletin Board, and will be available at the Office of the Borough Clerk for any interested members of the public.

This ordinance amends the Dunellen Downtown Redevelopment Plan, Phase One, that was adopted in February 2003 and revised on July 12, 2004, with further Amendments in June 2011, August 2013, November 2014, February 2016, and November 2017.

7.2 Relationship of Plan to the Borough Land Development (Zoning) Regulations

The land use controls and building restrictions set forth in this Redevelopment Plan shall apply to all new development within the Redevelopment Area and shall supersede any requirements set forth in the Borough of Dunellen Zoning Ordinance. All existing uses will be permitted to remain in the Redevelopment Area; however, any change in use or major alterations to any building or structures will be required to meet the land use and building requirements contained in this Redevelopment Plan. All the redevelopment regulations not addressed herein shall

remain applicable. It is recognized that all development is contingent upon all necessary state, county and local approvals.

Site plan approval from the Borough's Planning Board in accordance with the Municipal Land Use Law ("MLUL") shall be required for all development within the Redevelopment Area, together with any other local approvals that may be required under a Redevelopment Agreement, which shall also be required. The Planning Board shall have the authority to grant variances that would be considered (c) variances under the Municipal Land Use Law and design waivers during the site plan approval process.

Further, the Planning Board, which is a consolidated board pursuant to N.J.S.A. 40:55D-25(c), shall also have the authority to grant certain variances which are considered to be (d) variances under the MLUL, provided, however, that the power of the Planning Board to grant such variances shall be limited and restricted to those enumerated in N.J.S.A. 40:55D-70(d) 3, 4, 5 and 6.

Moreover, those (d) variances enumerated in N.J.S.A. 40:55D-70 (d)(1) and (2) shall not be within the jurisdiction of the Planning Board to grant but, rather, any such proposed variance under the aforesaid subsections (1) and (2) shall require an amendment to this Redevelopment Plan by ordinance in accordance with the local redevelopment and housing law.

NOW THEREFORE, BE IT ORDAINED by the Council of the Borough of Dunellen, County of Middlesex, State of New Jersey, as follows:

- 1. The foregoing recitals are incorporated herein by reference as if fully set forth at length; and
- 2. The Redevelopment Plan is hereby amended to include an amended Section 7.2; and
- 3. This Ordinance shall take effect in accordance with applicable law following final adoption and publication thereof.

ORDINANCE 2018-03

BOROUGH OF DUNELLEN COUNTY OF MIDDLESEX, NEW JERSEY

AN ORDINANCE TO VACATE A PORTION OF SOUTH AVENUE AND TO RELEASE AND EXTINGUISH THE PUBLIC RIGHTS EXISTING THEREIN

The following ordinance was Introduced for first reading on May 7, 2018. A public hearing and adoption is now being held at 7:00 p.m. in the Dunellen Borough Municipal Building, 355 North Avenue, Dunellen, New Jersey on the 21st day of May, 2018. Copies of this Ordinance have been posted on the public bulletin board prior to the date for second reading and final passage and copies of this Ordinance have been available at the Office of the Borough Clerk for any interested members of the public.

- **WHEREAS**, a portion of South Avenue is a street in the Borough of Dunellen, County of Middlesex, State of New Jersey; and
- **WHEREAS**, said portion of South Avenue is adjacent to Block 85, Lots 1 and 2 on the Official Tax Map of the Borough of Dunellen; and
- **WHEREAS**, Block 85, Lots 1 and 2 are part of the Redevelopment Area included in the Amended and Restated Dunellen Downtown Redevelopment Plan; and
- **WHEREAS**, the designated Redeveloper has made application to the Mayor and Council of the Borough of Dunellen, for the vacation of the hereinafter described portion of South Avenue: and
- **WHEREAS**, N.J.S.A. 40:67-1(b) authorizes the governing body of every municipality to adopt an ordinance to vacate any public street or any part thereof; and
- **WHEREAS**, pursuant to N.J.S.A. 40:49-6 a municipality must publish ordinances that authorize vacations of land in the manner required by N.J.S.A. 40:49-2, except that every such ordinance, after being introduced and having passed a first reading, shall be published at least once not less than ten (10) days instead of one week prior to the time fixed for further consideration for final passage, and, at least one week prior to the time fixed for final passage, a copy of such ordinance, together with a notice of the introduction thereof and the time and place when and where the ordinance shall be considered for final passage shall be mailed to every person whose lands may be affected by the ordinance; and
- **WHEREAS**, the Borough Council of the Borough of Dunellen has determined that it would fulfill a public purpose to vacate a portion of South Avenue (as more fully described on Exhibit A, attached hereto and made a part hereof) as same is not needed nor used as a public street.

NOW THEREFORE, BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF DUNELLEN, NEW JERSEY AS FOLLOWS:

- Section 1. The Recitals are incorporated by reference as if set forth in full.
- Section 2. That a portion of South Avenue, as more fully described in <u>Exhibit A</u>, attached hereto and made a part hereof, be and hereby is vacated and the public rights therein be and hereby are released and extinguished.
- Section 3. The Clerk and Mayor of the Borough are hereby authorized and directed to execute any documents which may be required to effectuate said vacation.
- Section 4. That the Borough of Dunellen, pursuant to the provisions of <u>N.J.S.A.</u> 40:67-1(b), hereby expressly reserves and excepts from vacation all rights and privileges currently possessed by public utilities (as defined in N.J.S.A. 48:2-13) and by any cable

television company (as defined in N.J.S.A. 48:5-1, et seq.), to maintain, repair and replace their existing facilities, in, adjacent to, over or under the street, or any part thereof, to be vacated.

- Section 5. The Clerk shall publish this Ordinance in the manner provided for in N.J.S.A. 40:49-6.
- Section 6. Within thirty (30) days after this Ordinance becomes effective, the Clerk shall file a certified copy thereof, together with proof of publication thereof, in the office of the Middlesex County Clerk to be recorded in a book with property index to be provided for this purpose entitled "Vacations", in accordance with the provisions of N.J.S.A. 40:67-21.
- Section 7. If any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudicated by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause, or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.
- Section 8. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.
 - Section 9. This ordinance shall take effect in accordance with all applicable laws.

Mr. Bayer: 1) DPW have been focusing on filling potholes along the Memorial Day Parade route; 2) Nature's Choice, which is contracted to remove the brush from the Yard, has no room in their dumps so they are enforcing the 5-caliper rule. We could bring in a tub grinder and reduce the pile (at a cost) and then there would also be a removal fee. Fanwood did something like this, at \$5,000 per day. Various options were discussed including selling the resulting mulch.

Dr. Dunne: 1) from the School District: the National Arts Honor Society Induction is the following night and the High School Middle School Band Concert is Wednesday night. Mr. Cilento: 1) Recreation/Memorial Day Parade is on May 28th at 10:00 am and starts at the Library; 2) please submit what you have for *The Dunellen Report*; 3) informed the Council on

the meeting held earlier today with the representatives from the North Jersey Transit Hub project. Himself, Ken Baudendistel, Dr. Robins, and Julie Grof. They just wanted to get to know us and the borough and they will be putting together a plan that will be presented to the Council; 4) DACC is working on the rail decoration project on Prospect Avenue. Mayor Seader: 1) Memorial Day Parade looks like it will be well attended with marchers; 2) the redevelopers came before the Planning Board and will need at least one more meeting to complete their presentation.

Mr. Bruder: noted that Governor Murphy was moving ahead on his plans to legalize marijuana and many municipalities are taking action in opposition, mostly through resolutions that are being sent to Trenton as messages that they are against the use of recreational marijuana. He asked the Council if they wished him to put together a resolution that could be circulated and then Council could decide if they wanted it to be placed on the Agenda. A second action municipalities are taking is the adoption of ordinances making it unlawful to engage in the recreational use of marijuana. Municipalities are trying to get these in place before the Governor takes any action to legalize it. It may or may not "grandfather" it but a lot of municipalities are going that route. He continued that though state statutes do supersede local ordinances, there are a number of circumstances in which the state statute does permit such a "grandfathering." The resolution would be a statement of opposition to recreational marijuana and the ordinance would ban the use or sale of recreational marijuana. Medicinal use would still be permitted. The ordinance would state that we do not want it in certain areas such as near schools or churches. Mr. Baudendistel asked if there have been problems in states that have legalized it. Mr. Bruder responded that there have been problems such as an increase in DWIs. Mr. Petracca noted that stores that sell marijuana largely deal in cash which could lead to the potential for crimes. Mayor Seader noted that Chief Nelson is against it because there is no machine that accurately measures how high a person is. Mr. Bruder responded that the Chief is partly correct. Marijuana has a half-life of 28 days so the argument could go that it is impossible to determine when ingestion occurred. But this is where Drug Recognition Experts come in where they run a battery of tests on an individual and based on those tests they call whether a person is under the influence of a controlled dangerous substance. Mr. Baudendistel raised the issue of whether marijuana sales might or might not be beneficial to our downtown businesses. Others wished to have more facts and data upon which to base their decisions. Mayor Seader stated that sometimes you have to vote your conscience on an issue. Mr. Bruder read some statistics gathered from Colorado: marijuana traffic deaths have more than doubled from 55 deaths to 125 deaths; Colorado's marijuana youth rate is the highest in the nation; drug related student expulsions increased by 32%; college use rate is considerably higher than the national average; college students with access to marijuana get lower grades than those without; in 2013, 48% of adult arrestees tested positive for marijuana; 35% increase in marijuana related Emergency Room visits; and black-market sales of marijuana have increased rather than decreased since legalization. Mr. Bruder will put together a resolution for Council consideration.
