Minutes of the public meeting of the Mayor and Council of the Borough of Dunellen held on November 18, 2019.

Mayor Robert J. Seader called the meeting to order at 7:00 p.m. and he led the Pledge of Allegiance.

Municipal Clerk William Robins read the Sunshine Statement and called the Roll.

RESOLUTION OF THE BOROUGH OF DUNELLEN, COUNTY OF MIDDLESEX AND STATE OF NEW JERSEY, AUTHORIZING THE DUNELLEN BOROUGH PLANNING BOARD TO UNDERTAKE A PRELIMINARY INVESTIGATION TO DETERMINE WHETHER BLOCK 85, LOT 2 QUALIFIES FOR DESIGNATION AS AN AREA IN NEED OF NON-CONDEMNATION REDEVELOPMENT PURSUANT TO N.J.S.A. 40A:12A-1 ET SEQ.

WHEREAS, the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1 *et seq.* (the "Redevelopment Law"), provides a mechanism to empower and assist local governments in efforts to promote programs of redevelopment; and

WHEREAS, on or about May 5, 2003, the Council of the Borough of Dunellen (the "Borough Council") determined by resolution that certain properties in the Borough's downtown area constituted an area in need of redevelopment (the "Downtown Redevelopment Area"); and

WHEREAS, while the Borough intended to include in the Downtown Redevelopment Area that certain property identified as Block 85, Lot 2 (the "Property"), it is unclear whether such Property was properly included; and

WHEREAS, in order to perfect the designation of the Downtown Redevelopment Area to include the Property, the Borough has determined to authorize a new investigation of the Property to determine if such Property may be qualified for designation as an area in need of non-condemnation redevelopment pursuant to the Redevelopment Law; and

WHEREAS, the Local Redevelopment and Housing Law sets forth a specific procedure for establishing an area in need of redevelopment; and

WHEREAS, pursuant to *N.J.S.A.* 40A:12A-6, prior to the Borough Council making a determination as to whether the Property qualifies as an area in need of redevelopment, the Borough Council must authorize the Planning Board, by resolution, to undertake a preliminary investigation to determine whether the Property meets the criteria of an area in need of redevelopment set forth in *N.J.S.A.* 40A:12A-5; and

WHEREAS, the Borough Council desires to direct the Borough Planning Board to undertake such preliminary investigation to determine whether the Property meets the criteria for designation as an area in need of redevelopment pursuant to *N.J.S.A.* 40A:12A-5 and in accordance with the investigation and hearing process set forth at *N.J.S.A.* 40A:12A-6,

NOW, THEREFORE, BE IT RESOLVED that the Borough Council hereby directs the Dunellen Borough Planning Board to conduct the necessary investigation, to hold a public hearing and to comply with other requirements of the Redevelopment Law in order to determine whether

the Property defined hereinabove qualifies for designation as an area in need of non-condemnation redevelopment under the criteria and pursuant to the public hearing process set forth in the Redevelopment Law; and

- **BE IT FURTHER RESOLVED** that the redevelopment area determination shall further authorize the municipality to use all those powers provided by the New Jersey Legislature for use in a redevelopment area, but not to include the power of eminent domain (such designated redevelopment area referred to as a "Non-Condemnation Redevelopment Area").
- **BE IT FURTHER RESOLVED** that the Planning Board shall submit its findings and recommendations to the Borough Council in the form of a resolution with supportive documentation.
- **BE IT FURTHER RESOLVED** that a certified copy of this Resolution be forwarded to the Borough Clerk, the Borough Planning Board and the Planning Board Secretary.

Dr. Dunne asked where this parcel was located and what the resolution is intended to accomplish. Mr. Robins responded that it is uncertain whether this block and Lot was included in the 2003 designation of areas in need of redevelopment. The Lot is in the "Art Color Complex." This resolution is part of the process of making sure it is included as an area in need of redevelopment and thus subject to the Borough's redevelopment Plan.

Reports:				

Mr. Petracca: no report.

Mrs. Burke: 1) Fire Company trees will probably be available this coming weekend; 2) playground equipment should be delivered this week and construction should take about four weeks. Mr. Bayer: no report.

Dr. Dunne: 1) she thanked Bill and Lauren for launching the website. It looks great and she encourages the public to have a look; 2) she asked what the next steps will be for the School District FAQ? Mr. Robins responded that it is a Council decision and Mr. Cilento noted that it is now on the floor. Dr. Dunne continued that she and Mr. Cilento and Mrs. Narvesen met with CFO Scott Olsen and they felt it important to put out a FAQ for the residents regarding the implications of the school bond. A copy of the draft FAQ was distributed with the packets and the governing body discussed the wording of the FAQ and the intent of the December 10th referendum. There was a difference of opinion among the governing body members on how the bonds were to be paid off if the State decided not to grant the District the same level of funding. It was noted that Brian DeLucia had said during the presentation to the Council in August that there was no guarantee of continued State funding. Dr. Dunne noted that there is a misperception among the public that the Council has control over actions of the School District and School Board, and this was one of the reasons for the FAQ. She also emphasized that the FAQ is designed to inform the residents of the repercussions of limiting the Borough's ability to bond for capital projects and infrastructure improvement. Mr. Robins indicated that after Council has had a chance to review the draft FAQ and submit suggestions, he will put the FAQ onto the website, on Friday.

Mr. Cilento: 1) Congratulated Homer Mosley on his election as President of the Senior Club; 2) please submit copy for the next edition of *The Dunellen Report* by December 13th; 3) additional trains have been added on the Raritan Valley line; 4) the Dunellen Downtown Management Organization's e-newsletter, "Next Stop Dunellen," was sent to 314 people, opened by 63% of subscribers, and we have 20 new subscribers; 5) on November 15th, he and Ken Baudendistel attended a seminar on the 20th Anniversary of the Transit Village (in 2012, Dunellen was designated the 26th Transit Village); 6) he reviewed the signs for Columbia Park per the AARP grant (Councilmembers had examples in their packets). The signs discuss the project and acknowledge the contributors. He is asking for Council consent on the signs and noted that John Gibney is making the signs and donating them to the borough. Consent granted.

Mrs. Narvesen: 1) the Municipal Alliance will be meeting on November 26th at the Senior Center; 2) the School District referendum will be on December 10th; 3) DDMO is hoping to have the holiday trees installed and decorated by the end of the month; 4) the Holiday Tree Lighting will be on Sunday, December 1st, at 6:00 pm, in Washington Memorial Park.

Mayor Seader: 1) thanked Bill for receiving the grant for the Gazebo in Columbia Park and he thanked Alex Miller for overseeing its installation; 2) asked Ron Safar about the trees in Columbia Park that were cut down? Ron replied that two trees near the Gazebo were dead and might fall on the new construct and there were three dead trees in the playground area.

PUBLIC PORTION

Homer Mosley, 113 Pearl Place, asked a question about the School Board and its ability to act independently from the borough. Mayor Seader explained that regarding the referendum, the District can take from the borough's borrowing power. They do not take money from us; rather, it is like they have access to our credit line. Mr. Mosley asked what if the citizenry has a different opinion? Mayor Seader recommended attending a Board of Education meeting. Mr. Mosley's

concern is a sudden large increase in property taxes. Mr. Petracca acknowledged that this is a possibility and referred to the uncertainty of State funding at present levels.

Jeff Best, 401 Madison Avenue, asked if the School District budget is on our municipal website? The municipal website has a link to the District website.
