**GUEST SPEAKERS** – County Commissioners Bohm and Vandenbossche were present to review information pertaining to the 26 & 32 mile road corridor expansion possibilities in relation to sewer and water availability from the surrounding municipalities. They will be returning at a later date to discuss possibilities.
