### PLAN REVIEW REQUIRED

Plans must be submitted with an application for plan examination before a permit can be issued, except as listed below.

#### Plans are not required for the following:

- 1: When the electrical system rating does not exceed 400 amps and the building is not over 3,500 square feet in area.
- 2: Work completed by a governmental subdivision or state agency costing less than \$15,000.00

**Plans are required** for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear that architect's or engineer's seal and signature.

**MOBILE HOME UNIT SITE:** When installing a site service in a park, the permit application must include the application fee, plus the number of park sites. When setting a HUD mobile home in a park, a permit must include the application fee and a feeder. A licensed electrical contractor shall do this. When setting a HUD mobile home or pre-manufactured home on private property, a permit must include the application fee, service and feeder.

**Expiration of Permit –** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.**

Electrical work shall not be started until the application for a permit has been filed with the Charter Township of East China. All installations shall be in conformance with the State Electrical Code. **No work shall be concealed until it has been inspected.**

When **ready for an inspection**, call the Township Office at **810-765-8879, Ext. 123**. Please provide as much advance notice as possible. **Always provide the job location and permit number.**

**EXPIRATION OF PERMIT**

A permit remains valid as long as work is progressing and inspections are conducted. A permit shall become invalid if the authorized work is not commenced within six (6) months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six (6) months after the time of commencing the work. A permit will be cancelled when no inspections are required or conducted within six (6) months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.
