**Plans must be submitted with an Application for Plan Examination before a permit can be issued, except as listed below:**

**Plans are not required for the following:**

1. One and two family dwellings containing not more than 3,500 square feet of building area.
  2. Alterations and repair work determined by the plumbing inspector to be of a minor nature.
  3. Buildings with a required plumbing fixture count of less than 12.
  4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00
- If work being performed is described above, a Plan Review is not required.

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA 299 and shall bear the architects or engineers seal and signature.

**Mobile Home Unit Site:** When item is used for sewer excavations in a new park, the permit application fee plus the number of unit sites. When setting a mobile home in a park, or a modular home on private property, a permit shall include the application fee, a sewer or building drain and a water service or water distribution pipe.

**Expiration of Permit:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. **A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OF A PREVIOUS INSPECTION. CLOSED PERMITS CANNOT BE REFUNDED OR REINSTATED.**

Plumbing work shall not be started until the application for a permit has been filed with the Charter Township of East China. All installations shall be in conformance with the State Plumbing Code. <b>No work shall be concealed until it has been inspected.</b>	
When <b>ready for an inspection</b> , call the Township Office at <b>810-765-8879, Ext. 116</b> . Please provide as much advance notice as possible. <b>Always provide the job location and permit number.</b>	
<b>EXPIRATION OF PERMIT</b>	
A permit remains valid as long as work is progressing and inspections are conducted. A permit shall become invalid if the authorized work is not commenced within six (6) months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six (6) months after the time of commencing the work. A permit will be cancelled when no inspections are required or conducted within six (6) months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.
