Listed below are the Charter Township of East China appointed Board, Commission and Committee positions, with a brief description of the duties and responsibilities of each. Most positions require members to be residents of East China Township. Some positions have other criteria. Contact the East China Township Clerk's office with questions regarding vacancies and criteria for appointment.

BOARD OF REVIEW (2-year term)

Three members. Reviews tax assessment appeals.

CEMETERY COMMITTEE (3-year term)

Three members. Will make recommendations to the East China Township Board of Trustees regarding cemetery maintenance and upkeep, cemetery expansions, rules and regulations, financing and similar matters.

CONSTRUCTION BOARD OF APPEALS (3-year term)

Three members. Hears any appeals arising from the Township's enforcement of the building code.

FIRE AUTHORITY BOARD (MARINE CITY AREA, ST. CLAIR AREA) (5-year term)

Two members to each Authority. Provide financial oversight to the Fire Authority.

HISTORICAL COMMISSION (3-year term)

Seven members (one member must be from the Township Board of Trustees, and there must be an alternate appointed from the Township Board of Trustees). Promotes and preserves East China Township historical assets / history.

PLANNING COMMISSION (3-year term)

Seven members (one member must be from the Township Board of Trustees). Acts as an advisory group to the Township Board of Trustees on issues and policies related to planning, land use regulation, and community development.

ST. CLAIR RIVER SEWER & WATER AUTHORITY (SCRSWA) COMMISSION (5-year terms)

Four members (one member from China Township = five total). Provide budgetary and administrative oversight to the Water Plant and Wastewater Plant operations.

ZONING BOARD OF APPEALS (3-year term)

Five members. Cannot be an employee or contractor of the Township. Decides all variance and definition requests regarding land division and development ordinances.
