

RESOLUTION 2020-59

WHEREAS Ryan and Becky Watchorn (dba Lincoln Land and Cattle) has requested a Conditional Use Permit (#20-33) for a Dwelling Unit: Vacation Rental located in Lot B Replat of Lots 51-55 Lakeshore Subdivision, more commonly known as 50 Lakeshore, located in 6-15-40, Keith County, Nebraska; and

WHEREAS: The Keith County Planning Commission, after due public notice in the official county newspaper, did hold a public hearing on June 4, 2020 at 6:30 p.m. in the Keith County Department of Roads meeting room and via TELECONFERENCE/ VIDEOCONFERENCE in regard to the request; and

WHEREAS: The Keith County Planning Commission found the request for Conditional Use Permit #20-33 in conformance with the Keith County Comprehensive Plan and Zoning Ordinance, and has, therefore, recommended approval of the request with the following conditions:

- No on street parking
- Two on-property parking spaces
- Occupancy limit of 12
- Two or more written complaints in a six-month time period shall initiate a written warning to the property owner. A response to the complaint is required to be received from the property owner. The planning commission and the county board will review said complaints and at their discretion may terminate the Conditional Use Permit for Dwelling Unit: Vacation Rental.

WHEREAS: The Keith County Board of Commissioners, after due notice in the official county newspaper, did hold a public hearing on June 24, 2020, in the Keith County Courthouse via TELECONFERENCE / VIDEOCONFERENCE on said request and recommendation.


NOW THEREFORE BE IT RESOLVED, THAT




- a. No conditions
- b. No on street parking allowed
- c. Number of allowed parking spaces 2
- d. Occupancy limit 12

The planning commission and the county board will review said complaints and at their discretion may terminate the Conditional Use Permit for Dwelling Unit: Vacation Rental.




