KEITH COUNTY BOARD OF EQUALIZATION ESTABLISHMENT OF 2021-2022 LEVIES

WHEREAS, Nebraska Revised Statute 13-508 requires all subdivisions within Keith County to file with and certify to the Keith County Board of Equalization a copy of the adopted budget statement with the amount of real and personal property tax required to fund their adopted budget; and

WHEREAS, THE Keith County Board of Equalization has received copies of adopted statements of real and personal property tax requirements from all political subdivisions whose certified valuation in Keith County is greater than certified valuation in other counties; and

WHEREAS, Nebraska Revised Statute 77-1601 requires that the Keith County Board of Equalization levy the necessary taxes for political subdivisions on or before October 15 each year.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Equalization of Keith County, Nebraska as follows:

- 1. That the levies of local political subdivisions for fiscal year 2021-2022 be established based on the attached document (Attachment A) which is incorporated into and is considered a part of this resolution.
- 2. That the final levies for other political subdivisions with certified valuation in Keith County less than certified valuation in other counties must be set by the Board of Equalization in the county with the greatest certified valuation.
- 3. The Keith County Clerk shall certify these levies to the County Clerk's in Deuel, Garden, Lincoln and Perkins Counties.
