### **DRAFT MINUTES**

- I. Meeting was called to order by Vice Chairman Mariluch at 5:42 pm. He led us in the Pledge of Allegiance.
- II. Members present were: Shawn Mariluch, Ted McElvain, Worth Nelson, & Larry Teske.
- III. Ted McElvain made a motion to approve the agenda. The motion was seconded and carried.
- IV. Ted McElvain mentioned that the minutes from the March meeting need to be edited to Unit 068 in Item #1 under New Business. Then Ted McElvain made a motion to accept the minutes from the March 17, 2021 meeting. The motion was seconded and carried.
- V. Correspondence--None
- VI. Public Comment

Jerry Annis talked about the Mule Deer Enhancement Meeting and explained that its main focus is habitat projects (site specific).

Our County put in \$250,000 for wildlife enhancement in Lander County. This can go toward water projects, birds, restocking fish for the 14 & under free fish day.

### VII. Old Business

Worth Nelson mentioned that a good project would be to slope the gravel pits in our area so that kids can go fish easier.

## VIII. New Business

#### A. Election of New Officers

## B. Request Reopening Western Elko County Elk Plan

Larry Teske would like to see this Elk Plan reopened. Ted McElvain made a motion to write a letter to NDOW to request the Western Elko County Elk Plan be reopened. Larry and Ted will write the letter. They will get it to Sondra and she will send it out.

### C. Restock Pond at BMHS

Worth Nelson will check with NDOW and contact the fishery about restocking the pond. Shawn Mariluch made a motion and it was seconded and carried.

## D. Update from NDOW Biologist Sarah Hale

Sarah Hale stated that they have been doing sage grouse surveys and that all but 3 will be surveyed. She said the numbers seem down and it is probably due to drought. She also informed us that the Rabbit Hemorrhagic disease is in the area and if we find a rabbit that does not show a reason for dying to contact Sarah. There will be a press release coming out about it to inform our community.

E. Update from Ted McElvain about the March State Commissioners Meeting The issue about Wildlife game kills (coyote hunt, etc...) was a 5 to 2 vote to move forward on it. NDOW has received over 600 calls about it going both ways. The Wildlife Board will put together language to vote on it in the June meeting. They did not leave any idea of the direction that language will go.

The issue before the commissioners about the Bear versus Dogs deals primarily with guides and outfitters. The State has received 2,200 emails about it going both ways. The Bear population has increased to 700 bears. Dogs are used in every open season. The commission voted 5 to 2 to continue with the way it is currently.

They want our CAB members in on the meetings.

Shawn Mariluch made a motion to change the quota to 130. It was seconded and carried.

Resident Mule Deer--Antlered--any legal weapon Hunt 1311 (Late Hunt)

Shawn Mariluch made a motion to change the numbers to 9 (resident) and 2 (nonresident). It was seconded and carried. This hunt did not appear in the form from NDOW.

Resident Mule Deer--Antlered--Muzzleloader Hunt 1371 (the number was 1331 on form) Shawn Mariluch made a motion to change the quotas to 8 (resident) and 1 (nonresident). It was seconded and carried.

Resident Mule Deer--Antlered--Archery Hunt 1341 (the number was 1331 on form)
Shawn Mariluch made a motion to change the quotas to 50 (resident) and 8 (nonresident). Ted McElvain amended the motion to 45 (resident) and 5 (nonresident). It was seconded and carried.

The following hunts were on the NDOW form, but we did not act upon them due to incorrect numbering and other issues.
