County Public Health Director Fran Tougas and Emergency Manager Josh Johnston joined the meeting via Zoom and provided a COVID-19 Update.

- 1. Have 1st confirmed case in Marshall County no new protocols to take as they are already in place.
- 2. LM Power in Grand Forks has seen a number of positive cases. This will most likely impact our County as well.
- 3. The Governor's Stay at Home Order is in place until May 4th.
- 4. Testing is limited in this part of the State. All tests need to be sent away for results. There is a quicker test version and also a blood antibody test that will show those that have antibodies against the virus. We are unsure when either of these tests will be available here.
- 5. North Valley now has a drive thru Respiratory Clinic. All North Valley employees are now wearing masks at work. Area hospitals are preparing for possible needs for increase in bed space.
- 6. Information relating to the Pandemic is being communicated through the Emergency Management Facebook site. This site is being read by over 1000 persons daily and was as high as 20000 hits on Sunday's post of a positive case in the County.

- 7. A Homelessness plan was discussed if this occurs in Marshall County due to the Pandemic.
- 8. Fran and Josh are coordinating efforts in working with all partners in the County and meeting weekly for a coordinated response.
- 9. Information relating to this event changes daily.
- 10. Josh has acquired a stock of hand sanitizers from Up North Distillery in Kittson County.
- 11. Mask donations by community members is increasing.
- 12. Polk County has 13 new cases from yesterday.
- 13. Minnesota Department of Health has models in place indicating the peak for the Virus could be sometime from end of May to June, but these are just models at this time.

Mr. Johnston provided a Flood Report to the Board.

- 1. Water is receding but still over a few roads on the west side of the County
- 2. Letters to affected Townships have been sent to ascertain damages.
- 3. The County will probably qualify for a State Disaster Declaration.
