

**MIDVALE CITY, UTAH  
RESOLUTION NO. 2014-R-25**

**A RESOLUTION APPROVING A CONTRACT WITH COWDELL & WOOLLEY TO PROVIDE LEGAL COUNSEL TO MIDVALE CITY AND AUTHORIZING THE MAYOR TO SIGN ON BEHALF OF THE CITY AND APPROVING THE APPOINTMENT OF TRACY SCOTT COWDELL ESQ. AND CHAD L. WOOLLEY ESQ. AS CO - MIDVALE CITY ATTORNEYS.**

**WHEREAS**, H. Craig Hall Esq. has served as the City Attorney since May 1, 2008 and has resigned that position with the City effective June 30, 2014; and

**WHEREAS**, in accordance with Section 2.20 of the Midvale City Municipal Code, that creates the position of City Attorney; and

**WHEREAS**, Section 2.20 of the Midvale City Municipal Code gives the Mayor the authority to appoint the City Attorney with advise and consent of the City Council; and

**WHEREAS**, the Mayor and City Manager have considered several options and proposals from qualified individuals and law firms to fill this vacant position; and

**WHEREAS**, Tracy Scott Cowdell and Chad L. Woolley with Cowdell & Woolley, P.C. have been serving in an interim capacity as Prosecuting Attorneys for the City since April 14, 2014; and

**WHEREAS**, Cowdell & Woolley, P.C. have submitted a proposal to provide legal counsel to the City and also propose to have Tracy Scott Cowdell Esq. and Chad L. Woolley Esq. serve as Co- City Attorneys; and

**WHEREAS**, the Mayor has determined that it would be in the best interests of the City to enter into an agreement with Cowdell & Woolley, P. C. to provide legal counsel to the City and to have Tracy Scott Cowdell Esq. and Chad L. Woolley Esq. serve as Co-City Attorneys.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF MIDVALE, UTAH**, as follows:

**SECTION ONE:** That the City Council hereby approves the contract submitted by Cowdell & Woolley, P.C. to provide legal counsel to Midvale City and authorizes the Mayor to sign said contract on behalf of the City.

**SECTION TWO:** That the City Council hereby approves the Mayor's appointment of Tracy Scott Cowdell, Esq. and Chad L. Woolley, Esq. as Co-City Attorneys effective July 1, 2014.


**SECTION THREE:** This resolution takes effect immediately upon passage.
