A RESOLUTION SETTING THE RATE OF TAX FOR CALENDAR YEAR 2020 AND LEVYING TAXES UPON ALL REAL AND PERSONAL PROPERTY WITHIN THE CORPORATE BOUNDARIES OF MIDVALE CITY, UTAH

Whereas, pursuant to Utah State Code, Midvale City is required to establish and set forth the property tax levy rate for property located within the corporate boundaries of Midvale City; and

Whereas, the certified tax rate must be established on or before the 22nd day of June of each year, unless an increase in the certified tax rate is required. In this case, the certified tax rate must be established on or before the 31st of August.

Whereas, the property tax levy rate established by this resolution is sufficient to provide the revenue necessary to operate the General Fund and <u>does</u> exceed the certified tax rate established by the Salt Lake County Auditor's Office.

Whereas, the requisite public notices and hearings have been published and conducted; and

Whereas, the governing body will adopt the General Fund Budget for Fiscal Year 2021.

Now therefore be it resolved by the City Council of Midvale City, State of Utah, as follows:

Section One: That the property tax rate for property located within the corporate boundaries of Midvale City for calendar year 2020 be set at and distributed as follows:
