**INTERLOCAL AGREEMENT FOR ANIMAL SERVICES  
BETWEEN SALT LAKE COUNTY AND THE CITY OF MIDVALE**

**AMENDMENT #3**

SALT LAKE COUNTY ("County"), a body corporate and politic of the State of Utah, for and in behalf of its Animal Services Division ("Animal Services"), and the CITY OF MIDVALE, ("City"), a municipal corporation of the State of Utah, enter into this agreement, to be effective the 1<sup>st</sup> day of July, 2021. This agreement amends a prior interlocal agreement of the parties, described more fully below, which went into effect the 1<sup>st</sup> day of JULY 2017.

**RECITALS**

WHEREAS, Parties entered into an interlocal agreement effective JULY 1, 2017, to provide for animal control services within the City (County contract# CA0000000000405) (Interlocal Agreement); and

WHEREAS, Sections 16 and 20 of the Agreement provide that the term of the contract may be renewed for additional terms and that the level of services may be changed; and

WHEREAS, Section 17 of the Agreement contains a provision allowing for a revised contract price; and

WHEREAS, Amendment #3 of the Interlocal Agreement expires June 30, 2022; and  
WHEREAS, the parties wish to renew the agreement for an additional 2 year period; and

WHEREAS, the City is aware that price increases will be made this year to gradually reach an amount representing full cost to the County as required; and

THEREFORE, in consideration of the mutual desires of the Parties expressed herein, it is agreed as follows:

1. All terms and conditions of the original interlocal agreement of the parties, not hereby amended, shall remain in full legal force and effect.
2. This amendment shall become effective July 1, 2021.
3. City shall pay County \$289,320.00 as detailed in Paragraph 19 of the Interlocal Agreement.
4. This renewal of the Interlocal agreement shall become effective July 1, 2022 and shall expire on June 30, 2024, with up to 2 additional renewals.
5. The parties acknowledge that the price will be increased annually by a maximum of 5% each year. If the contract price for any subsequent year shall increase by more than 5%, then the County shall notify the City of the proposed expenditure decision and consult with the City regarding such decision.
6. Presentations to the City Council by Animal Services will occur as requested by the City, and not quarterly and annually (as stated in the original agreement), unless requested by the City.
7. This contract price shall be contingent upon the participation of other contracted cities and entities who receive Animal Control and Sheltering Services from Salt Lake County Animal Services.
8. The parties acknowledge that this Amendment is subject to the provisions and procedures contained in the Interlocal Cooperation Act and they agree to process, approve, manage, and archive this Agreement in accordance with the provisions of that Act.

IN WITNESS WHEREOF, Midvale City, by resolution duly adopted by its city Council, a certified copy of which is attached hereto, caused this Agreement to be signed by its Mayor and attested by its City Recorder; and Animal Services, caused this Agreement to be signed by its Mayor and attested by its City Recorder.
