A RESOLUTION ADOPTING THE PUBLIC ART FUNDING RECCOMENDATION FROM THE MAIN STREET PUBLIC ART PROGRAM'S DESIGN ADVISORY BOARD

WHEREAS, the Redevelopment Agency of Midvale City (the "Agency") was created to transact the business and exercise the powers provided for in the Utah Redevelopment Agencies Act; and

WHEREAS, the Agency's Board of Directors adopted the Main Street Project Area Plan on November 17th, 2015 and the amended project area budget on October 6, 2020; and

WHEREAS, the Main Street CDA plan and budget call for the improvement, development, and revitalization of the project area, which includes support and funding for public art; and

WHEREAS, the Agency's Board adopted the Main Street Public Art Program on September 21, 2021; and


WHEREAS, the Main Street Public Art Program includes a design advisory board made up of an RDA representative, a community development staff member, a council member, an arts community representative, and a community/property owner representative, and this body meets and makes funding recommendations to the Agency's Board.

NOW THEREFORE BE IT RESOLVED BY THE REDEVELOPMENT AGENCY OF MIDVALE CITY, that the Board of Directors does hereby approve and adopt the public art funding recommendations made by the Main Street Public Art Program Design Advisory Board to fund the proposed public art project attached to this resolution.
