

**THE REDEVELOPMENT AGENCY OF MIDVALE CITY
RESOLUTION NO. 2024-06RDA**

**A RESOLUTION WAIVING THE ART HOUSE USAGE FEE FOR CRAFT LAKE CITY FROM
MARCH 1, 2024, TO MARCH 2, 2024 FOR THEIR PRODUCTION OF THE LETTERWEST
CONFERENCE**

WHEREAS, the Redevelopment Agency of Midvale City (“Agency”) was created to transact the business and exercise the powers provided for in the Utah Redevelopment Agencies Act; and

WHEREAS, the Agency owns the Art House located at 7697 S Main Street Midvale, Utah, referred to in this Resolution as the "Art House";

WHEREAS, since the building located at 7697 S Main Street was repurposed from the Midvale Museum to the Art House, it has only been used to support public events on Main Street, the Main Street Business Alliance meetings, and has been rented out twice by film production companies for a total of five day;

WHEREAS, the Redevelopment Agency of Midvale City has commissioned Craft Lake City to produce an arts conference within Midvale Main; and

WHEREAS, the LetterWest Conference will be a one-day event held on Saturday March 2, 2024 (“Art Conference”); and


WHEREAS, through this one-day event, LetterWest will offer workshops, demonstrations, networking opportunities, and community markets fostering community engagement and leaving a lasting impact on Midvale's cultural landscape; and

WHEREAS, Craft Lake City would like to activate the Art House to host a workshop and would need access to the event space from March 1, 2024, to March 2, 2024; and


WHEREAS, the request to waive the Art House usage fee would be in line with the Agency's objectives of supporting the arts within the Main Street CDA and establishing the area as an arts and culture district.

NOW THEREFORE BE IT RESOLVED BY THE REDEVELOPMENT AGENCY OF MIDVALE CITY, that the Board of Directors does hereby agree to waive the Art House usage fee for Craft Lake City for the production of the 2024 LetterWest Conference.


