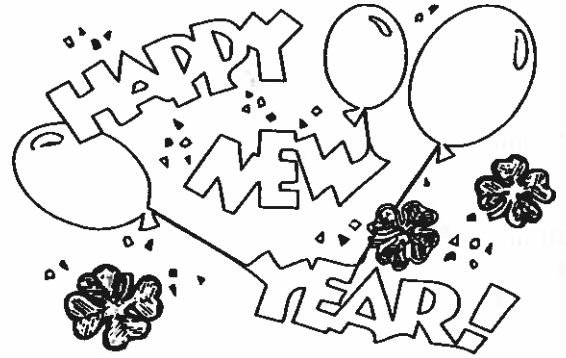

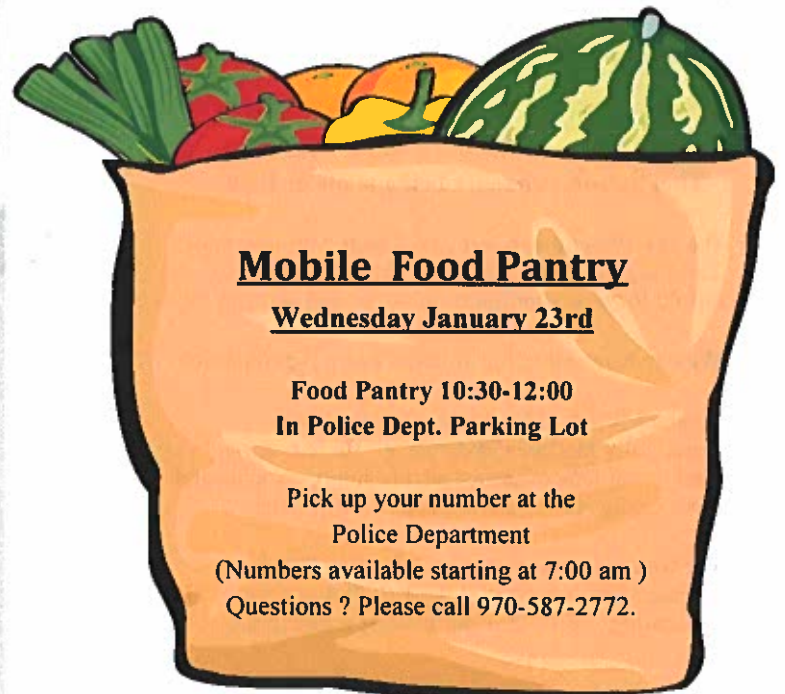

Snow Removal - Your Responsibility

Milliken Police department would like to remind residents of ordinance : 11-1-20 Snow & ice removal from sidewalks. The owner, occupant, lessee or person in possession or control of any premises or property shall maintain the sidewalks adjoining such premises or property, and shall remove and clear away, or cause to be removed or cleared away, snow and ice from sidewalks in all business districts within the Town by four (4) business hours after the cessation of any fall of snow, sleet or freezing rain or by the beginning hours of the next business day following such fall, whichever period is shorter, and from all other sidewalks in the Town within twenty-four (24) hours of the cessation of any fall of snow, sleet or freezing rain.

AVOID BEING SCAMMED

The Internal Revenue Service is warning consumers of a phone scam targeting taxpayers. Victims are told they owe money to the IRS and it must be paid promptly through a pre-loaded debit card or wire transfer. If the victim refuses to cooperate, they are then threatened with arrest and a warrant issued. If you receive a call from someone claiming to be from the IRS, here's what you should do:

If you know you owe taxes or you think you might owe taxes, call the IRS at 1.800.829.1040. The IRS employees at that line can help you with a payment issue — if there really is such an issue.

If you've never received a bill or the caller made some bogus threats as described above), report the incident to the Treasury Inspector General for Tax Administration at 1.800.366.4484.

File a complaint using the FTC Complaint Assistant; choose "Other" and then "Imposter Scams." If the complaint involves someone impersonating the IRS, include the words "IRS Telephone Scam" in the notes.

We advise that you never give out personal information over the phone. Please contact Milliken Police Dept. (970) 587-2772, if you have further questions or other suspicious phone calls.
