

EFFECTIVE MARCH 18, 2020

Limited Access to County Offices

This action is being taken as an appropriate prevention and protection measure in response to the COVID-19. In taking these measures, Meeker County remains in line with guidance for social distancing strategies recommended by the Minnesota Department of Health (MDH) (www.health.state.mn.us), and by the Center for Disease Control (CDC) (www.cdc.gov), as well as by the Governor and Commissioner of Health of the State of Minnesota.

Meeker County offices will limit access to the public effective March 18, 2020 and until further notice. Access to the Family Services Building will be limited to the front entrance and the Law Enforcement Center access will be through the main entrance door. All other County buildings are closed to the public including the Courthouse, except for required court hearings. All community rooms are closed to the public and reserved for emergency services only.

While our offices are limited and/or closed to the public, we encourage citizens to access services through the use of phone or email. Normal county services and operations will continue to be provided to the community on the same schedule. Many services can also be accessed online by visiting our website at www.co.meeker.mn.us.

This action will help protect the public and staff from being exposed to potentially sick individuals and from spreading the virus to our citizens, friends, and families.
